#### John Robert Blue Chief Judge for Florida's 2nd District Court of Appeal

1963 Stetson University College of Law graduate John R. Blue practiced law in Bradenton with Grimes, Goebel, Parry, Blue, Boylston and McGuire from 1963-84 and with Blue and McGuire from 1984-86.



He served as president of the Manatee County Bar Association from 1975-76, was a member of the 12th Judicial Circuit Nominating Committee from 1981-83 and was a member of the Grievance Committee for that circuit from 1985-86. Judge Blue was a member of The Florida Bar Board of Governors from 1986-87.

Governor Bob Graham appointed Judge Blue to the 12th Judicial Circuit Court in 1986 and he was elected to that office in 1988. Governor Lawton Chiles appointed him to the 2nd District Court of Appeal in 1992 and he was retained by the electorate in 1994 and in 2000. He was elected Chief Judge in May to serve through June 2003.



#### Susan Cawthon Bucklew U.S. District Court Judge for the Middle District of Florida

Susan Bucklew was a high school English teacher for five years before she attended Stetson. Now a U.S. District Judge for the Middle District of Florida, she was the first woman circuit judge in Florida's 13th Judicial Circuit and the first woman county judge in Hillsborough County.

The 1977 graduate has dedicated much of her career to ending discrimination in the legal profession. She has worked on the statewide Gender Bias Study Commission and on the Commission on the Status of Women, and won the Hillsborough Association for Women Lawyers Award for Outstanding Public Service Advancing the Status of Women in 1991.

Her efforts can be seen in Stetson's 2001 enrollment; 54% of its students are female. "When I first became a judge in 1982, it was a rare occurrence when a female attorney appeared before me in court. Today, it's routine. Women have served as chief judges, president of the ABA, and president of The Florida Bar," she said. "The transition for women into positions of power has been slower than I would have liked but quicker than I had hoped."

#### David Alan Demers Chief Judge for Florida's 6th Judicial Circuit Court

David Demers, a 1972 Stetson graduate, was a county judge 13 years before being appointed to the circuit bench in March 1994.

Demers was elected last year as the circuit's chief judge. He teaches and coaches at Stetson with his wife, **Susan Demers**, director of the legal assistants program at St. Petersburg College, and their daughter, attorney **Kristin Demers-Crowell '97**, a former Stetson Trial Competition Team member.

## **Florence Foster** Judge for Florida's 13th Judicial Circuit

1985 Stetson graduate Florence Foster, who formerly worked for Elizabeth Kovachevich, Chief U.S. District Court Judge for the Middle District of Florida, gained recent attention as a circuit judge in the Darryl Strawberry case.

She met, married and worked with attorney

Robert Foster before running for the bench in 1990, and served in juvenile and family court before her current assignment in drug court. "Hillsborough County is on the cutting edge of drug court," she said, adding that the Florida Legislature recently mandated drug courts throughout the state, nine years after the Hillsborough program began. And crime rates have fallen since then, she said. "Drugs drive so much of crime."

# Carol W. Hunstein Justice, Georgia Supreme Court

Adversity in her early life made the journey to Georgia's top court difficult for Justice Carol Hunstein.

At age 23, she was a divorced, single mother who lost her left leg to cancer. She earned a business degree at Florida Atlantic University, then enrolled at Stetson. After graduating in 1976, she opened a private practice in Georgia.



She ran for the Superior Court in DeKalb County in 1984, using the slogan "This woman this time," and became the first woman superior court judge in the county when she was elected. "One reason I ran was because I loved being in the courtroom, and this would be one way I could be in the courtroom every day," she said.

In 1992, she was nominated for an appointment to the Georgia Supreme Court shortly after the governor had appointed the first woman to the bench, and became the second woman Supreme Court Justice in the state.

During her years on the bench, she has been a tireless champion of racial, ethnic and gender equality in the courts. Her work has brought into being Georgia's state and local domestic violence task forces, the interpreter's certification program and countless training programs for judges, lawyers and court personnel. She currently chairs the Georgia Supreme Court Commission on Equality and the Unauthorized Practice of Law Committee. In addition, she serves as Supreme Court liaison to the Chief Justice's Commission on Professionalism and Georgia Indigent Defense Council. Among the many awards she has received for her contributions are the ABA Commission on Women in the Professions' Margaret Brent Award and an honorary LL.M. from Stetson.

"There are wonderful lessons in life that can be learned from adversity," she said. "I've dealt with serious health problems and my own mortality. But that adversity has made me what I am today."



# James David Whittemore U.S. District Court Judge for the Middle District of Florida

U.S. District Court Judge James D. Whittemore is a 1977 Stetson graduate. He worked for a small St. Petersburg law firm before moving to the newly-created federal public defender's office in 1978. One of four initial assistant federal defenders in the Middle District of Florida, he did trial and appellate work. He resumed private practice in 1981 and, in 1985, successfully argued a case before the U.S. Supreme Court.

In 1990, he was appointed to the Circuit Court of the Thirteenth Judicial Circuit and served as a Circuit Judge in Tampa until his confirmation as a U.S. District Court Judge in May 2000. He was the featured speaker at the law school's December 2000 graduation ceremony.

#### **Elizabeth Kovachevich** Chief U.S. District Court Judge for the Middle District of Florida

Elizabeth Kovachevich decided to go to law school after meeting then President Dwight Eisenhower during a national American Legion auxiliary event in July 1953. She told her immigrant grandfather that the meeting inspired her to go to law school, and his proud reaction spurred her on to attend Stetson after earning a business degree at the University of Miami.

Judge Kovachevich graduated from Stetson in 1961, and by 1973, she was the first woman elected to Florida's 6th Judicial Circuit for Pinellas and Pasco counties. In 1982, former President Ronald Reagan nominated her to the U.S. District Court for the Middle District of Florida, where she has been Chief Judge since 1996. She was honored by Stetson with the

**Wm. Reece Smith, Jr.** Award for outstanding public service last year. "I have never forgotten how important it is to serve as a judicial officer," she said. "It is a privilege; it affects so many people's lives."

During her 40 years in the law, Judge Kovachevich said the biggest change she has seen is a decline in the relationships among lawyers, and among lawyers and judges. "When I started to practice law, your word was your bond, you shook hands. Nobody needed a paper trail."

But problems have developed in the realm of values, morals and principles, she said, adding, "Lawyers who are ethical – and there are many – would agree with me." Stetson's emphasis on teaching ethics is among the successful efforts of the profession to rectify that, she said. "If you don't have self respect, how can you possibly engender respect?"
