PESTICIDES SUMMARY

This Pesticides Summary replaces the previous Summary dated 15 October 2004.

Wellington Conservancy

Notification Period: 1 March 2005 to 30 June 2005

Important notes:

- Refer to the most recent publication, which is available from the local DOC office. Pesticides Summaries cover the periods [1 March to 30 June], [1 July to 31 October] and [1 November to 28/29 February].
- All areas where pesticides have been laid are clearly identified with WARNING signs. Take note of signs when entering area.
- This Pesticides Summary excludes the use of herbicides for control of plants, the use of pesticides for rodent control in huts or buildings and the laying of cyanide baits for possum skin recovery operations, invertebrate pest operations (e.g. wasps), use of pesticides on off-shore islands that have permit-only access, DOC pesticide operations on private land.

Caution notes:

- The application dates listed for the planned operations are provisional only and may be subject to change. Unprogrammed operations such as TB blips may occur from time to time. Due to their immediate nature, they may not appear on the current Pesticide Summary. Check with the local DOC office before entering any area.
- Pigs and deer may have access to these pesticides. It is recommended NOT to take animals for eating from these areas during the caution period. Outside of the operational area boundary, do not take deer within 2 km and pigs within 5 km of that boundary (except where the pesticide being used is Cyanide or Cholecalciferol).

I, **Allan Ross, Conservator** of the Wellington Conservancy of the Department of Conservation, advise as follows:
