

### Let's Hear from Volunteers!

## Vandalism in the Parks "Who is Responsible?"

Vandalism seems to be an on-going problem in West Hanover Township. In 2005 alone, we had graffiti on picnic tables, playground equipment, park signs, and on pavilion walls. Trashcans have been smashed, and a hole was burned in the climbing rock at Lenker Park. Skyline Park trashcans, picnic tables, playground equipment and pavilion were victims of a paint-ball gun. An eagle scout project that was constructed at Lenker Park was destroyed, all the window screens in the log cabin at Fairville Park were cut out and beer cans keep filling up

the trashcans in all the parks.

The Park and Recreation Board asks residents to help keep a lookout for any suspicious actions in your neighborhood park. The Township needs your help to catch the individuals responsible for the vandalism. Please contact the State Police at 671-7500 (911 for emergency) or the Township Office 652-4841 if you see someone vandalizing park facilities.

Anyone involved in these criminal acts will prosecuted to the full extent of the law.

## WHT Historical Society

The October 20th meeting of the Historical Society honored the Fahnestock family. Many members of the family were longtime residents of West Hanover Township. The Harold and Vernice Fahnestock farm was at the current location of Clover Lee, a development of new homes.

Linda Fahnestock Hubbard gave an excellent presentation, and had a fine display of family heirlooms. She documented the history of the family, where they came from, and the various businesses that members of the family engaged in over the years.

A field trip was led by Tom Felsburg and Ed Wisehaupt on October 29th to the slave graves in West Hanover Township. They are located on the mountain off an old section of the Appalachian Trail. About 15 members and guests made their way to the location. Repairs to the two headstones marking the location had been recently made by Tom, Ed and Carol Buskirk. Harry Senft also assisted in clearing the way to the location.

The historical society invites young and old to the 19th annual Carol Sing and burning of the Yule Log. This will be held on Sunday, December 4, 2005 at 6:00 p.m. at the Log Cabin in Fairville Park. Shirley McCahan will lead the burning of the Yule log and Cindy Wertz, choral director at West Hanover Elementary School will lead the singing. St. Nick is expected to pay a visit. Cookies and beverages will be served in the Log Cabin at the conclusion to warm everyone up.

### **SNOW REMOVAL**

Township residents are asked to aid the Public Works Crew in their ice and snow removal efforts by refraining from parking on Township streets during inclement weather and by not throwing/pushing snow from driveways or sidewalks onto Township streets.

Please remember that the Township's main arteries receive first priority for salting and plowing. The main arteries plowed by the Township are: **Piketown Road, Fairville Avenue, Jonestown Road, Manor Drive and Devonshire Heights Road.** If there is a problem with a Township maintained road please call 652-1054.

Maintenance and plowing of all private roads are the responsibility of the owner.

The following roads are plowed by PENNDOT: Allentown Boulevard (Rt. 22), Fishing Creek Valley Road (Rt. 443), Green Hill Road (from Oak Grove Road to Hershey Road), Hershey Road (Rt. 39), Linglestown Road (Rt. 39), Oak Grove Road, Red Top Road and Route 81. If there is a problem with a State maintained road, call PENNDOT at 787-5284.

Christmas Tree recycling will be held at the West Hanover Township Public Works Building, 402 N. Fairville Avenue, on Saturdays January 7, 14 & 21 from 9 a.m. to noon.

Tinsel, ornaments, wire, string and rope should be removed from trees before bringing them for recycling. Wreaths and garlands will also be accepted, but frames, wire and string must be removed before bringing them for recycling. Township residents are urged to participate in this EAC sponsored free community program.

**Please note:** Christmas trees, wreaths, and garlands <u>will not</u> be picked up by Waste Management and cannot be land filled. All trees and greens will be mulched and available, at no cost to township residents, when the Composting Center reopens in the Spring.

## On Lot Septic Pumping Reminder

Chapter 158, Article I, Section 158-9 of the West Hanover Township Code of Ordinances requires all on lot septic systems to be pumped every four (4) years and proof of pumping is to be submitted to the Township Codes Enforcement Officer.

Failure to comply with this ordinance will result in further action and up to a \$300.00 fine. A list of licensed pumper/haulers is available at the Township Office.

Please note that the Township does not send reminder letters. Any property owner who does not maintain a current proof of pumping form on record at the Township (every four years) will be issued a violation letter. At that time the property owner will have 30 days to have the on lot system pumped. Please remind your pumper/hauler to submit the yellow copy of the "Septic Tank Pumper's Report" to the Township in a timely manner.




