





## **Definitions**

Accommodation (2001 Census): Accommodation type describes the type of accommodation occupied by an individual household, or if unoccupied, available for an individual household, for example the whole of a terraced house or a flat in a purpose-built block of flats.

Car Ownership (2001 Census): The number of cars or vans owned, or available for use, by one or more members of a household. It includes company cars and vans available for private use.

**Crime (Reported):** *Total Crime* includes all recorded types of crime. *Burglary Dwelling* includes domestic burglaries. *Vehicle Crime* includes 'Theft of' and 'Theft From' vehicle and 'Aggravated vehicle taking'. *Robbery* includes 'Robbery of Personal Property' (but not Robbery of Business property). *Violent Crime* includes 'Common Assault' and 'Other Wounding' offences only. *Criminal Damage* includes all types of 'Criminal Damage' combined (dwelling, building, vehicle and other). *Other* Crimes includes total crime figure minus above categories.

**Dependent Child (2001 Census):** A dependent child is a person aged 0-15 in a household (whether or not in a family) or aged 16-18 in full-time education and living in a family with his or her parent(s).

**Disability Living Allowance (DLA):** Disability Living Allowance is payable to people who are disabled and need help with personal care, getting around or both, who became disabled before the age of 65. Claim rates are calculated using the total (all ages) populations from the 2001 Census. Please visit: <u>http://www.dwp.gov.uk/asd/asd1/neighbourhood/neighbourhood.asp</u>

**Distance travelled to work (2001 Census):** The distance in kilometres of a straight line between the postcode of residence and the postcode of workplace. Not calculated for people working mainly at or from home, people with no fixed workplace, people working on an offshore installation or people working outside the UK.

**Economic activity (2001 Census):** The Economic Activity questions apply only to people aged 16 to 74. They relate to whether or not a person was working or looking for work in the week before Census. All people who were working in the week before the Census are described as *economically active*. In addition, the category includes people who were not working but were looking for work and were available to start work within two weeks. A person who is looking for work but is not available to start work within two weeks is counted as *economically inactive*. Students are distinguished between those who are economically active full time students, and economically inactive students who may not necessarily be in full time education.

**Ethnicity (2001 Census):** The Ethnic Group question records each person's perceived ethnic group and cultural background. Ethnic minority groups includes persons categorised as 'Non White British'. White ethnic groups includes all persons categorised as either 'White Irish' or 'White Other'. Non white ethnic groups includes all persons categorised as 'Mixed', 'Black or Black British', 'Asian or Asian British', 'Chinese or Other Ethnic Groups'.

General health (2001 Census): self-assessment of a person's general health over the 12 months before the Census.

**Household:** A household for the purpose of this profile is defined as a property on the Council Tax Valuation List deemed to be occupied with residents. This is calculated as all properties minus those exempt from Council Tax due to being vacant.

Household space (2001 Census): A household space is the accommodation occupied by an individual household or, if unoccupied, available for an individual household.

House prices: Average house price data provided at postcode level by HM Land Registry and aggregated to wards.

Incapacity Benefit (IB) / Severe Disablement Allowance (SDA) Combined: IB is paid to people who are assessed as being incapable of work and who meet the appropriate contribution conditions. SDA is paid to people who are incapable of work and do not satisfy the contribution conditions for Incapacity Benefit (IB). Income Support Benefit (IS): IS can be paid to a person who is in Great Britain, is aged 16 or over, is not working 16 hours or more a week and has less money coming in than the law says they need to live on. In general Income Support is now only available to people who are not required to be available for work such as carers, lone parents and sick and disabled people. Claim rates are calculated using the aged 16-59 populations from the 2001 Census. Please visit: http://www.dwp.gov.uk/asd/asd1/neighbourhood/neighbourhood.asp

Index of Multiple Deprivation 2004: 37 deprivation indicators measured at Lower Layer Super Output Area (LSOA) level across seven 'domains' of deprivation, combined into an overall Index of Multiple Deprivation. Each LSOA within Warrington is scored and ranked nationally out of 32,482 LSOAs. A 'National Rank Percentile' is calculated by dividing Warrington Lower Layer SOA deprivation rank out of 32,482 English SOAs and multiplying by 100. ## **Definitions**

Lifestyle Area Profile: 'ACORN' is postcode level classifications based upon demographic, socio-economic and market research information. It can be used to identify typical residents and their characteristics living in households within a specific postcode or group of postcodes. It is licensed to Warrington borough Council by CACI Ltd. Limiting long - term illness (2001 Census): A self assessment of whether or not a person has a limiting long-term illness, health problem or disability which limits their daily activities or the work they can do, including problems that are due to old age.

Lone parent household (2001 Census): In most tables, the term 'lone parent household' is used to describe a household that comprises a lone parent family and no other person.

Means of travel to work (2001 Census): The means of travel used for the longest part, by distance, of the usual journey to work.

**Overcrowded households (2001 Census):** This provides a measure of under occupancy and over crowding. It relates the actual number of rooms to the number of rooms 'required' by the members of the household. That is a one-person household is assumed to require three rooms (two common rooms and a bedroom): where there are two or more residents it is assumed that they require a minimum of two common rooms plus one bedroom.

**Pensioner (2001 Census):** This term is used in some tables as a shorthand for 'person of pensionable age'. Pensionable age is 65 and over for males and 60 and over for females.

Population density: Average number of residents mid year 2004 per hectare.

**Resident Population:** Registrar General's mid year population estimates by age of the resident population. Please visit National Statistics <u>http://www.statistics.gov.uk</u> or the Warrington Borough Council website: <u>http://www.warrington.gov.uk/council/facts/default.asp</u>

### Qualifications (2001 Census):

Lower qualifications (Levels 1,2 and 3): 1+ 'O' level passes, 1+ CSE/GCSE any grades, NVQ level 1, Foundation GNVQ 5+ 'O' level passes, 5+ CSEs (grade 1). 5+ GCSEs (grades A-C), School Certificate, 1+'A' levels/ AS levels, NVQ level 2, Intermediate GNVQ, 2+ 'A' levels, 4+ AS levels, Higher School certificate, NVQ level 3, Advanced GNVQ. Higher qualifications (Level 4 and 5): First degree, Higher degree, NVQ levels 4 and 5, HNC, HND, Qualified Teacher status, Qualified Medical Doctor, Qualified Dentist, Qualified Nurse, Midwife, Health Visitor.

**Tenure (2001 Census):** The tenure of a household is derived from the response to the question asking whether the household owns or rents its accommodation and, if rented, from the response to the question asking who is the landlord.

**Unemployment Claimant Count i.e. Jobseeker's Allowance (JSA):** JSA which is payable to people under pensionable age who are available for, and actively seeking, work of at least 40 hours a week. In addition, to be entitled to JSA the person must be in Great Britain, be capable of work, not be in relevant education, be working less than 16 hours a week on average. Claim rates are calculated monthly as a percentage of the resident working age population (males 16 to 64, females 16 to 59).
