**COMMUNICATIONS REGULATION ACT 2002  
 (SECTION 30) POSTAL LEVY ORDER 2003**

The Commission for Communications Regulation made a Postal Levy Order (S.I. No. 733 of 2003) on 30 December 2003 to come into operation from 1 January 2004.

S.I. No. 733 of 2003 makes provision for a levy on providers of postal services for the purpose of meeting expenses properly incurred by the Commission in the discharge of its functions in respect of postal services. An Post will continue to pay 0.25% of relevant turnover while Authorised Postal Service Providers will pay 0.075% of relevant turnover subject to a minimum annual levy of €1,000.

A revised levy order will be made for the levy year commencing 1 July 2004 and ending 30 June 2005, and for subsequent levy years.

INTRODUCTION OF A VISITOR'S & CARER'S DISC  
PARKING SYSTEM FOR QUALIFIED RESIDENTS  
WITHIN THE DISC PARKING AREA OF WATERFORD  
CITY

Waterford City Council, has made Parking Places Bye-Laws under Section 36 of the Road Traffic Act 1994 to cater for the above.

These Bye-Laws provide for the issue of:

1. A visitor's parking disc to each householder in the disc parking area **solely occupied** by one or more persons aged 65 years or over. Each visitor's parking disc will allow a visitor to park for a period of up to two hours in the relevant street or streets.
2. A carer's parking disc to each resident in the disc parking area who suffers from a chronic illness and is in need of ongoing daily care (as certified by their doctor). The carer's parking disc will allow a carer to park in the relevant street or streets during disc parking hours.
