The papers of Tracy W. McGregor were placed in the Archives of Labor and Urban Affairs by the McGregor Fund and Philip P. Mason in March of 1973 and opened for research in September of 2005.

Tracy William McGregor, grandson of a Presbyterian minister and eldest son of Thomas McGregor and Elizabeth Taitt McGregor, was born April 14, 1869 in Berlin Heights, Ohio. Four years later the family moved to Toledo, where, in 1889, his father closed his music store and set up the Helping Hand Mission for homeless men. In 1890 Thomas McGregor came to Detroit to establish a second mission, but died less than a month after it opened its doors in April of 1891. Tracy McGregor was attending Oberlin College at the time, preparing for a career in the ministry, but left school to take up his father's work in Detroit. Under his leadership, the McGregor Institute, as it was later called, grew to be one of the largest of its kind in the country.

McGregor married Katherine Whitney, daughter of David Whitney, Jr., one of Detroit's wealthiest businessmen, in 1901. She shared his social conscience and together they used her substantial fortune to carve a place for themselves among Detroit's leading philanthropists.

In addition to his social welfare activities, Tracy McGregor devoted himself to the betterment of the growing metropolis of Detroit. As the guiding force behind the Thursday Group, an informal club of influential businessmen and professionals working behind the scenes to promote reform, he helped spearhead improvements in housing, schools, criminal justice and services for the mentally and physically disabled. In 1917, he helped organize the Detroit Community Union and Patriotic Fund, forerunners of today's United Way for Southeastern Michigan. He also served as president of the Merrill-Palmer School and the Provident Loan and Savings Society. Indeed, his growing civic and philanthropic commitments forced him to turn over the reins of the McGregor Institute to his brother Murray in 1915.

The crowning achievement of McGregor philanthropy occurred in 1925 when he and his wife created the McGregor Fund to channel their enormous wealth to social service during their lifetimes and beyond. In the 1930's the McGregors moved to Washington, D.C., where Tracy had more time to feed his passion for rare-book collecting. After his death on May 6, 1936, his valuable library of Americana was donated to the University of Virginia, where it is housed in a special room of the school's Alderman Library. Katherine Whitney McGregor died in 1954.

The Tracy W. McGregor Collection contains correspondence, reports, journals, meeting minutes, publications and other material documenting the extended McGregor family, the founding and flourishing of the McGregor Institute, his civic and philanthropic activities, especially with regard to the McGregor Fund, and his later life as a bibliophile. The collection also contains some contemporary documentation compiled from other sources by McGregor biographer, Philip P. Mason, as well as oral histories and other material collected for the Fund's McGregor biography project.
