SERIES 6: 3-2-1 CONTACT

3-2-1 Contact, the third program series produced by the Children's Television Workshop (CTW), was intended to interest 8-12 year-olds, particularly girls and minorities, in science. The project was first proposed in 1977. With funding from the National Science Foundation, the U.S. Department of Education, the Corporation for Public Broadcasting and the United Technologies Corporation, the first thirteen-week season aired beginning on January 14, 1980. Each week included five "magazine" format half-hour shows with a common theme; the Monday-Thursday shows also featured a mystery series called *The Bloodhound Gang*. A second season of 40 episodes, which featured new hosts and the efforts of new executive producer Al Hyslop (replacing Kathy Mendoza), aired beginning October 17, 1983 with continued funding from the National Science Foundation and the U.S. Department of Education as well as support from the Arthur Vining Davis Foundation. New staff also took over other production, research and direction positions; few of the people involved in the second season had been involved in the program's early development. The third season of the series, which included 20 new episodes, aired beginning October 22, 1984. The fourth season, also of 20 episodes, aired beginning September 23, 1985. The fifth season premiered on September 15, 1986. Production for a 20-episode sixth season began the same month. The series aired through October 1992.

Intending the program for classroom use as well as home viewing, CTW produced a series of teacher's guides to the program. Museums, Girl Scouts and Boys Clubs also developed programs using the series. Additionally, CTW produced books and a monthly magazine; *3-2-1 Contact Magazine* debuted in the fall of 1979 and, by 1985, the CTW had sold more than a quarter of a million *3-2-1 Contact* books.

This series includes proposals and reports and the administrative files of Executive Vice President for Production David Connell, Executive Vice President of CTW Paul Firstenberg, and Executive Producer Samuel Gibbon; production files; research files; ancillary materials; and the promotion files of Director of Information Frances Kaufman. The bulk of the series deals with the early development and first and second seasons of the program. Some research, production and promotional materials are available from Season III, as well as progress reports and some promotional materials from Season IV. The only information regarding Seasons V and VI is found in progress reports in subseries 1. This collection also includes copies of 3-2-1 Contact Magazine and materials relating to its production and promotion.

SUBSERIES 1: PROPOSALS, REPORTS AND ADMINISTRATIVE FILES

The proposals and reports, which cover the period from 1977 through 1986, from the program's early development through the production of its sixth season, are arranged chronologically. The administrative files are all limited to the development phase and first season. David Connell's files include the initial proposal for the program and information on its early development, staff, budget, international cooperation, and Season

I production notes. The bulk of Paul Firstenberg's files deal with the program's funding and budget. Samuel Gibbon's files cover program content, funding, legal issues (including negotiations with the Writer's Guild of America), staff and production.

SUBSERIES 2: PRODUCTION

The production files are arranged by season. The Development section of the production files include information on the content of the series, the selection of its title, draft scripts, final scripts and production notes for test shows. The section on Season I includes early animation, content research and outlines, draft scripts and the production schedule, as well as scripts and production information on the first season of *The Bloodhound Gang*. The section on Season II includes production notes, transcripts of all 40 episodes and music cue sheets. The section on Season III includes only the transcripts to two shows.

SUBSERIES 3: RESEARCH

The research files, also arranged by season, include reports spanning the development phase through Season III. Seasons I and II each include a set of short formative research reports as well as more substantial reports. Season III includes carriage data and longer reports. This subseries also includes Nielsen ratings from 1980 and 1983.

SUBSERIES 4: ANCILLARY MATERIALS

The ancillary materials include the proposal for a series of books based on the program; a 3-2-1 Contact club leader's handbook; teacher's guides; a 3-2-1 Contact resource manual; bound volumes and loose copies of 3-2-1 Contact Magazine, and information relating to the magazine's development.

SUBSERIES 5: PROMOTION

The promotion files, created by Frances Kaufman, are arranged by season and include copies of many of the same memos, research reports and proposals found elsewhere in the collection. The section on the first season also includes information on and photographs of members of the cast and advisory board; draft and final press releases; information on the press conference which announced the show and its press preview; press kits for the first run and rebroadcast of the first season; advertisements; and press coverage and clippings. Very little information is available on Seasons II-IV. The section on the magazine includes memos and production information not found elsewhere in the collection, as well as the press release announcing the magazine's debut.
