## PROPOSED RENAMING OF SWAN STREET, MELBOURNE (BETWEEN BATMAN AVENUE AND PUNT ROAD) TO OLYMPIC BOULEVARD

**Division** Sustainability & Innovation

### Purpose

1. To seek Committee approval of a joint proposal from the Victorian Olympic Council and the Melbourne and Olympic Parks Trust that, in association with the 50th year celebrations of the 1956 Olympic Games, Swan Street within the City of Melbourne be renamed Olympic Boulevard.

#### **Recommendation from Management**

- 2. That the Planning Committee:
  - 2.1. support the renaming of Swan Street, as generally shown hatched on the attached plan, as at Attachment 1, as Olympic Boulevard;
  - 2.2. note that VicRoads has delegated to the Council's Chief Executive, VicRoad's powers as coordinating road authority to implement the renaming of Swan Street;
  - 2.3. by instrument of delegation sealed by the Council under Section 98(1) *Local Government Act* 1989, delegate to the Chief Executive, or the persons from time to time acting in that position, the authority to implement the renaming of Swan Street and do all things incidental and ancillary to the same; and
  - 2.4. under Section 98(3) of the *Local Government Act* 1989, authorise the instrument of delegation to the Chief Executive, or the person from time to time acting in the position, to empower him or her to delegate any power, duty of function delegated to him or her under the paragraph above to a member of Council staff.

### Key Issues

3. The Melbourne and Olympic Parks Trust ("MOPT") was established in 1995, being a merger of the National Tennis Centre Trust and the Olympic Park Committee of Management. MOPT's functions include the care, use, improvement, financial management and promotion of Melbourne Park and Olympic Park, with their extensive sporting, function and ancillary facilities. The body operates to provide world class facilities and services for sport, entertainment and function events, primarily for the State of Victoria. Melbourne and Olympic's Parks is also the administrative and training home for various sporting organisations.

- 4. MOPT and Victorian Olympic Council ("VOC") have approached the Council and VicRoads, proposing that in association with the 50th year celebrations of the 1956 Olympic Games, Swan Street within the City of Melbourne (as generally shown hatched within Attachment 1 and further indicated within Attachment 2, aerial photograph) be renamed as Olympic Boulevard.
- 5. The applicants' rationale for the proposal is:
  - 5.1. as a sporting legacy, it further preserves and supports the legacy of the 1956 Olympics which provided a positive and lasting impact on how the world viewed our city and Australia. It is a testament to Melbourne as a home to over one third of all Australian Olympians and to the role the 1956 Olympics continued to play in the development of sport in Victoria;
  - 5.2. **sporting excellence**, the road runs through the heart of Melbourne's major events centre, a home to many past and current elite sporting bodies, including the Victorian Institute of Sport; and
  - 5.3. **investing in the future**, the renaming seeks to honour and identify the area and Melbourne as a proclaimed international host and supporter of unity through sports. However it will also be an investment in the future. Not only is the area already first class in facilities and recognition, it continues to be further developed for sporting purposes. A 20,000 seat rectangular pitch stadium is to be built in the area by 2009, including a sports campus that will hose a state-of-the-art training, competition and administration facility. Fittingly the Victorian Olympic Council will be tenants in the new stadium.
- 6. Advice from the VicRoads Information Centre and the President of the East Melbourne History Society is that the name "Swan Street" came from the White Swan Hotel circa1852. That is now named the Swan Hotel and is at the corner of Swan and Church Streets, Richmond.

### Time Frame

7. Timing is very critical as the above celebrations will occur in mid-November 2006. The Committee therefore needs to determine the matter this month.

## **Relation to Council Policy**

8. Road names must meet public expectations and must relate to the historical and cultural aspects of the road and its environs, under Part 10 of Council's Activities Local Law and its associated Naming of Places (Including Roads) Policy Statement (refer Attachment 3). The proposal is policy compliant.

## Consultation

- 9. Statutes require naming authorities to act in accordance with the guidelines in force for the time being under the *Geographic Place Names Act* 1988. Council's "Place Naming Policy" restates that and further requires consultative actions to be carried out in consideration of the significance and potential affects of a proposal.
- 10. The applicants' submission included letters containing very significant support to the proposal from stakeholders, being the tenants and operators of the abutting sporting and associated facilities (refer Attachment 4).
- 11. Council also approached the East Melbourne Group (residents association), the East Melbourne Historical Society, Yarra City Council, the Registrar, the Department of Sustainability and Environment ("DSE") and the statutory and emergency service providers. A public notice of the proposal was also published in the Age Newspaper seeking submissions from any interested party.

- 12. Council's Principal Engineer Traffic Engineering does not oppose the renaming but questioned the impacts of retaining the name "Swan Street Bridge" for the road's continuation over the Yarra River.
- 13. Council's Principal Engineer Infrastructure (Engineering Service Group) does not oppose the renaming.
- 14. The results of the applicants' and Council's consultation are set out in the attached consultative summary (Attachment 6).

## **Government Relations**

15. The VOC in February 2006 wrote to the Premier of Victoria seeking his support for the renaming proposal. This followed an earlier briefing with the Premier in July 2005 regarding VOC planned activities, including the Olympics anniversary celebrations. The Premier then forwarded the matter to the Minister for Sport and Recreation (the Hon, J.M. Madden MLC). The Minister in turn preferred that the matter be dealt with by the responsible naming authority.

## Finance

- 16. The applicants have undertaken to reimburse Council's public consultancy costs.
- 17. All advanced directional signs are located on either VicRoads or City Link roads and Council will only incur minimal costs in replacement street naming signage (less than \$2,000). Those costs can be readily met from existing budgets.

## Legal

18. The renaming of roads must comply with the *Geographic Place Names Act* 1988 and with current Guidelines under that Act. Roads can be renamed under the *Road Management Act* 2004 (Section 11) and pursuant to the *Local Government Act* 1989 (Naming of Places (Including Roads) Policy under Council's *Activities Local Law* 1999).

## Sustainability

19. The proposal should have no effects or impacts on sustainability issues.

## Comments

- 20. The proposal is forwarded to the Committee for determination given the significance of the road and its environs.
- 21. A possible renaming of "Swan Street Bridge" was also raised. It might be incongruous to keep that name, but alternatively the bridge is well known and the retention of the name could identify the history of names and be quite warranted. Careful attention should be given to the change of any place name, each having a history that must be considered. Some parties expressed interest on the bridge, but considerably more consultancy was requested and needed, including possible contact with the Minister for Transport and further DSE review. This could not occur within the available timeframe, but could be later pursued.


- 22. Swan Street is a declared arterial road for which VicRoads is the coordinating road authority under the *Road Management Act* 2004 but Council is the responsible road authority for certain elements of the road. The Registrar considers VicRoads to be the proper naming authority for the road, but has not objected to Council proposing such. The Registrar is primarily concerned that any renaming has been founded on consultation and agreement between VicRoads and Council. Furthermore the Registrar does not consider the proposal to hold statewide significance (the Act prescribes that certain place namings hold statewide significance and must be named by an appointed Panel).
- 23. Swan Street is principally a local road name and the renaming proposal is likely to be of interest to abutting land managers, businesses, special interests groups and the community generally. On that basis VicRoads has formally delegated (under seal) its naming powers under the *Road Management Act* 2004, to Council's Chief Executive (refer Attachment 5).

## Background

- 24. Olympic Park was developed for the 1956 Olympic Games including the building of two stadiums, a velodrome and a then new world standard 5,500 seat swimming pool (now the Lexus Centre). Those venues hosted the Game's hockey, cycling, soccer, athletics, diving and swimming competitions. The area has since remained and has been further developed and continues to be further developed, as a sporting mecca. It is a nationally and internationally recognised world class sporting precinct.
- 25. This is a proposed commemorative naming coinciding with planned extensive 50<sup>th</sup> anniversary celebrations of the 1956 Olympic Games. Over 300 Australian and International Olympians from the 1956 Olympics will return to Melbourne to celebrate the Golden Jubilee of those Olympics. The celebrations will doubtlessly receive considerable media attention, thus providing another significant opportunity of showcasing this sporting precinct and serving as a reminder that Melbourne is an Olympic City.
- 26. The VOC has commissioned two very significant bronze commemorative tableaus. These together with the reinstatement of the restored Olympic Rings on the Olympic Park Stadium, will assist visitors identifying the Olympic site and its evolution. The applicants further propose with the establishment of the name "Olympic Boulevard", to place Olympic themed portals at the entry and exit points to the road.

The power delegated is subject to the conditions in Schedule 1 to this Instrument.



# INSTRUMENT OF DELEGATION

## Schedule 1

This Instrument of Delegation is subject to the following conditions:

- a) The Melbourne City Council must conduct the change of name in accordance with all legislative requirements, in particular sections 11(9) and 11(10) of the *Road Management Act 2004*.
- b) The Melbourne City Council must notify VicRoads immediately the change of name is completed or the proposal to change the name is abandoned.
- c) This Instrument of Delegation ceases to have effect once:
  - i. the delegated power has been exercised in accordance with legislative requirements; or
  - ii. the proposal to change the name of Swan Street Melbourne is abandoned; or
  - iii. 30 March 2007,

whichever is earlier.

## LEGAL ATTACHMENT

## PROPOSED RENAMING OF SWAN STREET, MELBOURNE (BETWEEN BATMAN AVENUE TO PUNT ROAD) TO OLYMPIC BOULEVARD

Council's powers with respect to naming roads are set out in the *Activities Local Law* 1999, Section 206 of the *Local Government Act* 1989 ("the Act") and paragraph 5 of Schedule 10 in the Act.

Paragraph 5(1)(a) of the Act provides that Council may "*approve, assign or change the name of a road*".

Paragraph 5(2) of Schedule 10 of the Act provides that in exercising this power Council must act in accordance with the guidelines in force for the time being under the *Geographic Place Names Act* 1998 and advise the Registrar appointed under that Act of the action Council has taken.

Council is required to notify the Registrar of Geographic Place Names of any change to a road name within its municipality to enable the Register to be amended. The Registrar normally requires details of the name change and an accompanying map.

The *Activities Local Law* 1999 provides that no person may give, approve or allot a name to any road without the approval of Council. The accompanying policy and procedural standards specify the procedure to be followed when considering naming and renaming proposals, including a requirement that the views of potentially affected property owners be sought and, if necessary, submissions sought from the public and relevant service authorities.

The procedure detailed in the report is consistent with the policy and procedural standards.
