On behalf of the Parents Television Council and its over 800,000 members, I am filing an indecency complaint against the NBC network television program, *Will and Grace*. The episode that contained the indecent material originally aired at 9:00 p.m. on November 13, 2003. This program was seen in homes across the country on NBC, and in Washington DC, the program aired on WRC.

If the content is found to be indecent, then a Notice of Apparent Liability should be levied against each NBC affiliate that aired the program.

A transcript of the indecent segment follows. I would be happy to provide you with a videotape of this episode to further demonstrate the indecency of this episode.

Partial Transcript

Will and Grace
November 13, 2003

Show Summary: Will takes Karen to get a physical and encounters a very odd doctor played by Jack Black. Later, at Will's apartment-

- Jack: "Well while I was waiting I met Student Nurse Clark. We started talking, then there was some flirting, a little over the smock fondling. And then you can probably guess what happened next."
- Will: "A law suit?"
- Karen: "Under the smock fondling?"



- Jack to Karen: "Yes and nursing. I enrolled in nursing school."
They refuse to give him the money for school.
 - Jack: "And if you can't support me you are dead to me. No, not dead, because a nurse takes a oath to prevent death. You have crabs that won't go away and you have a smattering of adult acne."
 - Will: "We're gonna give him the money aren't we."
 - Karen: "Honey we have to. Its what we do. We're Will and Grace. Now come on, sit next to me on the couch and we'll dry hump."
- He sits down next to her.

When Student Nurse Derek finds out that Jack is dropping out he runs away crying.

- Nurse: "They were lab partners. Derek really hitched his wagon to Jack's star. Somebody walked in a saw them."
