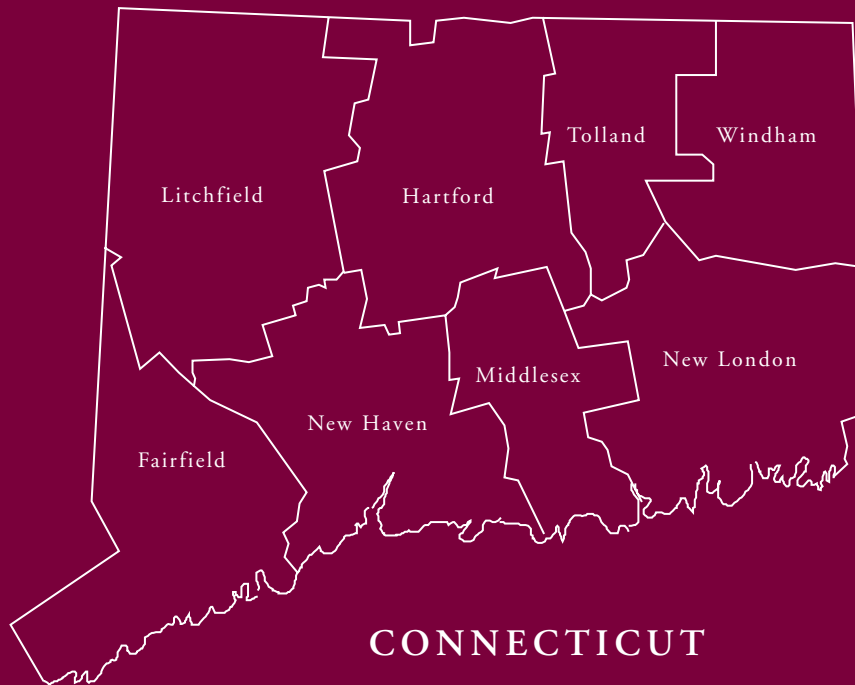

- breakdown of units by bedroom size and total units
- type of housing, such as family, elderly and single room occupancy (SRO), Real Estate Owner (REO)
- amenities included (if any), such as an elevator, garage and/or swimming pool
- name and telephone number of the managing agent
- type of financing assistance (if any), such as Section 8, Section 236, supportive housing and co-ops *
