Executive Summary

Fiscal year 2007–2008 was a year of major change on many levels at the Board, but all consistent in purpose—to assist the Board in its mission to better serve the public.

Effective January 1, 2008, the structure of the Board changed. There is no longer a separate Division of Licensing and a Division of Medical Quality; the full Board meets as one deliberative body. This gives all members of the Board knowledge about policy and statutes for both licensing and enforcement functions.

Further, as of August 1, 2008, the composition of the Board changed from 21 members to 15—seven public and eight physician members. This reduction in numbers was intended by the Legislature to increase the efficiency of the Board. Staff functions remain substantially the same, with licensing and enforcement programs, rather than divisions.

The Board's Diversion Program, in effect since 1980, was allowed to sunset and ceased to exist on June 30, 2008. This occurred after five failed, independent audits and numerous attempts by the Board to fix the many problems that led to its demise. Fundamentally, the Board voted unanimously, and the Legislature concurred, to eliminate the program because its critical component of secrecy ran contrary to the Board's consumer protection mission. Physicians with substance abuse problems who now come to the attention of the Board will still have the option of entering private treatment programs, but may face discipline, not "diversion" to a confidential program of the Medical Board. This controversial action was taken only after a great deal of public discussion and deliberation by the Board and the Legislature. As a result, a diversion-participant transition plan

was developed and implemented. The Board's Wellness and Education committees are discussing ways to assist medical students and physicians in both preventing and effectively dealing with issues surrounding substance abuse.

In March 2008 Board staff moved its Sacramento headquarters, which it had occupied since 1976, to a modern, efficient office about two miles away. The new building, at 2005 Evergreen Street, also is occupied by other boards and bureaus under the Department of Consumer Affairs. The layout of the old building was fragmented, making it difficult for all visitors to find offices, and the structure itself was outdated and failing. Now staff may better serve both the public and our licensees from a location that is more secure and user friendly.



Medical Board of California 2007–2008 Fiscal Year



Licensing Program

The Licensing Program promotes public protection for health care consumers by ensuring all applicants' educational credentials and training meet statutory and regulatory requirements prior to issuing physicians' and surgeons' and allied health care professionals' licenses. The Licensing Program also issues fictitious name permits, administers the continuing medical education program, and manages the cashiering and consumer information unit functions.

During the last fiscal year, the Licensing Program received 6,192 new physicians' and surgeons' applications and issued 4,787 licenses. The licensing activity tables on the following

page illustrate the volume of physicians' and surgeons' and allied health care professionals' licenses in effect and other licensing operations workload processed by program staff.

Some key Licensing Program accomplishments during the past fiscal year included completing the first annual licensed midwifery report on out-of-hospital births, convening a special program workshop for the eight California medical schools, successfully completing a cashiering unit audit, and combining the Licensing and Enforcement programs' call centers into one call center to provide more effective customer service.

Diversion Program

The Medical Board's Diversion Program was established in 1980 as a monitoring and rehabilitation program for impaired physicians. Since that time, the program has been audited five times and each audit found problems within the program indicating it was not adequately monitoring drug- or alcohol-addicted physicians. After each audit, the Board made improvements to the program to implement the recommendations of the auditor.

However, in June 2007, a report released by the Bureau of State Audits identified several ongoing problems with the Medical Board's Diversion Program. In light of this report, the Board voted not to support legislation to continue the Diversion Program. With no legislation introduced to extend the program, a transition plan was established and approved by the Medical Board in November 2007. The plan identified the different groups of program participants and determined a course of action for each group following sunset of the Diversion Program. On July 1, 2008, the laws for the Diversion Program became inoperative and will be repealed on January 1, 2009. Therefore, the Medical Board no longer has a Diversion Program.

Enforcement Program

The vertical enforcement pilot was extended to July 1, 2010 (SB 797, Ridley-Thomas, 2008). This is a law that requires investigators of the Medical Board and prosecutors from the Health Quality Enforcement Section of the Office of the Attorney General to work together from the outset of an investigation of possible physician misconduct to the conclusion of any legal proceedings (if warranted). Procedures and guidelines to refine this process continue to be developed, and staff from both agencies remain dedicated to the program's success.

The probation program underwent a substantial reorganization during this fiscal year. Previously, peace officer investigators were assigned to monitor probationers. Since the vast majority of probationers comply with the terms and conditions of their probation, it was decided to assign the monitoring function to investigator assistants (who are non-sworn) and reclassify them to inspectors. This has enabled a redirection of peace officers to the field to conduct investigations, which lowered investigators' caseloads, and lower caseloads should shorten the overall time in which an investigation can be concluded.

Tremendous effort was focused on training this fiscal year. Sixteen hours of specialized training was provided for all district medical consultants. A 32-hour training course was provided to all supervising investigators and staff services managers.

Retention remains a serious problem for the Enforcement Program, as well-trained Medical Board investigators are highly sought after by state agencies with more competitive pay scales. The Enforcement Program made great strides in reducing the overall vacancy rate. District supervising investigators have been vigilant in recruiting investigators for impending vacancies (rather than waiting for the vacancy to actually occur). Field investigators also have participated in numerous outreach efforts (college job fairs). That, coupled with the efficiency of staff in the Office of Standards and Training, enabled the Board to hire 13 investigators, one Supervising Investigator II, one Supervising Investigator I and five inspectors since November 2007.
