Changes effected by Order of the Secretary of State under the Local Government Act 1972

There is 1 Order giving effect to recommendations to change the electoral cycle

THE DISTRICT OF BROADLANDS (WHOLE COUNCIL ELECTIONS) ORDER 2006 (S.I. 2006 NO. 245)

This Order changes the electoral cycle from thirds to whole council elections from May 2007. The Order was made on 6 February 2006 and came into effect on 17 February 2006.

Changes effected by Order of the Secretary of State under the Local Government and Rating Act 1997

- 1. There are 8 Orders giving effect to recommendations resulting from the district reviews made by the Secretary of State under section 9 of the Local Government and Rating Act 1997.

THE BRADFORD (PARISHES) ORDER 2006 - S.I. 2006 NO. 505

*This Order created two new parishes of Burley and Menston and made alterations to the parishes of Denholme and Oxenhope. The Order directed the Bradford City Council to establish parish councils for each of the new parishes. The Order was made on 24 February 2006 and came into effect on 1 April 2006.

THE GATESHEAD (PARISH) ORDER 2006 - S.I. 2006 NO. 716

This Order abolished the parish of Birtley. The Order transfers the area to an unparished area of Gateshead Borough Council. The Order was made on 10 March 2006 and came into effect on 1 April 2006.

THE KETTERING (PARISHES) ORDER 2006 - S.I. 2006 NO. 504

This Order transferred areas between the parishes of Barton Seagrave, Burton Latimer and Pytchley and an unparished area. The Order was made on 24 February 2006 and came into effect on 1 April 2006.

THE SOUTH BUCKS (PARISHES) ORDER 2005 - S.I. 2005 NO. 2931

This Order transferred areas between the parishes of Denham, Dorney, Fulmer, Gerrards Cross, Iver, Taplow and Wexham. The Order was made on 17 October 2005 and came into effect on 1 April 2006.

THE STRATFORD-ON-AVON (PARISHES) (AMENDMENT) ORDER 2006 – S.I. 2006 NO. 61

This Order amended and substituted sheet 2 of the Maps of the Stratford-on-Avon (Parishes) Order 2004. The Order was made on 12 January 2006 and came into effect on the same day.

THE STRATFORD-ON-AVON (PARISHES) ORDER 2006 – S.I. 2006 NO. 526

This Order transferred areas between the parishes of Alcester, Arrow with Weethley, Beaudesert, Bidford-on-Avon, Burton Dassett, Butlers Marston, Chadshunt, Charlecote, Combrook, Compton Verney, Dorsington, Exhall, Halford, Hampton Lucy, Henley-in-Arden, Kineton, Lighthorne, Loxley, Moreton Morrell, Newbold Pacey, Snitterfield, Stratford-upon-Avon, Tanworth-in-Arden, Tredington, Welford-on-Avon, Wellesbourne and Wixford. The Order was made on 28 February 2006 and came into effect on 1 April 2006.

THE WELLINGBOROUGH (PARISHES) ORDER 2005 - S.I. 2005 NO. 2582

This Order transferred areas between the parish of Wilby and the un-parished area of the borough of Wellingborough. The Order was made on 9 September 2005 and came into effect on 1 April 2006.

THE WEST LINDSEY (PARISHES) ORDER 2005 - S.I. 2005 NO. 2581

This Order transferred areas between the parishes of Barlings and Scothern. The Order was made on 6 September 2005 and came into effect on 1 April 2006.

2. Order giving effect to recommendations resulting from petitions made to the Secretary of State under section 11 of the Local Government and Rating Act 1997

*indicates that the local authority has been directed by the Secretary of State to establish a parish council.

THE ISLE OF WIGHT (PARISHES) ORDER 2006 - S.I. 2006 NO. 503

*This Order created two new parishes called Fishbourne, and Havenstreet and Ashey. The Order directed the Isle of Wight Council to establish a parish council for each of the parishes. The Order was made on 24 February 2006 and came into effect on 1 April 2006.

Allows the parish meeting of Kentmere to exercise the powers of a parish council. The Order came into effect on 22 March 2006.

3. Orders amending electoral arrangements under section 17 of the Local Government and Rating Act 1997

ABBOTS MORTON PARISH COUNCIL ORDER 2006 (WYCHAVON DISTRICT COUNCIL)

Reduces the number of councillors from nine to seven. This Order was made on 14 February 2006.

BOLTON PARISH COUNCIL (COUNCILLORS) ORDER 2006 (EDEN DISTRICT COUNCIL)

Increases the number of councillors from five to seven. This Order was made on 10 January 2006.

PARISH OF COLDHARBOUR (COUNCILLORS) ORDER 2005 (AYLESBURY VALE DISTRICT COUNCIL)

Increases the number of councillors from nine to eleven. This Order was made on 25 July 2005.

PARISH OF HALTON (COUNCILLORS) ORDER 2005 (AYLESBURY VALE DISTRICT COUNCIL)

Reduces the number of councillors from ten to nine. This Order was made on 25 July 2005.

PARISH OF LITTLE HORWOOD (COUNCILLORS) ORDER 2005 (AYLESBURY VALE DISTRICT COUNCIL)

Increases the number of councillors from five to seven. This Order was made on 25 July 2005.

PARISH OF PITSTONE (COUNCILLORS) ORDER 2005 (AYLESBURY VALE DISTRICT COUNCIL)

Increases the number of councillors from nine to ten. This Order was made on 25 July 2005.

PARISH OF SONNING COMMON (COUNCILLORS) ORDER 2005 (SOUTH OXFORDSHIRE DISTRICT COUNCIL)

Reduces the number of councillors from fifteen to twelve. This Order was made on 3 October 2005.
