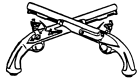

taste. The city's motto is "We Feel Good", in recognition of native son and soul music legend James Brown. A statue dedicated to James Brown, is located downtown at the Augusta Commons. Augusta's "downtown" has bloomed with many new businesses within the city. Broad Street -- downtown -- is host to many bars and music clubs that now enjoy popularity since instituting "First Friday," the celebrated first Friday night of each month. The carnival-like atmosphere of "First Friday" has helped many businesses to flourish.

Tourists also ride along the Augusta Canal, built in 1845 as a power source, in a Petersburg boat. The Augusta Marina rents boats for a fun day on the river. Energy nuclear facility) and the U.S. Army Signal Center, Fort Gordon. The Medical College of Georgia is the third largest employer in Augusta. Something to satisfy every interest can be found in Augusta.

As the host of the 2008 reunion I would like to provide our attendees with an update on the events you will enjoy in Augusta between 24 and 28 September 2008.

Overview. The basic events of the reunion.....the welcome buffett, the memorial breakfast and the banquet have been contracted for, menus selected, color guards and U.S. Army Signal Center Band coordinated with and entertainment and music for the banquet selected and booked. More on each of these events follow below. The hospitality room and transportation to Fort Gordon, Savannah River Site and the Augusta Canal for the Petersburg boat trips and Aiken for the tour of homes and shopping have also been finalized. So in short, things are coming together very nicely and I am happy to report that you can expect a splendid experience in Augusta.

Specifics of note.

1. The first day Wednesday 24 September will of course be registration followed by a lovely buffett. The spacious hospitality room will be open at 1200 hours and ready to meet and greet old friends with the beverage of your choice.

2. Thursday 25 September will be a busy but pleasant day for the attendees.

Starting this date, the hospitality room will daily offer a continental breakfast before tour/event departures. Starting early will be the tour to the Dept. of Energy's Savannah River Site courtesy of our corporate sponsor Wackenhut. *If you opt for the SRS Tour, you will need to complete and fax back the Savannah River Site Tour form found in the middle of this Digest. Non U.S. Citizens will need the Foreign Visitor Form.* In the early afternoon (1400 hours) our Fort Gordon tour will depart for our visit down memory lane and to see the many new facilities now offered by a modern-day Army Post. This stellar tour will conclude with our attendance at the Fort Gordon Dinner Theater with a fine buffet provided by the Fort Gordon Club which many of us remember as the fort's NCO club. As information, the Fort Gordon Provost Marshal is our project coordinator for this fine experience and will provide MP tour guides on each bus. The Fort's Dinner Theater is well known for its professional performances in the Augusta area for over 25 years and offer 7 separate plays annually. Most recently the Fort's presentation for Cabaret was sold-out for weeks. So expect something special! Please note due to transportation limitations this Tour to Fort Gordon is limited to the first 135 registrations.....on a first come basis.

3. Friday morning after an early Continental breakfast our stalwart golfers will depart for a great golf outing at the exclusive River Course across the Savannah river from the Marriott hotel. The golfers will be exposed to a fine and manicured course and will conclude their outing with a lunch at the River Course Grill. Trophies will be presented to the winning team, for the longest drive, closest to the pins, and finally to the most athletically challenged team.

4. While our golfers are enjoying

the morning at the River Course our first group of boaters will depart at 10:00 for the scenic nature viewing trip on the Augusta Canal which will include beverages and a fine catered box lunch. This is a three (3) hour terrific experience riding in replicated Petersburg Boats that in pre-civil war days carried cotton to the market in Augusta. These are electric-powered boats that hold 40 passengers each. The second/afternoon voyage departs at 1400 and will also include beverages and a fine catered box supper meal. As you can see seating is limited for this experience.....so reservations will be on a first come basis. To assist in making this unique experience available to as many attendees as possible..... attendees will automatically be slotted against available seats. Every effort will be made to accommodate preferences for morning or afternoon voyages but we will also try our utmost to seat interested attendees if one or the other of the trips if their initial choice is already full when registrations are closed.

**So please register early
by NLT 1 JULY.**

Again note each iteration is limited to 40 attendees on a first come basisas that is what each boat will accommodate.

5. Those who chose the Aiken Tour will have a 6-hour experience leaving the hotel at 9 am. At Aiken there will be a 2 hour motorized guided trolley tour of picturesque Aiken's "Winter Colony" homes chosen for their architectural significance, a short, easy walking tour of Hopeland Gardens, a drive through of race and polo horse training facilities and farms, a visit to the Horse Racing Museum, a box luncheon and a specially guided tour by the Executive Director of, the Banksia Estate, a 32 room antique filled

home of the Aiken County Historical Museum which presents a picture of Aiken County over the last hundred or so years, the beginning of pottery in the South, wartime artifacts from the Revolutionary War to Iraq and much, much more. There will also be time for 2 free hours to explore the four square block downtown area of antique, art, gourmet and specialty shops, try the varieties of beer and coffees at the local cafes and microbrewery or just sit and "people-watch". This tour is limited to 48 attendees on a first come basis.

6. Presently the Augusta Visitors Bureau is planning a gala event at the city's Bell auditorium for Friday evening 26 September. Early reports indicate that this evening will be devoted to a combination symphony and ballet presentations. As more information is available it will be posted on the RMPO Webpage. I strongly urge all members to visit our RMPO Web page for periodic reunion updates. The entertainment picture in Augusta is diverse and as other special events are available.....they will be posted on our web page for the consideration of our reunion attendees. Please know that we are doing everything possible to provide a wonderful time in Augusta for our folks.

7. Please note that the Memorial Breakfast has been rescheduled from its traditional Sunday morning position to Saturday morning. The rationale for this change is driven by travel requirements inherent to our country's security posture since 9/11. Your reunion committee has listened to many requests for schedule change as this important event has in many instances been by-passed as folks are scrambling to make planes for their trips home. Now we will present this

important event with all the reverence it deserves with color guard, reading of scripture, calling the names of the year's departed and concluding with taps..... at a pace and time that maximizes both fellowship and attendance.

8. The Saturday evening 27 September banquet is going to be the highlight of the reunion. We will start with cocktails and listen to appropriate preamble music presented by the full Fort Gorton Army Band. The colors will be posted and toasts proposed. Our guest speaker will be the CSRA Wounded Warrior Advocate/representative and previous TV anchor Ms. Laurie Ott. She is working closely with both the Dept. of Defense and the Veterans Administration to help our returning warriors both heal and get on with their lives.. The entertainment will be provided by a group billed as the "Boogie-Sisters" who reinvent the performances of the Andrews Sisters of years gone-by. The music will be provided by the Fort Gordon Jazz Band playing Glenn Miller sweet music that we danced to when we were young. Finally, a large cake will be cut celebrating the Military Police's Birthday by junior and senior members of the RMPO. The host's sword will receive a special cleaning for this ceremony!

9. Item last: The block of rooms reserved for the RMPO at the Marriott has been **sold-out....completely**. If any members must cancel their already confirmed Marriott reservation please do so through Tom Regel. This way the RMPO will retain that canceled slot and be able to provide it to another member vice simply placing that space as available for any request from outside the RMPO. Please take time to follow this cancellation procedure as when you cancel the RMPO can lose a reserved space in their block of rooms. As information we booked

a block based on previous attendance at several different reunion venues. Reservations are now available near the reunion headquarters hotel at the following nearby locations. As previously reported our reunion is in competition with two other large conventions for space at the Marriott Hotel.....our reunion headquarters hotel in Augusta. As of nowour reserved block at the Marriott is full. As hoped, many RMPO Members have chosen to return home to Augusta for our 2008 reunion. Your reunion host and team are delighted! Know that we have planned for such a housing overflow situation. So good news follows! Besides asking both the Marriott and the two above cited conventions for any spaces that might later be available due to cancellations..... we have arranged for other lodging near the Marriott. 1. Our **First** choice is.....The River Golf Club where we will be conducting our reunion golf outing has agreed to provide sixteen (16) separate rooms in their new golf condominium complex. A very short 5 minutes from the Marriott hotel. This is the best bed and breakfast Inn in the Augusta Area. The owners have agreed to block twenty (20) rooms for the RMPO and give us a military discount of \$40 per nightWed. and Thursday and a 15 % discount for Friday & Saturday stays. Note: this is a very popular and upscale spot in Augusta.....hence our block of rooms are only reserved through April 2008. After April, rooms may not be available with the RMPO military discount. “HISTORIC MEETING ON THE ELBE”

The 63rd Anniversary of Victory in Europe (VE) Day is an important event in World history. Both Russia and America also celebrate a lesser momentous, but significant event.

In April 1945, nearly 11 months after D-Day (6 June 1944) and a few days before Germany's total surrender, the Russian Army had completely encircled Berlin and all of Germany became Allied territory. The end of the Third Reich was rapidly approaching. On 25 April, US First Army patrols from the 69th Infantry Division made contact with 58th Rifle Division of the 1st Ukrainian Front advancing from the east. The meeting occurred on the banks of the Elbe River near Torgau. On May 7th in Reims, France, the German High Command surrendered all land, sea, and air forces unconditionally to the Allies effective 9 May bringing about Victory in Europe Day (VE Day).

The anniversary celebration of the Elbe Meeting has continued through the years. Paralleling the entrance to the WWII Memorial on the Washington DC Mall (vicinity of 17th Street) is a bronze relief panel (total of 24 magnificent panels) commemorating the meeting of US-Russian troops at the Elbe. Also, the Russians placed a commemorative stone -- “Spirit of the Elbe Memorial” -- in Arlington National Cemetery. Each year, Russian Diplomatic Corps and WW II veterans hold a traditional wreath laying ceremony. On April 25th, the Russian Ambassador and representatives from other former Soviet Republics along with a small number of American World War II veterans including Colonel (Ret) Frank Cohn and Mrs Natalia George – representing her husband LTC (Ret) Ralph George, (Deceased), participated in the traditional wreath laying ceremony at the Russian “Elbe” monument in Arlington National Cemetery. The ceremony -- commemorating the 63rd anniversary of the meeting of US and Russian troops -- was also attended by a representative of the Office of the Secretary of the Army. Each placed a wreath at the marker. A reception was held at the Russian Embassy.

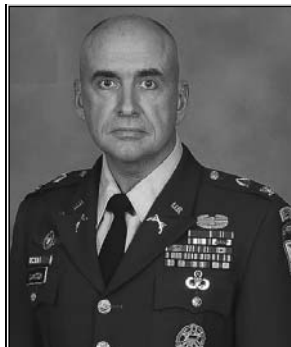
As I transition out of the United States Military Police School as its 50th Commandant, I wanted to take a moment and thank our GREAT retiree community for its continued support of our Regiment. I will be heading over to Iraq to be the Deputy Commanding General (Detainee Operations) for the Multi-National Force-Iraq (MNF-I), dual-hatted as the Commanding General of Task Force 134. I am looking forward to the challenges of this new position which has seen dramatic improvements in the care and custody of detainees since I left that mission in 2005. With the superb work done by our great Soldiers and Leaders of this regiment, we will continue to see improvements in this strategically important mission, while working to transition this responsibility over to the Iraqi government. I will be replaced by BG Dave Phillips who is coming out of Iraq as the Director of CPATT, overseeing the rebuilding of the Iraqi Police Force. His assignment to USAMPS will be perfect as we continue to transform our School into a Department of Defense Law Enforcement Center of Excellence by incorporating the lessons learned from his work in the contemporary operating environment.

Our Regiment is as busy as ever as our missions downrange continue to grow and develop. When you look at what Military Police units do in Iraq and Afghanistan, it falls into two mission areas, Police Transition Teams and Detainee Operations. Today the 18th Military Police Brigade provides Police Transition Teams overseeing hundreds of police stations while the 177th/300th and 42nd Military Police Brigades secure over 20 thousand detainees. Both of these missions are strategically important/essential for our Army's success in Iraq and, ultimately, the security of our Nation. While our brave Soldiers continue to excel at the "point of the spear," USAMPS continues to reinvent and transform itself into a fully functional Center of Excellence. Our number one priority continues to be support to our forces in the fight while training Soldiers that are prepared to deploy when they arrive/return to their units whether that is a new PVT, NCO, 2LT, or CPT. We are transitioning our courses to provide more law enforcement training while keeping the warrior tasks that make our Military Police a true full spectrum force. In sum, we are never happy with our curriculum, always trying to find a way to rapidly insert a lesson learned into our training to give our Soldiers the advantage on the battlefield.

It has been the highlight of my career to be the Chief of the Military Police Corps Regiment and the Commandant of the United States Military Police School. I hope to continue to contribute 110% to our great Army until they tell me its time to join all of you! Thanks again to all of you for your continued support of the Military Police Corps Regiment!

COL (Ret) Henry "Hank" Gerecke, 87, and wife Millie reside in Cape Girardeau, Missouri where Hank was Chief of Police from 1977 to 1982. Hank spent 35 years in the MP Corps serving in World War II, Korea and Vietnam. Hank was thrust into the spotlight in December 2007 when several murder cases during Hank's tenure were solved and the alleged serial killer and rapist was charged. Millie served as the rape counselor for the city at the time. Hank and Millie met in Nancy, France where Millie was an Army nurse during World War II. At same time, Hank's father was a Lutheran Chaplain in WW II assigned to the 98th General Hospital in England in 1943. After the war in 1945-46, senior Gerecke was assigned to the Nürnberg Trial as chaplain to the defendants. A remarkable letter — now on exhibit at the Concordia Historical Institute on the campus of Concordia Seminary in Clayton, Missouri -- begins: "My dearest Mrs. Gerecke (Hank's Mother), Your husband Pastor Gerecke has been taking religious care of the undersigned Lutheran defendants during the Nürnberg Trial." "The undersigned" include Hermann Goering, Albert Speer, Rudolf Hess, Julius Streicher, and 17 other Nazi officers who were imprisoned and tried. Some were executed for crimes

against humanity. Four were Catholic and 17 identified themselves as Protestant. Chaplain Gerecke lived and prayed with them, met with their families and walked many of them to the gallows. The exhibit, called "In the Gospel: Lutheran Church-Missouri Synod (LCMS) Military Chaplaincy," hronicles the service of military LCMS chaplains from the Civil War to the wars in Iraq and Afghanistan.

Privacy -- RMPO Roster. The Roster is used solely for two purposes: 1) invitation to the annual RMPO reunion, and 2) mailing list for the retiree newsletter (RMPO Digest). Those on the Roster are assured that names and addresses are not provided to organizations or individuals for purposes of solicitation. On occasion it is used to assist one RMPO to get in touch with another. Over the past eight years or so, the Roster has grown from a few hundred to nearly 1,500 retired MP officers including about 180 widows. It is estimated that between 3,000 to 4,000 retired MP officers reside somewhere in CONUS, so requests to locate them

continue. Over the years of Digest publication, a number of requests for paid "ads" have been received including some (e.g., consultants, business developers, etc.) who would like to simply put their business cards in the newsletter. The Digest has not favorably considered any requests for paid advertising. The "publication concept" for starting the Digest (and web site) back in 1997 was to become self-sustaining by providing "human interest" material that is considered "something of value" and supported by the recipients (donations). Therefore, subscriptions and paid advertisements are not used. The Roster, Homepage and Digest are treated foremost with privacy considerations.



IACP Veterans Project. The International Association of Chiefs of Police (IACP) has established a "Veteran-Cops Advisory Committee" to study the issues of "Employing Returning Combat Veterans as Police Officers". Among the large group of experts on the advisory Committee, the IACP has enlisted the aid of a number of RMPO officers for this project including MG (Ret) Gene Cromartie, Colonels (Ret) Frank Cohn, Arnie Claudio, Arnie Daxe, and Pat Lowrey. The first Advisory Committee Meeting, held on 22 January 2008 at the IACP Headquarters (Alexandria, VA), formed the framework for this important project. COL (Ret) Arnie Daxe was subsequently appointed Project Manager. Four focus groups are convening in various cities with each group comprised of 12 combat veterans (sworn police), 2 or 3 facilitators, a Psychologist, and IACP staff. The proposed outcome of the project are two guides and a training protocol that will benefit both police departments and returning veterans.

The Hall of Fame Induction Ceremony was held on Friday, 25 April 2008 at the end of the annual Regimental Strategic Forum and the Warrior Police Challenge Week from 21 to 26 April 2008. The Hall of Fame induction events began with an informal sit-down dinner for honorees, families, and friends hosted on April 24th as guests of BG and Mrs. Quantock at their quarters on Fort Leonard Wood. On Friday, April 25. the USAMPS Commandant's Invitational Luncheon for honorees and guests was held at the Pershing Community Club at which the inductees were formally introduced. Following the luncheon, the photo hanging ceremony at the Hall of Fame Center in the MP Museum. The military construction projects on the Wiesbaden garrison supporting the move include a network warfare center, a consolidated intelligence center, and a headquarters building which is the largest single Army construction project in Wiesbaden. A housing program will construct 326 new dwelling units on farms. A host of existing, unrelated construction projects at Wiesbaden, include whole neighborhood revitalization efforts at the Hainerberg, Crestview, and Aukamm housing areas; a new lodge, a bowling center, and several smaller flagship renovation and environmental projects. The numbers of Americans in Wiesbaden during the next five years is expected to rise from 12,000 Soldiers, family, and civilians to 16,000.

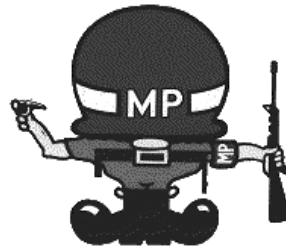
