Methodology

The survey findings presented in this release are based on the results of interviews conducted June 16-22, 2008. The interviews were conducted at the Center for Opinion Research at Franklin & Marshall College under the direction of the poll's Director, Dr. G. Terry Madonna, Head Methodologist, Berwood Yost, and Project Manager, Jennifer Harding. The data included in this release represent the responses of 1,501 adult residents of the United States who are currently registered to vote. Telephone numbers for the survey were generated using random digit dialing, and respondents were randomly selected from within each household. Survey results were weighted using an iterative weighting algorithm.

The sample error for registered adults is +/- 2.5 percent. In addition to sampling error, this poll is also subject to other sources of non-sampling error. Generally speaking, two sources of error concern researchers most. Non-response bias is created when selected participants either choose not to participate in the survey or are unavailable for interviewing. Response errors are the product of the question and answer process. Surveys that rely on self-reported behaviors and attitudes are susceptible to biases related to the way respondents process and respond to survey questions.

Key Findings

The Presidential Election

The June 2008 Franklin and Marshall College Poll of registered adults finds Democrat Barack Obama leading Republican John McCain by six points, 42% to 36%. Obama leads among those under 55 years of age, blacks, Hispanics, and those living in the Northeast and Midwest (see Table A-1). McCain has an advantage among those over 55, non-Hispanic whites, fundamentalist Christians, and military veterans. Both candidates fare well among their party faithful, and Obama has an advantage among independents (see Figure 1).

Attitudinal variables are also associated with vote choice. Three in four (78%) registered adults believe the country is "off on the wrong track," and nearly half (42%) say they are worse off financially this year than last. Obama is currently leading among both of these groups (see Table 1). The economy (38%) and the Iraq War (18%) are most often mentioned as the issues that will influence



presidential vote choices in the fall, and Obama leads McCain among registered

adults who are primarily concerned with these two issues.




Figure 2. Candidate Favorability Ratings by Party

More registered Americans rate the candidates favorably than unfavorably. Partisan favorability scores show that John McCain is not as positively viewed among Republicans as is Barack Obama among Democrats (see Figure 2). Fewer Republicans have a strongly favorable opinion of John McCain (23%) than Democrats who have a strongly favorable opinion of Barack Obama (45%).

Economic Concern and Hardship

The race for the president is taking place at a time when Americans are focused intently on the economy. In addition to the results noted earlier about the direction of the country and respondents' financial standing, many Americans mention that economic issues are the greatest problems facing their families. Two-thirds of respondents name an economic issue (the economy in general-24%, gasoline and energy prices-22%, and personal finances-21%) as the biggest



problem facing their families. About seven in ten (66%) registered adults believe that the problems they are facing can be solved with the help of government.




Figure 3. Economic Hardships during Previous 12 Months

Many registered Americans have suffered some economic hardships during the previous 12 months. About one in four (24%) says they have been without health insurance coverage at some point during the past year, and one in five (21%) has experienced a reduction in pay (see Figure 3). Overall, half (52%) of registered adults have experienced at least one of the 11 listed financial hardships at some point during the past year, and these respondents are much more likely to vote for Obama (50%) than McCain (27%) in November.
