#### Welsh Church Act Fund Applications

#### **Options Considered/Reasons for Decision**

This report details applications for grant under the Welsh Church Act Fund.

The income for 2008/09 has yet to be confirmed by Monmouthshire County Council, managers of the whole Gwent fund. For current year planning it is assumed that a figure of £37,000 will be available as has been the case for several years. In 2007/8 a total of £25,100 was awarded to 33 organisations leaving a balance of £16,628.60 from the money available for that year, which can be added to that total making a total of £53,628.20 available

This is the second consideration of applications in the current year. Previous grants have been to the value of  $\pounds$ 1,000 as shown below:

#### Strategic Marketing and External Funding

# **Options Considered/Reasons for Decision**

A need to strengthen marketing and events programmes to capitalise on opportunities arising from the regeneration of the City and Ryder Cup 2010 has been recognised. Proposals to restructure the Economic Development Section to incorporate an enlarged marketing and events team are currently being finalised, in co-operation with other Service Areas. It has become apparent, however, that there is an urgent need to

create a new post of City Marketing and Events Manager to co-ordinate strategic marketing and events management to promote the City. In addition, it is clear that the role and structure of the European Affairs Team needs to be reviewed in light of the closure of the Objective 2 European funding programme and the move to the replacement Regional Competitiveness and Employment programme, 2007-2013.

7. To delete the post of Economic Development Manager Post SCP 47-50, and to create the post of Development Manager – SCP 51-54
