SuperJet International signs agreement with AMA Asset Management Advisors (Suisse) for 5 Sukhoi Superjet 100

SuperJet International and AMA Asset Management Advisors (Suisse) signed today an agreement for the acquisition of 5 new Sukhoi Superjet 100 aircraft for a total value of approximately 150 million US\$. The agreement refers to the SSJ-95 aircraft model.

The aircraft will be delivered by SuperJet International to AMA in the year 2011.

"I am very pleased for the settlement of this strategic agreement" – said Francesco Guarnieri, Chief Executive Officer of AMA Asset Management Advisors – "I do believe that these orders will be the commencement of a new financial cooperation with SuperJet International finalized to promote and support the development of Sukhoi Superjet 100 in Europe".

The SSJ is the most advanced and environmentally friendly new generation regional jet. Superior technical and operational characteristics make Sukhoi Superjet 100 a fully marketable and competitive product – cost-effective, easy to operate and maintain. Sukhoi Superjet 100 is a conceptually new platform designed specifically for a 100-seat segment offering the most efficient combination of regional efficiency with mainline capabilities. The first flight SSJ100 was rolled out from SCAC's final assembly shop at Komsomolsk-on Amur on September 26, 2007. First flight was successfully accomplished last May 19, 2008.
