Re: Presentation of the three candidates for the post of Judge at the European Court of Human Rights in respect of the Republic of San Marino

Dear Sir,

With reference to the post of judge at the European Court of Human Rights in respect of the Republic of San Marino which remains vacant, and following the rejection of the list of three San Marino candidates submitted on 6 November 2008, I wish to inform you that the San Marino government, conscious of the need to compensate for the absence of a judge and, at the same time, anxious to ensure full respect for the principles of democratic procedure, transparency and non-discrimination in seeking and selecting candidates for this post, published an announcement, dated 17 February 2009, in the press and on the Internet, to the effect that a new deadline had been set for the submission of candidatures, and forwarded this information to the relevant professionals and sectors.

In this notification, it was clearly stated that this was an extended deadline to the one specified in the public call for candidatures of 22 September 2008 and consequently that the applications already submitted were still considered as valid unless the individuals concerned expressly stated that they wished to withdraw.

This information was widely disseminated among the San Marino Bar Association, whose President I personally contacted to ensure that it was brought to the attention of all its members.

The information was also further relayed on several occasions in the press and on the Internet.

Despite that, upon the expiry of the deadline for the submission of applications (30 March 2009), the San Marino government noted that no candidature other than those already submitted by 15 October 2008 (previous deadline) had been put forward. On the contrary, one of the San Marino legal professionals had withdrawn his application, reducing the number of available candidates from 6 to 5.

Of the remaining candidates, the government has designated the following three (in alphabetical order)

- Mr Gianni Cardelli;
- Mr Guido Casali;
- Ms Kristina Pardalos.

Please find enclosed the CVs of the three candidates written in one of the two official languages of the Council of Europe, in line with the model *curriculum vitae* appended to Resolution 1646 (2009) adopted by the Parliamentary Assembly on 27 January 2009.

In the light of the above, I would be grateful if you would forward these candidatures to the competent bodies of the Parliamentary Assembly for examination, and in particular to the relevant Sub-Committee of the Committee on Legal Affairs and Human Rights before which the candidates will be invited for interview. If the conclusions of the Sub-Committee are favourable, the Parliamentary Assembly could then consider, if it deems it expedient, electing the judge at the next plenary session to be held from 22 to 26 June 2009.
