1 INTRODUCTION

Coorable and districts incorporates three residential communities including Nundroo on the Eyre Highway, less than 400 kilometres from the Western Australian border.

Nundroo was originally settled by pioneering sheep graziers. Today sheep and grain production still occurs, but Nundroo is now more famous for its roadhouse, a welcome stop for many people crossing the Nullarbor Plains. The roadhouse is a licensed restaurant, with a takeaway food menu, a large bar, fuel services, powered caravan sites, backpacker's facilities and air-conditioned motel rooms.





Coorabie located between Nundroo and Fowlers Bay is the central hub of the district Town Hall with а and the original schoolrooms with the oval, old post office and tennis courts located nearby. Originally part of the large sheep run that went from Nullarbor to Point Brown, the pastoral leases were given back to the government in the late 1880's and wheat and cereal growing commenced soon after. Today these crops are still grown and sheep are prevalent, although the number of people farming has declined, as farm size increases.

Fowlers Bay was named by Matthew Flinders after his Lieutenant Robert Fowler whilst they were undertaking a nautical chart of the area. In the 1840's Fowlers Bay became well known to French and American whaling ships and even today the Southern Right Whales can be seen making their way to the Head of the Bight for calving. A colony of sea lions can be seen residing annually at Point Fowler.



Fowlers Bay is a very scenic spot with the luxury of a commercial jetty, for the crayfish season and wonderful sand dunes for the adventurous 4WD person. The facilities for tourists within this community are very modern and well kept. The main attraction in this area is fishing and the area boasts an abundance of safe places to fish and an endless variety of fish to catch.



The Coorabie and Districts Progress Association and the Outback Areas Community Development Trust officially represent the district. For a district that has approximately 45 permanent residents, the attendance to the town meeting of 12 people, illustrates the communities desire to be actively involved in planning for their future.



Collins Anderson Management was commissioned by the Outback Areas Community Development Trust and the Northern Regional Development Board to prepare a Community Plan for Coorabie and districts. The Plan will assist in planning the future of the town by establishing clear goals, objectives and strategies to be addressed by the Outback Areas Community Development Trust, Northern Regional Development Board and the community as a whole.

This Plan highlights strategies to assist the town in moving forward. Improvements in infrastructure, economic development and the environment are key issues, specifically identified by the community and subsequently addressed in the Plan.





2 VISION

To become a thriving community with quality infrastructure, that is protective of its natural assets.





3 MISSION

The Coorabie and Districts Progress Association will work for the community to improve services and facilities, whilst maintaining its pristine environment.





4 KEY ISSUES

5 KEY GOALS & OBJECTIVES

Goal 1 Upgrade and improve the infrastructure of the district

Coorabie and districts have managed extremely well with limited infrastructure. Power supply to the district is in a variety of formats, therefore making repairs difficult and the supply of other services unpredictable. The residents have identified four key objectives.

1.1 Improve the quality of the districts power supply

Electricity supply to the district is sourced from generators and Nundroo has mains power. Fowlers Bay has no formal power supply with residents having to generate their own power.

Given the number of visitors to this area, services are often in high demand. If the areas is to develop its tourism potential then a permanent electricity supply would assist in ensuring a reliable and regular service to the visitor as well as the towns people.

Key strategies for this objective are:

- Request Outback Areas Community Development Trust seek funding to conduct an assessment of current power supplies
- Following the assessment, develop a Plan for upgrade of the electricity supply

1.2 Improved telecommunications

Given the distance between communities, the current telecommunications available in the area does not meet the districts needs. The area has limited public telephones and if damaged then the district is easily isolated. However Yalata has a CDMA mobile telephone service. The community recognises that they need to continue to lobby the appropriate authorities for coverage to the area.

Given the proximity to Penong and Ceduna, a mobile telephone tower would improve communications between the communities. It is understood that the Telstra Networking the Nation roll out will take place in this area later this year.

Television broadcast is intermittent to the district. Fowlers Bay is a black hole in the broadcast band, with no permanent power supply, however a community-viewing scheme is in place, which brings access to the wider community.

High speed internet access cannot be achieved with the current optic fibre cable.

Key strategies for this objective are:

- Lobby the Northern Regional Development Board to erect a mobile telephone tower in the district
- Request installation of additional public telephones
- Investigate television broadcast limitations

1.3 Secure a permanent water supply

Residents of the area are very conscious of their natural environment. The communities are very mindful not to waste water they currently obtain from their underground supply, of which the lifespan of this reserve is unknown.

The extreme climate changes make it difficult for residents to revegetate their environment with native species and a permanent water supply would assist them greatly in achieving this.

Innovative Fowlers Bay residents currently use windmills to pump water from a basin in the sand dunes.



Key strategies of this objective are:

- Coorabie and Districts Progress Association and Outback Areas Community Development Trust to review and assess alternative water supplies
- Develop a Plan of action to obtain further funding to provide a permanent water supply for the whole area
- Analyse funding options with Northern Regional Development Board and Outback Areas Community Development Trust
- Lobby key agencies and government bodies to obtain funding

1.4 Upgrade roads within the district

Roads within the area are repaired infrequently. Many roads off the Eyre Highway are gravel bed and are deteriorating rapidly with increased traffic and harsh weather conditions.

Residents have done well to keep roadsides clear and to reduce flooding and drainage problems to the low-lying areas.

With increased visitation to the area, parking bays will be required, especially at the Kooringabie Hall.



- Seek funding to conduct an assessment of current roads, drainage and parking for the district
- Develop a Plan to repair and upgrade the roads



Goal 2 Improve economic opportunities for the district

With an increasing cost of farm machinery, running costs and insurance, pastoral operations as a source of income are declining. The extreme weather conditions heighten the risks associated with crop production. The transportation of produce and goods is also very expensive.

Unlike other remote communities who have natural resources such as opals, salt, uranium, gypsum, etc the Coorabie district relies on farm production as the main source of income.

2.1 Capitalise on the impact of tourism for the district

The pristine environment along the coast of Fowlers Bay, offers the intrepid tourist a unique experience. Spectacular sand dunes, cliff tops and sparkling coral reefs are on offer at no charge.

The opportunity to view the Great Southern Right Whale as it takes it young back to the Bight is also a key tourist attraction. A permanently based sea lion colony can be viewed up close, and the ocean offers an abundance of sea life, including Great White Sharks.

A lack of tourist information and signage at Fowlers Bay leaves the tourist to find their own way around and many tourists only know about the attractions by word of mouth from the locals. With an irregular power supply and restricted water, facilities for tourists are also limited.

With improved signage, controlled access to areas of conservation and friendly local advice, the tourist experience could be enhanced with minimal disruption to the community.

- Form a tourism committee
- Develop a marketing theme and brand
- Improve current marketing and website material
- Improve tourist services and facilities
- Upgrade signage in the district
- Educate residents about the importance of tourism
- Lobby the South Australian Tourism Commission and Outback Areas Community Development Trust for support





2.2 Reposition Coorabie and district with government, as an important gateway to the Nullarbor

With the very successful Year of the Outback, areas such as the Coorabie district have been given extra exposure. Coorabie and Districts Progress Association should capitalise on this and lobby government agencies for funding, particularly in the tourism sector. Opportunities exist especially for areas such as the Great Australian Bight and the Nullarbor Plain.

Key strategies for this objective are:

- Coorabie and Districts Progress Association to lobby the South Australian Tourism Commission for support
- Coorable and Districts Progress Association to inform relevant government departments about the proximity and potential of Coorable, Nundroo and Fowlers Bay
- Coorabie and Districts Progress Association to establish closer working relationship with regional authorities

2.3 Encourage additional industries for the district that will positively impact on the population

With a declining number of farms in the area, pastoral opportunities are diminishing. A benefit of reduced farming is additional land for sale to investors.

There is some interest in developing viticulture and aquaculture in the area, however to date little progress has been made. It would be also be advantageous to examine options for increasing primary production through alternative crops and specific aquaculture produce.

Innovative approaches to land division may also enable establishment of retirement and hobby farms.

The recent establishment of the Kooringabie Hall as a craft and internet access site, perfectly located on the main highway offers an avenue for local products to be sold.

- Investigate the suitability of viticulture within the district
- Encourage expansion of the cottage industry
- Investigate options for aquaculture industry development
- Investigate hobby farming opportunities that may positively impact on population





Goal 3 Improve community and social services to the district

With a small and scattered population, providers find it difficult to service the needs of the residents. Sporting clubs have folded, retail outlets have closed and as a result work opportunities have declined.

A number of properties are owned by persons who do not live within the district and therefore do not contribute to its permanent population and are not particularly interested in community life.

3.1 Enhance standard of education and opportunities for the district

The school closed in December 2001 and students have to travel over 70kms to attend Penong School, 3 days a week.

For adults access to TAFE courses would provide personal development training and offer additional skills to obtain alternative work, although it is difficult for people to travel to Ceduna.

Career guidance for young people is not available. The lack of educational choices has meant many youth have left the district to pursue further education and career opportunities.

- The community must identify its education needs
- Provide information and lobby the relevant education providers to eliminate the gaps





3.2 Improve health, social and recreational services

Medical services to the area are limited. Residents currently have access to telephone consultation with the doctor at Ceduna and pharmaceutical supplies can be couriered from Ceduna. However couriering medical supplies to the district is expensive and there is no regular service.

A number of residents in the district are middle aged or elderly and more and more families are wanting to retire to the town. Currently there are no aged care services. In addition a number of families have young children and there is a two-week waiting period to access medical services in Ceduna.

Due to a declining population, sporting teams and clubs have folded. Any activities of this nature are conducted at Penong, with residents once again having to schedule their time to commute, which can also be an expensive exercise.

There appears to be no organised approach to improving recreational choices or social activities and therefore very few social activities occur in the district. On the social calendar there are only two events per year, which include New Years Day Sports Day and the Annual Golf Day.

As a result of the school closing, a bus is provided to transport children to and from Penong. In the case of an emergency, services must come from Penong or Yalata, which has meant that many patients are reliant on their neighbours to drive them halfway to meet these services. Unfortunately very few residents are trained in first aid.

Access to counselling services, especially in the area of stress management, lifestyle change, budgeting, unemployment and family therapy are not readily available and the lack of subsidy to travel to these services makes it out of reach for many of the residents.

- Identify the health and emergency services gaps and make representation to relevant agencies
- Identify recreational and social needs of the community and examine funding opportunities to achieve recreation objectives
- Investigate the opportunity to operate the school bus privately for community needs
- Organise social gatherings
- Identify youth needs and make representation of community to relevant agencies
- Investigate aged care/retirement services for an ageing population



3.3 Foster a united Coorabie district spirit

Due to the residents being scattered over a vast area, the only form of communication is the school newsletter. If a resident does not have a school age child, then they do not receive the newsletter and as a consequence are not aware of activities within the district. With the closure of the school, the newsletter will now be produced in Penong.

The community needs to encourage resident interaction between youth, the aged, farmers, working residents and non-resident landowners, to ensure a successful future.

To gain support from government organisations, the district must present a united front to official bodies to assist in obtaining funding to undertake improvements. District residents have not always supported community meetings where issues are discussed. Initiatives must be explored which encourage residents to attend meetings so they can voice their opinion and become involved in discussion.

Key strategies for this objective are:

- Encourage community participation in implementing the Community Plan
- Develop a district communication tool
- Develop a major event
- Investigate opportunities to work with other towns to generate services to the area

3.4 Improve transportation services

There is no airstrip within the district and no rail access, however a Greyhound bus service travels through the area on the Perth to Adelaide route. Residents who do not own a vehicle, therefore do not have access to any form of transport.

Increasing fuel prices have meant residents often do not travel to access much needed services or to attend functions in Penong.

- Identify the extent of service required
- Link into regional transport study



Goal 4 Protect and maintain the natural environment

The district has a most unique and spectacular coastal environment. The residents pride themselves on a litter free community and are pro-actively involved in programs such as "Trees for Life", a weed control program, drum musters, recycling using facilities at Ceduna and have a Soil Board.

The majority of residents make their livelihood from the land and are very respectful of the environment and native animals. One area of concern is the increasing number of wombats and kangaroos that cause damage to crops.

4.1 Protect the pristine environment

With an increase in tourist visitation to the area there is an increasing risk of damage to the environment. Many visitors are novice 4WD motorists who do not appreciate or respect the coastal strip and can pose a danger to other people and the environment.

Very little signage exists to tell visitors about water restrictions, fire hazards, marine pollution, disposal of litter and flora and fauna protection.

- Identify native flora and fauna for protection
- Investigate with National Parks culling program for wombats and kangaroos
- Educate residents about culling process for wombats and kangaroos
- Establish a native animal rescue shelter
- Develop signage about the environment
- Formulate an education campaign for visitors to the area



4.2 Maintain waste management and district cleanliness

The Coorabie and Districts Progress Association currently manage the resident's waste, utilising three sites. Increasingly this management role is becoming more demanding and environmental protection regulations more prevalent.

The community could become more proactive in waste management by encouraging greening programs, revegetation schemes and recycling. A permanent water supply would assist the continuation of the revegetation program.

- Encourage a Greening Plan for the district
- Encourage recycling, dump site management and district cleanliness
- Develop an education campaign about waste management within the district

- Working Towns Northern Regional Development Board
- Family and Community Services Commonwealth
- Regional Infrastructure Fund Department of Industry and Trade funds via Northern Regional Development Board
- Foundation for Rural and Regional Renewal
- Community Benefit SA
- Adult Community Education, Regional Development Department of Education, Training and Employment

It is important that a close working relationship be established with funding providers.

To ensure Coorabie and districts continues to grow and provide a pleasurable lifestyle for its residents, it is imperative that the community further investigates alternative industries and ways of capitalising on the tourism industry.

The Coorabie and Districts Progress Association must endeavour to attract assistance to improve infrastructure and services for the community and to ensure it meets the objectives of the Community Plan.

This Plan should be updated on a regular basis and strategies modified as implementation occurs.

Information in this Plan will be incorporated as part of a whole of "Outback" Plan for the Outback Areas Community Development Trust.
