am delighted to introduce this 2008 Report and data update for our Federation.

The EFTBA is now in its fourteenth year, and I have the honour of being its Chairman for the next three years. I have a number of priorities for my Chairmanship, and this report and data update is one of the most important. We need to promote European thoroughbred breeding more widely, not just amongst our own racing and breeding audiences, but also amongst the wider media and, of course, in the European institutions.

European laws impact more and more upon our businesses. EFTBA's workload in the area of political lobbying in Brussels is increasing year on

year. Over the past twelve months we have been in meetings with European policy makers up to the highest levels, including two European Commissioners. We have been working for breeders throughout Europe on crucial issues ranging from VAT, to farm payment subsidies, sports betting legislation, transport, veterinary issues and more.

We also continue to serve as an important focal point for breeders' associations to come together to discuss issues and to formulate common policies.

I would like to thank the previous Chairman Dr Franco Castelfranchi, who has led the organisation for the past three years, and who is staying on as Vice Chairman, together with Bo Helander as our new Second Vice Chairman. I would also like to thank Alec Head, our outgoing Honorary President, who has been with us since EFTBA's inception, and welcome Her Highness Princess Zahra Aga Khan as our new Honorary President. Thanks should also be given to Rolf Leisten, Bernard Ferrand and Charles Henri de Moussac for their work as Vice Chairmen of the EFTBA over the past years.

EFTBA, the European Federation of Thoroughbred Breeders Associations, was set up in 1994 to enable European breeders' associations to be represented at a European level with a strong single voice. EFTBA represents the majority of European Thoroughbred breeding countries.

#### Our aims are


- to provide a single focus for breeders associations to come together to discuss and formulate common policies
- to lobby at a European level on issues which affect European breeders
- to promote the Thoroughbred breeding industry at a European level including better access to EC funding schemes

## Some of EFTBA's main areas of activity include

- Education of Thoroughbred breeders
- Exchange of new information regarding legislation, veterinary research, international and domestic regulations, publication of new research data, etc
- Equine health. Veterinary routines and checks. EU veterinary border inspection procedures
- Codes of Practice the agreed veterinary procedures when presenting a Thoroughbred mare for breeding
- To work towards the standardisation of veterinary laboratories (for equine tests) throughout Europe
- Expansion of the international market for European Thoroughbred horses



# 2007 Report



## Report from the EFTBA Annual General Meeting, May 2008

The fourteenth Annual General Meeting of the European Federation of Thoroughbred Breeders' Associations was held at Longchamp Racecourse, Paris. Twenty five delegates from thirteen countries attended, including new member Russia.

#### Outgoing Chairman's address

The outgoing Chairman, Dr Franco Castelfranchi, in his final Chairman's address underlined the importance of the horse sector as part of the agricultural sector. He stressed the important role EFTBA has to play as the only European Federation in the thoroughbred racing and breeding sector, and as such, the responsibility it has in explaining and promoting not just breeding but the sport of racing to European institutions.

Dr Castelfranchi also underlined the importance of the EFTBA support which was given to the efforts made by French horse organisations in relation to their PMU and the inquiry by the European Commission into the PMU's monopoly status. Thoroughbred breeding and racing depends on betting revenues, and Dr Castelfranchi stressed that it cannot be accepted that third parties make money out of horseracing without contributing to the future existence of that sport.

EFTBA members unanimously approved the following appointments for a three year term

#### Incoming Chairman's address

Mr Joe Hernon underlined the importance of the EFTBA in supporting thoroughbred breeders throughout Europe. His main priorities for his Chairmanship would be in strengthening the Veterinary Committee and its work, stepping up lobbying at a European level, and ensuring EFTBA promotes this work to a wider audience.

He stressed his determination to work for the good of all European breeding countries, regardless of their size, and his overall aim of growing and strengthening the Federation itself.

## Political Report 2007-8

## The agricultural activity of horse breeding

In November 2007 EFTBA representatives met with Mrs Mariann Fischer Boel, the Agriculture Commissioner. Horse breeding is strongly linked to the land, and is considered by the Agriculture DG to be an agricultural activity. The meeting talked about raising the profile of thoroughbred breeding in Europe both as an important farm diversification activity, and an ideal sector in which to safeguard Europe's permanent pastures and rural employment.

EFTBA representatives were pleased to receive such a positive reaction from the Commissioner and her officials who recognised the huge advantages of horse breeding as a rural activity, from its labour intensive, year round employment needs, to its international market. In addition it uses extensive grazing methods using little or no chemicals, and supports a biodiverse environment.

EFTBA representatives have also subsequently met with senior Agriculture DG officials to talk about the importance of taking into account the hundreds of thousands of hectares throughout Europe used by horse breeding when looking at future changes to the Common Agricultural Policy in the move away from direct payments for production towards a more land-management oriented approach.

## European Commission VAT investigation

In 2007 the European Commission announced an inquiry into EU countries which applied a reduced VAT rate to horse sales and any associated products (from riding school and livery fees to prizes). Their principal reasoning is that horses are not normally intended for the generation or production of foodstuffs (only a limited list of supplies can apply reduced VAT). Of the countries concerned (Netherlands, Austria, Czech Republic, France, Germany, Italy, Luxembourg and Ireland) Italy has already amended its legislation from 1 January 2008 to apply full VAT, and the Netherlands government have announced their decision to do so.

EFTBA is strongly against this decision. Horse breeding and the selling of horses is a labour intensive activity, and while many breeders are registered farmers, the fact remains that they cannot sell horses under the flat rate VAT scheme for farmers, as our sector does not operate in the same way as the farm livestock sector, and horses are sold to owners or agents who are obviously not registered as farmers.

EFTBA remains convinced that the French government's decision a few years ago to lower the VAT rate on equestrian activities in order to stimulate the rural economy is a positive and proactive policy change which we believe should be welcomed by European policymakers who should be encouraging countries who apply full VAT to horses to consider similar changes to their legislation.

As soon as the enquiries were announced the EFTBA sent a delegation to the European Commission to see the officials who were heading the investigation, to underline the importance of horse breeding for the European rural economy and rural land use, and to point out how damaging full VAT rates would be for horse breeders in these countries.

## Funding of horseracing, and EU policy on sports betting

The political arena in 2007 was dominated by increased political activity in relation to horserace betting. The catalyst for this was the announcement by the Commission on the free movement of sports betting services in several countries including France.

This is of huge significance for thoroughbred breeders, who depend on a healthy racing industry in order for them to continue to sell their youngstock.

The response by horseracing authorities was significant as it is the first time they have mobilised at a European political level. EFTBA was instrumental in providing support in terms of European media links, participation and knowledge of the EU institutions.

A Common Declaration of European Horseracing Organisations was presented at the European Parliament in March 2008, and was strongly welcomed by many Members of the European Parliament:

'We call on the European Parliament, the Council and the Commission, to recognize urgently the need for a clear and coherent legal and regulatory framework, guaranteeing:

- 1. A fair return from betting to the racing on which it is promoted or offered;
- 2. The protection of the future integrity of the sport.

We call on the European Commission to develop a policy to achieve this, in consultation with the European horseracing organizations. It is necessary that, in conformity with the principle of subsidiarity, Member States have a European legal framework on betting, which will allow them to exercise their own competence in conformity with EU law'

## Animal welfare in Transport Regulation review

Discussions have begun between the European Commission and the governments of the EU member states for the 2009 review of this Regulation. The EFTBA has sent an initial response, and will be seeking to have coordination with other equine bodies such as the FEI, and EU horse racing authorities.

EFTBA will be underlining the importance of retaining the important derogations which were obtained in the 2005 Regulation in relation to the travelling of registered horses, while at the same time supporting horse welfare organisations in their aim of improving the standards for horses destined for slaughter.

#### Stud Books

In a report to the 2008 AGM in May, Dr Devolz informed members that the Serbian stud book has been approved. Bosnia and Herzegovena will be incorporated into the Serbian book in future. The Lithuanian book may also be approved and this book will have its first two foals in 2008.

Ukraine and Kirgistan are also keen to establish a thoroughbred studbook. Outside Europe, Syria is to have a book, and Oman shortly. The Pakistan book is moving forward and the American Bahamas also.

#### Country initiatives

Turkey is to be congratulated on its positive action of a huge testing programme for Equine infectious anaemia to clean the country. It will test on Elisa and confirm on Coggins. The horses testing positive on the Coggins test will be destroyed and compensated.

The Thoroughbred Breeders' Association of Great Britain held a seminar on exotic diseases in Newmarket in June 2008 in order to raise awareness by European breeders and veterinarians of these diseases and to discuss action which can be taken.

In October 2007 the French TBA organised an informal meeting in Deauville, France, on the Equine European sanitary situation and ideas to harmonise rulings between countries.

Veterinary representatives from almost a dozen countries attended this excellent initiative. The two main conclusions were are follows:

- that there should be a common aim to improve communications regarding health problems between countries
- a continuing priority should be the drive towards the harmonisation of testing methods across Europe.

#### CEM

Dr Hanspeter Meier, the EFTBA B&C country veterinary representative also raised at the AGM the problem of CEM throughout Europe and the extra costs this imposes on thoroughbred breeders, as well as being a continued export problem.

It was agreed that education is needed on how to take swabs and how they are transported to the lab, and not necessarily in thoroughbred areas, as thoroughbreds are tested much more than the non-thoroughbred population despite the fact that nowadays there are also a huge number of sports horses moving between countries for breeding purposes

#### Further EFTBA Action for 2008-09

At a European level the EFTBA remain convinced that there is need for urgent action in two main areas:

- A risk analysis for exotic diseases in order to have a contingency plan in case of an outbreak. The main problem will be the lack of movement for thoroughbreds particularly during the breeding season.
- Industry waste: evacuation of manure, and disposal of carcasses remains a problem in some European countries.

EFTBA also regard it of prime importance to continue to support and develop initiatives to spread best practice amongst breeders themselves and their veterinarians in relation to health status and disease control, particularly regarding the smaller and developing countries and their access to the latest veterinary advice and research.

#### European successes

European bred horses continued to dominate the international thoroughbred horseracing scene in 2007.


Over half of all the horses in the International Federation of Horseracing Authorities World Thoroughbred Racehorse Rankings Northern Hemisphere were bred in Europe, including the top two horses.



The number one racehorse was Manduro, German bred and trained by André Fabre in France by top German sire Monsun. Authorised took the runner up spot – Irish bred and trained in Britain by Peter Chapple Hyam.








## Number of mares used for breeding 2007

## Comparison of mare numbers 1999, 2003 and 2007













# Percentage of Thoroughbred mare population according to type in Ireland GB and Germany


















French bred horses continue to enjoy success throughout the world -notable wins include

Doctor Dino (FR) winner of the 2007 Hong Kong Vase, and Darjina (FR) winning the Dubai Duty Free in 2007. Literato (FR), Lawman (FR), Mandesha (FR) Geordieland (FR) Irish Wells (FR) and Passager (FR) were all outstanding GR1 winners throughout 2007. In 2008 Mauralakana (FR) and Spirit One (FR) both won at GR1 level in the USA, and French bred Group 1 success continued elsewhere with Vision d'Etat (FR) winner of the Jockey Club and Goldikova Prix Rothschild and Prix du Moulin de Longchamp, Manchand d'Or (FR) with the July Cup and Monmartre Grand Prix de Paris, and Belle et Celebre (FR) the Prix Saint Alary.

#### **GERMANY**



The German-bred and owned Manduro marked a new dimension for German breeding when ending the year 2007 as the world's leading racehorse. He proved to have reached his utmost height of maturity at five that year.

The classically bred and arguably best son of the German sire sensation Monsun opened up with a easy victory in the Group III Earl of Sefton Stakes before notching up his much deserved first Group I victory in the Prix d'Ispahan.

He subsequently landed the Prince of Wales's Stakes and the Prix Jacques le Marois at this level and the Group II Prix Foy for his final outing. During his entire career, Manduro raced 18 times from two to five winning ten races including eight Pattern events with a winning distance of a mile to twelve furlongs as well as

placing in all his other starts. His other Group victories came in the Preis des Winterfavoriten as a juvenile, the Preis der Deutschen Einheit at three as well as the Prix d'Harcourt at four.

Manduro was bred from the Listed placed Be My Guest mare Mandellicht and is a close relative to the German 2000 Guineas victor Mandelbaum who shares the German Triple Crown winner Konigsstuhl as a sire with Monsun with this being the family of the Epsom Oaks heroine Ginevra.

GB had no less than 24 successful Group 1 winners in 07/08 including African Rose, Bordelescott, Champs Elysees, Grand Couturier, Lush Lashes, Saddex.....and not only in the Northern Hemisphere; British bred horses enjoy success throughout the globe - just one example is Viva Pataca (GB) who claimed success in the Hong Kong Cup, Hong Kong Gold Cup and Dubai Sheema Classic in 2007/8
