**Financial Aid Application for the Summer 2009 Term**

**WHO IS ELIGIBLE**

If you are currently enrolled in a degree granting or eligible certificate program at Georgetown and will be registered for at least three credits at Georgetown during the summer term you may be eligible to receive financial aid from the programs listed below. If you enroll in a summer program away from Georgetown you may be eligible for any of the aid below *except* GU Scholarship. If you do *not* plan to enroll in summer school but you will be a degree candidate at Georgetown in the Fall 2009 semester the only aid you may be eligible to receive is Federal Work-Study.

**WHAT IS AVAILABLE**

Due to limited funding Georgetown is not able to meet full financial need for students who enroll during the summer term. Most applicants are able to borrow to meet certified summer school costs through our loan programs.

**APPLICATION REQUIREMENTS**

**Undergraduates applying for GU Scholarship:** Submit this application and you must have filed both the 2008-09 CSS Profile form and the 2008-09 Free Application for Federal Student Aid (FAFSA). *Priority will be given to applicants who received Georgetown Scholarship during the 2008-09 academic year whose Dean has certified that summer school attendance is required to graduate on time. Due to limited funding, Graduate and Liberal Studies students are not eligible for GU Scholarship awards for the summer term.*

**Undergraduates applying for Federal financial aid only, Graduate and Liberal Studies Students:** If you will be in summer school you must submit this application and you must file (or have already filed) the 2008-09 Free Application for Federal Student Aid (FAFSA). Students who will *not* be in summer school may be eligible for Federal Work-Study *only*; these applicants must file the 2009-10 FAFSA.

**All Applicants:** If you are applying *only* for a Federal PLUS Loan or a private loan, submit this Georgetown Summer Term Financial Aid Application only.

**Application Deadlines:** In awarding GU Scholarship funds priority will be given to students who submit a complete application by April 1, 2009. Summer aid decisions will be communicated to applicants beginning May 1, 2009 and will continue on a rolling basis as applications are received. Applicants who have not already completed a 2008-09 Free Application for Federal Student Aid (FAFSA) must do so by June 30, 2009.
