#### Registration

- 1. The 2010 Skoda Breakaway Series forms part of the Tour Down Under (TDU) and is owned and administered by Events South Australia (ESA), a trading name of South Australian Tourism Commission (SATC).
- 2. The 2010 Skoda Breakaway Series comprises two bicycle events, namely, the Mutual Community Challenge Tour (MCCT) and the Mini Tour for Kids (collectively referred in this form as "the Event").
- 3. Registration places for the Event are limited and close at 5.00pm on Friday 8 January 2010 unless sold out beforehand.
- 4. ESA reserves the right, in its absolute discretion, to accept or decline an application from any participant.
- 5. No registrations will be accepted after 5.00pm 8 January 2010 or on Event day.
- 6. All prices are quoted in AUD per person and are inclusive of Goods and Services Tax (GST).

# **General Conditions**

- 7. ESA and the Event Manager reserve the right to refuse entry by any person into the Event.
- 8. ESA and the Event Manager reserve the right to remove any persons from the Event where they consider it necessary to do so, for health and safety or other reasons.
- 9. ESA and the Event Manager strongly recommend all participants take out travel insurance and private health cover to cover any unforseen circumstances that may arise.

- 15. Participants wanting to change their ride distance must contact the South Australian Visitor and Travel Centre prior to COB Friday 8 January 2010. Participants who change their distance after this date or on Event day cannot be guaranteed their jersey will be at the correct start location.
- 16. Only human powered bicycles are permitted to enter the ride. Motorcycles, scooters and motorised and power assisted bicycles are not permitted.
- 17. Child seats, tagalongs, tandem and hand powered bicycles are permitted.
- 18. Participants sharing a bicycle, such as a tandem, must register each rider individually.
- 19. Participants are responsible for ensuring they are capable of riding the Event distance. It is the responsibility of the participant to prepare mentally and physically for the Event.
- 20. Full payment is required to confirm your Skoda Breakaway Series registration.
- 21. All cancellations received prior to 5.00pm on Monday 30 November 2009 will be entitled to a full refund of monies paid and will not be entitled to receive the official Event jersey.

- 30. The decision to cancel or modify the Event and the Event cancellation process will be in line with the Breakaway Series Heat/extreme weather policy guidelines. A copy of this policy will be posted on the Tour Down Under website from 1 December 2009.







- 31. Without limiting the foregoing, Events South Australia and the Event Manager is not responsible for third party suppliers of services such as hotels, restaurants, or transportation companies.
- 32. The TDU is staged under a rolling road closure, meaning any vehicle on the road during this Event MUST give way and move off the road until clear. If a Mutual Community Challenge Tour rider is still on the route when the Tour Down Under race peloton arrives at that point, they will be required to move off the road until ALL professional riders and Event vehicles have safely passed by. At times during the stage this may take up to 20 minutes.
- 33. When participating in the Event participant understand that if they arrive at the finish location after the arrival of the Tour Parade (time subject to change on the day) then it may not be logistically possible to ride through the arch and a detour will be in place.
- 34. Rider support vehicles are not permitted on the ride. The Event Manager will provide support vehicles including SAG wagons, medical support and mechanical support.
- 35. All information in this form is correct at time of printing but may be subject to change.

# **Event Management**

- 2. The Event is managed by an external Event Manager (herein known as the Event Manager) on behalf of Events South Australia.

#### Registrations

- 3. ESA will manage all registrations for Coach Transfers.
- 4. Applications for registration for the Coach Transfers close at 5.00pm on Friday, 8 January 2010 and must be submitted via the Tour Down Under website at www.tourdownunder.com.au.
- 5. Full payment of the registration fee for the Coach Transfers is required by Friday, 8 January 2010 to confirm registration and participation in the Coach Transfer.
- 6. People are also required to provide a valid email address at the time of registration.
