Research

1. Short-term (completion by end 2007)

1.1 The Comparative Method

A systematic and concise introduction to comparison in the social sciences (Sage, "Quantitative Applications in the Social Sciences"). The monograph provides basic guidelines for comparative research by addressing all key methodological issues: case selection, comparability, taxonomical treatment, and research design. The principles of comparative control are dealt with by stressing the logical foundations of comparative research: the role of classification, Mill's methods, necessary/sufficient causes, and Boolean algebra.

1.2 European Regions: 1870–2005

A comparative reference handbook and CD-ROM in the series "The Societies of Europe": (1) presentation through text, tables, synopses of the development of political-administrative regional structures in Western, Central, and Eastern Europe; (2) a complete set of digitalised and machine-readable maps since 1870 for all European countries documenting border changes and changes in the internal organisation of administrative/political territorial units. The map files can be used by GIS systems for thematic mapping and analysis.

1.3 Comparative Politics Textbooks

Comparative Politics: Forthcoming Oxford University Press textbook (2007) assembling a group of renowned scholars. Chapters are thematic and cover industrial and developing countries. The book takes into account international factors and public policies. The goals are: introduce the main theories and methods; cover all core substantive areas, drawing from wide range of countries; produce a coherent volume with self-contained chapters; produce an accessible text of high intellectual quality; familiarise students with the current debates.

Companion website: The volume is accompanied by a website on which users can access: (1) 50 country profiles (information on state formation, institutions, party systems, electoral

system, latest elections results, etc.), (2) data in electronic format for 220 countries with more than 200 economic, demographic, labour, gender, environmental and cultural indicators are available in SPSS, SAS, Excel and Stata, (3) learning devices such as PowerPoint presentations for each chapters, exercises, questions and answers, extra tables and figures.

2. Long-term (from 2007 onwards)

2.1 Comparative Politics Textbooks (continued)

Comparative Politics Theories: Proposal for a second volume on theories of comparative politics in preparation: (1) constitutionalism (2) economic theory (3) sociological origins (4) elitism and pluralism (5) macro-historical analysis (6) systems theory (7) structural-functionalism (8) behaviourism (9) rational choice (10) institutionalism. As for Comparative Politics the volume assembles renowned international scholars. It can be used in advanced seminars either in conjunction with Comparative Politics or independently.

2.2 The European Electorate

This project analyses the integration of European electorates and party systems, and the formation of a supra-national cleavage constellation in the European Union. It is an empirical electoral research on the "Europeanisation" of electorates, and the extent to which national party systems converge and integrate. The project is based on three types of data: (1) aggregate data, (2) survey data and (3) party manifestos. This allows to analyse several dimensions of "electoral integration":

- The ideological integration among parties of the same family (socialists, Christian democrats, liberals, etc.) in Europe.
- The homogeneity of voting behaviour and common changes taking place simultaneously across Europe (as "waves" of uniform swings of votes).
- The location of sources for political-electoral behaviour: local, national or EU level.
- The degree of distinctiveness of the EU party system with respect to national party systems and their alignments.

The research covers (1) the 27 current member-states of the EU, (2) Iceland, Norway, Switzerland, over the period since 1945, but focuses particularly on the period since the first direct election to the European Parliament in 1979. The research project is available on request. The project is financed (100,000 CHF) by the National Centre of Competence in Research (NCCR: Challenges to Democracy in the 21st Century) of the Swiss National Science Foundation.

This research will lead to the following publications:

- 2. Research monograph: *The Integration of Electorates and Party Systems in the European Union: A Comparison of National and European Elections, 1975–2009.* To be submitted to Rowman and Littlefield (Governance in Europe Series).
- 3. A ESF "Exploratory Workshop".

Collaboration is planned with (members of) EUI, MZES (Mannheim), LSE and Arena (Oslo). It involves research, publication, grant applications and organisation of conferences.

2.3 The Nationalisation of Central and East European Countries

An ECPR workshop organised in 2008 in Rennes with Ingrid van Biezen will analyse processes of nationalisation since 1989 in Central and East European countries (including Russia, Bulgaria and Romania) after the break-down of communism. Papers will include country case studies with two introductory chapters: one analysing common trends in Central and Eastern Europe and the other comparing these trends with Western Europe. The papers will lead to an edited volume to be submitted to ECPR/Routledge European Politics series.

2.4 Elections in Europe

Update of handbook and CD-ROM *Elections in Western Europe since 1815* (Palgrave, 2000). It includes West, Central and East European countries, as well as elections to the EP. The project also aims to produce an *electoral atlas* with colour maps. for all European countries since the beginning of competitive elections. Electoral data are combined with a number of socio-economic indicators. The work is supplemented with CD-ROMs with data in different formats and GIS-assisted dynamic cartography. Publication in five volumes:

Volume I: Western Europe

Volume II: Central and Eastern Europe

Volume III: European Elections

Volume IV: Historical Electoral Atlas of Europe (with dynamic GIS cartography)

2.5 Stein Rokkan and Rational Choice

Organisation in collaboration with the "European Politics" group at POLSIS of meeting with the view of publishing a monographic issue of a theoretical review (possibly, *Journal of Theoretical Politics*) on elements of rational choice in historical political sociology, starting from the work of Stein Rokkan. The meeting will also address the question of the use of rational choice theory in projects involving large datasets. The aim is to bridge two important theoretical approaches – one of which is dominant in US and the other in Europe.
