# **Clubs Matter**

## Coaches registration process is off and running!

Thank you for all the support we have received in implementing the new coaches registration process. Here are some additional clarifications regarding the procedures:

- ✓ Coaches who teach in sanctioned activities and clubsponsored activities **DO** need to register. This includes test sessions, all competitions, performances, off-ice activities and private lessons on club ice regardless of whether they are employees or independent contractors.
- ✓ All coaches under the age of 18 (minors) and instructors who teach <u>ONLY</u> Basic Skills group classes do not need to register at this time.
- ✓ Registration fee is \$40 plus the cost of purchasing coaches liability insurance.
- Registration should be completed online, but we do have a paper system is available if necessary. Paper registrations will take more time to process.

- ✓ Coaches will be mailed a new registration card to show at check-in desks for events. Please request and verify proof of registration upon check-in at sanctioned events.
- ✓ Coaches who are not registered **by the start** of regionals this year will not be allowed to stand at the gate with their students. Prior to regionals, please ask for proof of registration and remind coaches of the new process. Qualifying coaches should be registered **no later than Aug. 15** to make the dead-line.

## Getting Your Board on Board

Do you have a junior member liaison position on your board? Read below for some helpful information from the *Blue Avocado e-newsletter*.

Can minors serve on boards?

The answer is , it depends. But when it is possible, the rewards usually outweigh most of the concerns. A few states do not allow young people to serve on boards, and many states have laws prohibiting minors to sign binding contracts. Before inviting young people to serve on your board, verify whether your state has an age limit for board members. Even if your state law prohibits minors from serving as full members of the board, there are many ways to benefit from the ideas and perspectives that young people bring. You can ask them to serve as nonvoting members of the board, to become members on an advisory council or to chair a committee or a special event.

If you decide to invite a minor to serve as a board member, keep these points in mind:

- $\checkmark$  Provide adequate orientation or assign a board mentor
- ✓ Avoid electing minors as officers in charge of financial matters
- ✓ When the law prohibits it, do not allow minors to sign binding contracts for the organization
- ✓ Provide D&O (directors and officers) insurance for the entire board, but be aware that standard, off-the-shelf policies may exclude minors




