### LYNCH APPROVAL RATINGS SLIP SLIGHTLY, JOBS AND ECONOMY TOP CONCERN



DURHAM, NH – Governor John Lynch job approval ratings in New Hampshire have dropped somewhat in recent months as economic concerns, and concerns about the state budget are the top problems on the minds of New Hampshire residents.

These findings are based on the latest **WMUR Granite State Poll**,<sup>\*</sup> conducted by the University of New Hampshire Survey Center. Five hundred (500) randomly selected New Hampshire adults were interviewed by telephone between January 27 and February 3, 2010. The margin of sampling error for the survey is +/- 4.4 percent. Included was a subsample of 444 likely 2010 general election voters (margin of sampling error +/-4.7%).

#### **Gubernatorial Approval**


Governor John Lynch continues to receive high marks for the job he has done as governor, even though that support has declined in the past year. In the most recent Granite State Poll, 60% of NH adults say they approve of the way he is handling his job as governor, 26% disapprove, and 14% are neutral or don't know. Lynch's job approval ratings had been declining largely because of the economic downturn and the impact that has had on the State's budget. However, Lynch has the approval of Democrats (74% approve) and Independents (68%) approve. However, Lynch's support among Republicans is slipping heading toward the election in November, currently 42% of Republicans approve of the job he is doing as governor, down from 50% in October.








Lynch's personal favorability rating remain high as well. In the latest Granite State Poll, 63% of New Hampshire adults say they have a favorable opinion of Lynch, 19% have an unfavorable opinion, 9% are neutral, and 9% say they don't know enough about him to say. Lynch's net favorability rating, the percentage having a favorable opinion minus the percentage having an unfavorable opinion, has risen to +44%, up from +38% in June. Even a plurality of Republicans (47%) have a favorable opinion of Lynch.




2010 NH Gubernatorial Race - John Stephen vs. John Lynch - Likely Voters

Lynch has faced easy reelection challenges in 2006 and 2008, and is attempting to become the first New Hampshire governor to win a fourth term. Currently, the Republicans who have declared their candidacy are largely unknown to voters and potential candidates are largely unknown as well. Former Health and Human Services Commissioner John Stephen is thought to be considering challenging Lynch, though he must raise his visibility significantly. In the most recent Granite State Poll, 14% of New Hampshire adults have a favorable opinion of him, 10% have an unfavorable opinion of him, 6% are neutral, and 70% don't know enough about him to say. Stephen's net favorability stands at +4%. Businessman Jack Kimball is running but is largely unknown – only 2% have a favorable opinion of him, 2% have an unfavorable opinion, and 96% are either neutral or don't know enough about him to say.






In a hypothetical matchup between John Lynch and John Stephen, 50% of likely 2010 voters say would vote Lynch, 30% would vote for Stephen, 1% would choose some other candidate, and 19% are undecided. It is important to point out that only 9% of likely voters say they definitely decided who they would vote for, 6% are leaning towards someone but may still change their mind, and 85% are still trying to decide.

### Most Important Problem Facing New Hampshire


New Hampshire residents are increasingly concerned the state's economy as unemployment remains high in the state. In the latest Granite State Poll, 48% of New Hampshire adults view the economy and jobs as the most important issue facing the state, up from 36% in October. Other top problems are the state budget (14%), high taxes (9%), education funding (6%), the quality of education provided (4%). Despite the controversy over health care reform in Washington, only 4% name health care as the most important problem facing the state.




### **Right Direction or Wrong Track?**

Although economic and budget problems persist, New Hampshire residents increasingly believe the state is headed in the right direction. Currently, 61% of New Hampshire adults feel the state is heading in the right direction, 31% think the state is seriously off on the wrong track, and 8% don't know.

Democrats, liberals, and upper income residents are most likely to think New Hampshire is headed in the right direction while Republicans and conservatives are most likely to say things are off on the wrong track.






**Condition of New Hampshire Roads** 

Budget shortfalls have meant that New Hampshire has had to put the brakes on a number of important road construction and repair projects, but most people in the state think overall, most roads and bridges are in OK condition -13% think they are in very good condition, 68% think they are in OK condition, 18% think they are in poor condition, and 1% are unsure. Residents of the Central and Western parts of the state are most likely to think that roads and bridges are in poor condition.

Currently, Interstate 93 is being widened between Manchester and the Massachusetts border, but this project is facing a stoppage due to a lack of revenues. Granite Staters were asked if they favored or opposed several options to raise funds to complete this project, but none are palatable to a majority of state residents. When asked if they favored or opposed raising tolls on New Hampshire's turnpikes to fund the I-93 project, 39% favored this option, 42% oppose, and 20% are unsure or say it depends on the amount. Putting tolls on I-93 near the Massachusetts border is even less popular with 33% saying they favor this option, 49% oppose, and 18% are unsure or say it depends. The least popular option is an increase in the gasoline tax – only 23% favor raise gas taxes, 66% oppose, and 12% are unsure or say it depends on the amount.



# Favor / Oppose Revenue Options for I-93 Project

#### **Granite State Poll Methodology**

These findings are based on the latest **WMUR Granite State Poll**,<sup>\*</sup> conducted by the University of New Hampshire Survey Center. Five hundred (500) randomly selected New Hampshire adults were interviewed by telephone between January 27 and February 3, 2010. The margin of sampling error for the survey is +/-4.4 percent. Included was a subsample of 444 likely 2010 general election voters (margin of sampling error +/-4.7%).

The data have been weighted to adjust for numbers of adults and telephone lines within households, respondent sex, and region of the state. In addition to potential sampling error, all surveys have other potential sources of non-sampling error including question order effects, question wording effects, and non-response.
