#### - National Assembly passes Electoral Bill

The two chambers of the National Assembly, at separate sessions, passed the Electoral Bill 2006, on the 31 of May 2006, which set campaign-spending limit for a presidential candidate at N500million.

The bill entitled: "A Bill for an Act to Regulate the Conduct of Elections in Federal, State and Local Governments, and the Registration of Voters and Matters Connected therewith, 2006 (Harmonized)", it also empowers the Independent National Electoral Commission (INEC) to fix the dates, and order of 2007 general elections.

The new Electoral Act prohibits the use of Electronic Voting Machine (EVM) "for the time being" and provided for an open ballot system at the elections. **ThisDay**, Thursday, June 01, 2006 page 1/4

## Obasanjo signs Electoral Act

The President has signed the Electoral Act, 2006 says the Special Adviser on National Assembly matters, Senator Florence Ita Giwa. The new law which would provide the platform for next year's elections limits election expenses of parties and candidates, ban the use of electronic voting machines, allows the Independent National Electoral Commission (INEC) a free hand to set dates and sequence of elections and provides sterner penalties for poll offences.

Ita Giwa statement came barely 24 hours after the House of Representatives had threatened to over-ride Obasanjo's veto should he refused to sign the harmonized bill passed by the two chambers sixteen days earlier. Daily Trust, Friday, June 16, 2006 pg1/2

#### - INEC seeks separate security agency for polls

The Independent National Electoral Commission (INEC) has made a proposal to the Legislative and Executives, requesting for a separate security agency during the 2007 polls this means that the Police and other conventional security agencies may play a minimal role in the conduct of the 2007 general elections. The INEC Chairman Prof. Iwu presented this request to the House of Representatives Speaker Alhaji Aminu Bello Masari.

However, Inspite of criticism by stakeholders of the election timetable, INEC insist that it is acting within the law says INEC's Director of Public Affairs, Mr. Segun Adeogun.

Reacting to the Movement 2007 Lawmakers who opposed the timing of April 7 to 28 2007, INEC says "we are still with the law and we know what we are doing". #### - INEC May Emboss Photos on Ballot Papers

A unique innovation may be introduced into the 2007 electoral process as the Independent National electoral Commission (INEC) is planning to emboss the photographs political parties candidates on ballot papers in a bid to check electoral malpractices. Unlike ballot papers used in the 1999 and 2003 elections that only bore the names and logos of the political parties without the names of the candidates. This INEC said would prevent the reoccurrence of the Anambra State's scenario where those who contested the 2003 senatorial election on the platform of the People Democratic Party (PDP) had their names replaced and their victory giving to other members of the party who were not fielded in the election.

Should this idea sail through; it will be difficult for any political party to change the list of candidates that emerge from their primaries once their names have been submitted to INEC. It will also become compulsory for political parties to have their primaries well on time to enable INEC order printing of ballot papers, which will have the photographs of their candidates, embossed on them. This will enable electorates to vote know and vote the candidates and not just the parties.

Meanwhile, in a later development, new Electoral Commissioners have been sworn in by the Chairman of INEC Prof. Maurice Iwu on Tuesday, June 13, 2006 to represent the various states of the Federation. # - I'm ready to lay down my life for 2007 polls- iwu tells party leaders

INEC Chairman, Maurice has reassured Nigerians of free and fair elections in 2007 even if it involves laying down his life to ensure electoral credibility. Iwu stated this on Wednesday, June 7 at Abuja during a meeting with representatives of the 37 political parties against the backdrop of threat to his life.

He raised alarm that there had been threats on his life from some quarters owing to his commitment to ensure credibility in the forthcoming general elections. He told party chieftains that the present INEC has zero tolerance for political violence as the newly passed electoral bill has empowered it to prosecute culprits. He reinstated that INEC has dropped the idea of using electronic voting machine (EVM), in 2007 elections but said the electronics voting system which involves tamper proof voters cards would be provided as well as rapid transmission of election results.

In a later development, the chairman of the Independent National Electoral Commission, Prof. Maurice Iwu, on Monday, June 12, defended the commission's timetable for the 2007 general elections.

He said despite criticisms against the timetable, the general elections would hold in April as scheduled. He said there was nothing wrong with the fixed dates for the elections as the constitution stipulated that the poll should hold not more than 60 days and not less

# - Fear grips INEC as FG sacks 13 Commissioners

Fear has gripped the leadership as well as top management cadre of the Independent National Electoral Commission (INEC), following the gale of sack that has swept off thirteen of its Resident Electoral Commissioners (REC), across the federation for some untoward practices during the 2003 general elections.

The sack of the thirteen commissioners was communicated to the National Chairman of INEC Prof. Maurice Iwu via a letter from the office of the Secretary to the Government of the Federation, Chief Uffot Ekaette.

The commissioners involved are those of Ekiti State, FCT, Niger Sate, Ebonyi State, Jigawa State, Kebbi State, Kwara State, Katsina State, Plateau State, Osun State, Zamfara State, Kaduna State and Nasarawa State. The Federal Government has picked replacements.

The Citizen's Popular Party (CPP), has condemned President Obasanjo's dismissal of the 13 Residential Electoral Commissioner (REC) over their implication in the brazen manipulation of the 2003 polls in favor of the incumbent executives and top politicians in the county.

Wumi Bewaji has said the declaration by Prof. Maurice Iwu that the Economic and Financial Crimes Commission (EFCC) and some security agencies would screen candidates is a demonstration of his ignorance of the provision of the new Electoral Act.

Faulting the INEC Chairman, Hon Bewaji said under the new Act, only the High Court of a state can disqualify a candidate whose name has been submitted to the commission by his political party. # - Lawmakers want presidential, governorship polls last

Senators and members of the House of Representatives yesterday asked the Independent National Electoral Commission (INEC) to sequence next years elections in a way that presidential and governorship elections would e held last.

The reasons the lawmakers gave was that if polls for the two executive offices are held first, then the result would be a bandwagon effect "which led to the collapse of the second republic".

#### - AREWA Youth jettisoned quest for a Northern Presidency

Northern youths have called on their elders to jettison the quest for a northern president for 2007 election. They said instead the people should support a candidate from the South-south. The youths have endorsed the Governor of Akwa Ibom State Victor Attah as their choice for Presidency come 2007 and urged the North to support Attah, noting that he has the qualities required to step into Obasanjo's shoes.

Similarly, the leadership of the Christian Association of Nigeria (CAN) in the 19 Northern States decried the clamor for rotational presidency on the ground that it violates the provisions of the 1999 Constitution.

A group the Forum of Northern Muslim Clerics has expressed support for the south-south geo-political zone in its quest to produce the nation's president in 2007. As another group the South-East Youth Coalition (SEYOC) called on security agents to investigate the statement credited to the Arewa Consultative Forum (ACF) National Secretary, Col Hammed Ali (rtd) over the ongoing debate on the zone to produce the next president.

# **Zimbabwe Accuses west of Encouraging Coup**

Zimbabwe's ruling party has accused an international organization of encouraging a military coup against President Robert Mugabe, and vowed to crush any effort to topple the government. The ZANU-PF Information Chief Nathan Shamuyarira said the International Crisis Group (ICG) which last week issued a report saying Zimbabwe was fast becoming a failed state was a font for Mugabe's western critics including Britain and the US.

The Brussels-based ICG, which said it is an independent non-governmental organization, denied all the allegations.

#### 1. PRESIDENTIAL CANDIDATE TO EMERGE LATEST DEC. 8

Going by the April 8 date of the general election announced by the Independent National Electoral Commission (INEC), all registered political parties will have up to December 8

to submit to the commission the list of their sponsored candidates. This is in accordance to Section 32 (1) of the Electoral Act 2006 of the National Assembly.

The section states thus: "every political party shall not later than 120 days before the date appointed for a general election submit its list of candidates to the commission". This is in contrast with the repealed Electoral Act of 2002, which gave political parties the mandate of 60 days before the date, appointed for election to submit their list of candidates.
