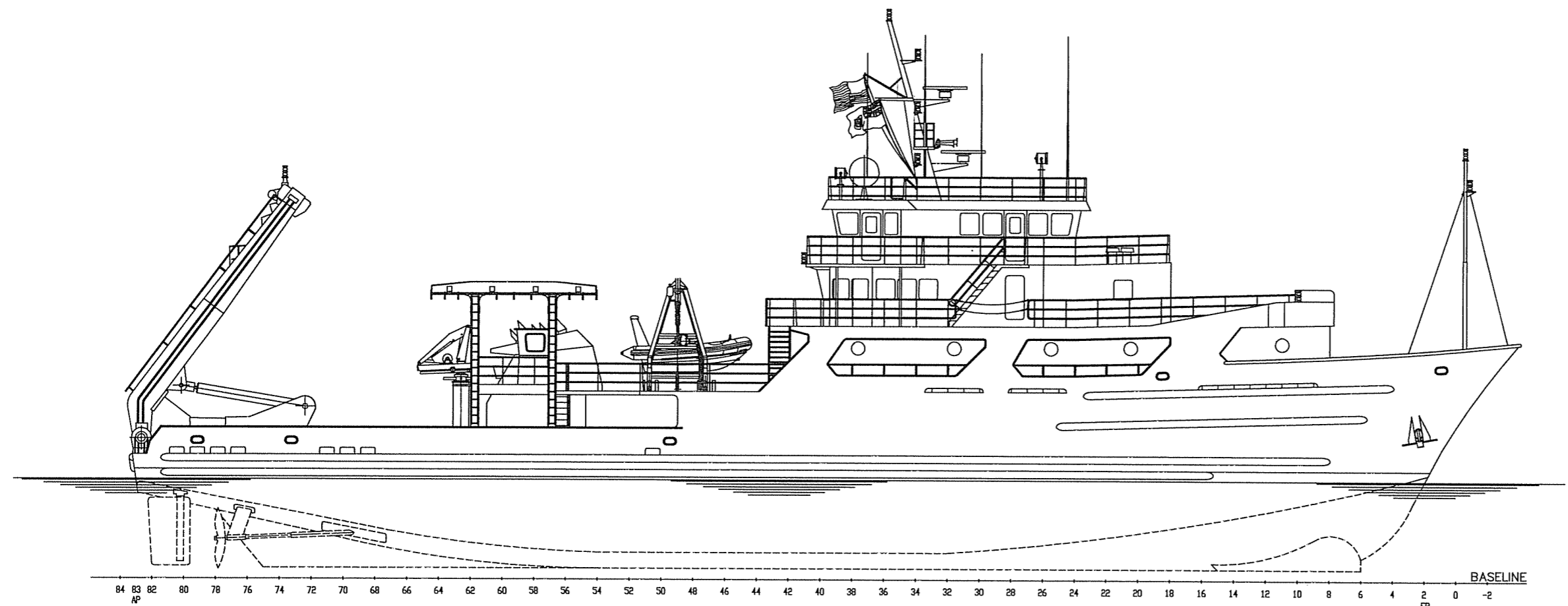

GENERAL NOTES

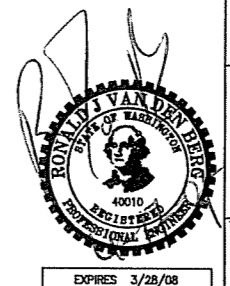
- ALL DESIGN, FABRICATION AND WELDING PROCESSES SHALL BE IN ACCORDANCE WITH THE LATEST ABS RULES FOR BUILDING AND CLASSING STEEL VESSELS AND USCG REQUIREMENTS PER 46 CFR.
- ALL PLATE AND SHAPE MATERIAL SHALL BE STEEL, ABS GRADE A OR EQUIVALENT. ALL PIPE SHALL BE SEAMLESS, STEEL, ASTM A53, OR EQUAL.
- NEW SUPPORT STRUCTURE SHALL BE FIELD FITTED TO ALIGN WITH EXISTING SHIP STRUCTURE.
- VERIFY DIMENSIONS PRIOR TO FABRICATION AND INSTALLATION.
- STANDARD STRUCTURAL DETAILS TO BE DEFINED BY SHIPYARD.
- OUTFIT AND MISC. DETAILS TO BE DETERMINED & CONFIRMED BY SHIPYARD AND OWNER.

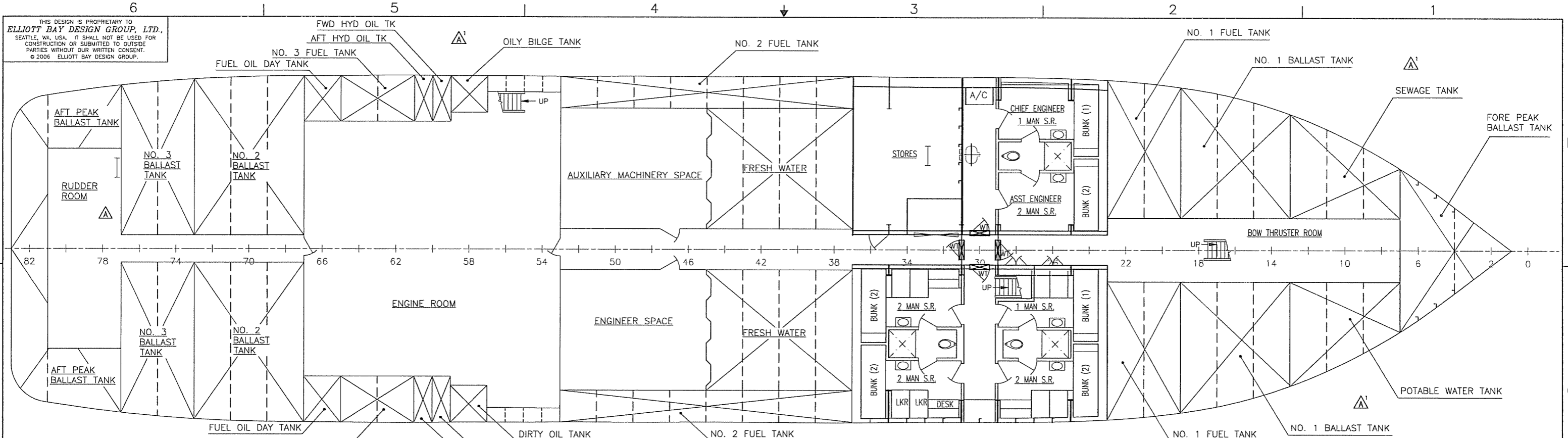

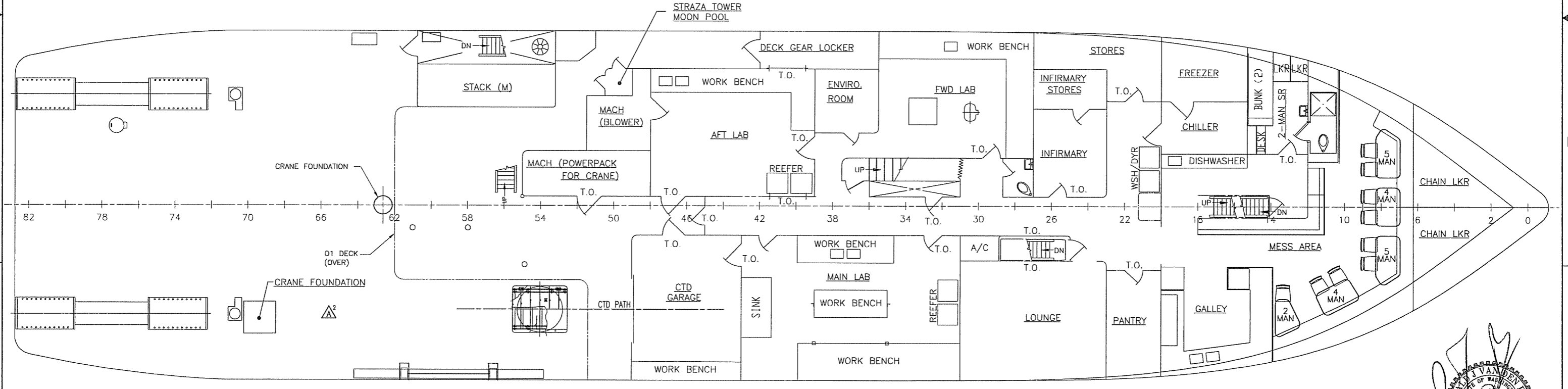

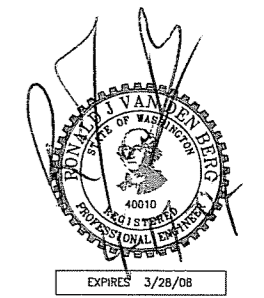


PLAN 2-3C

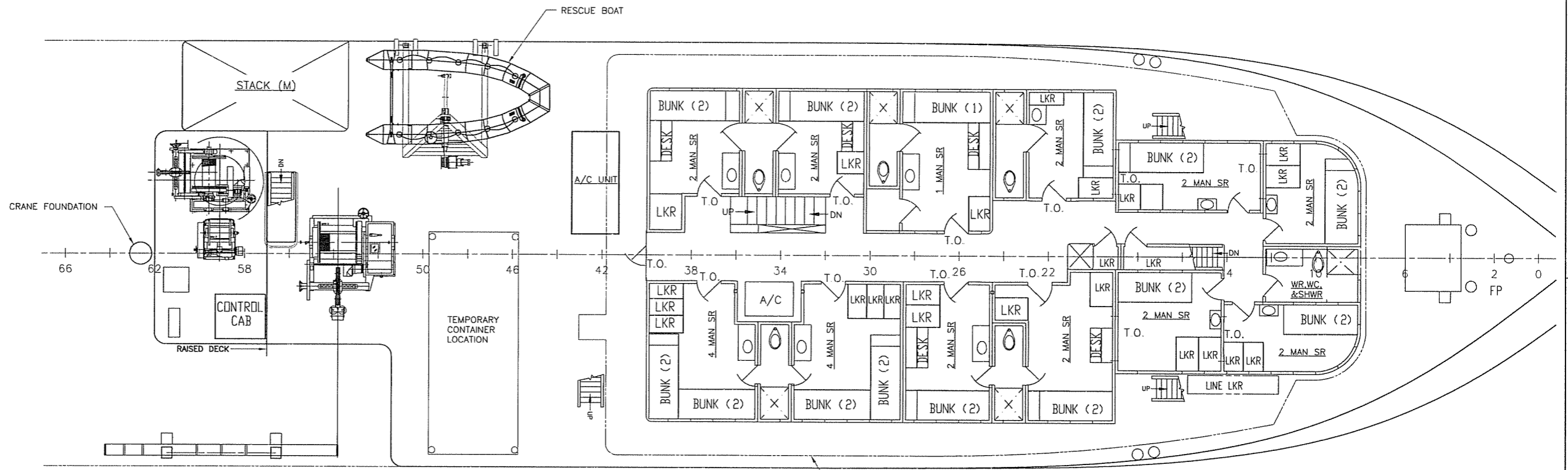

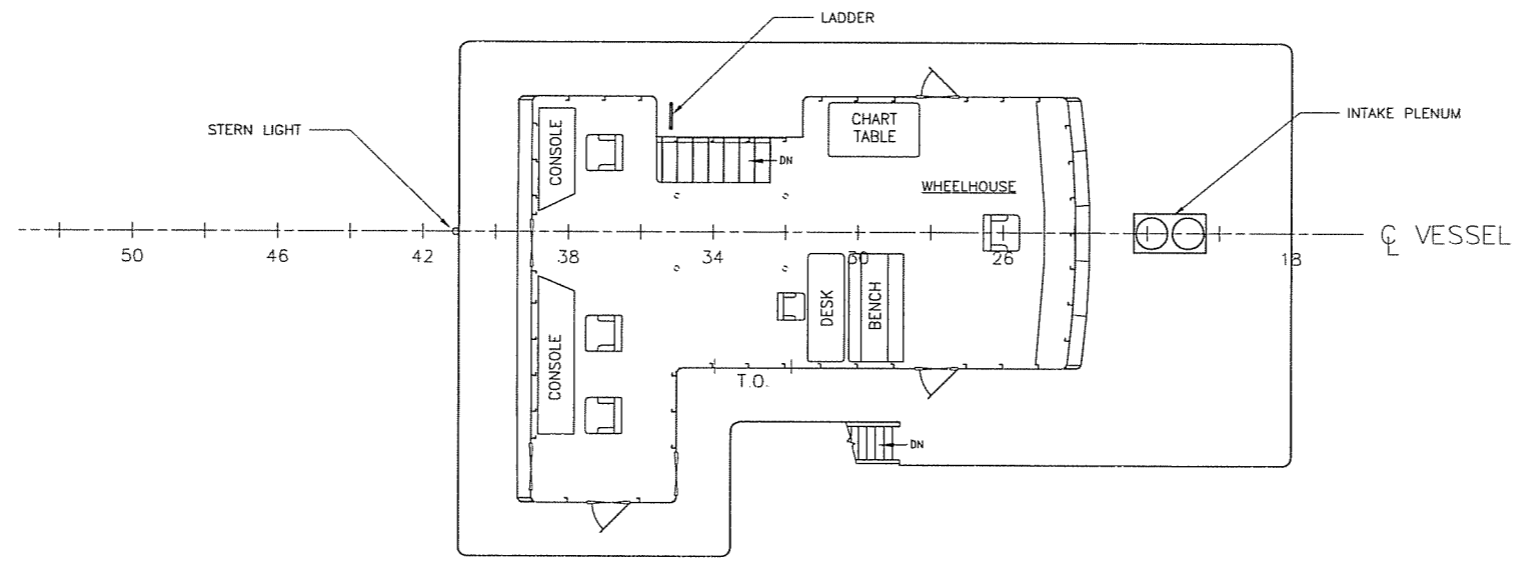

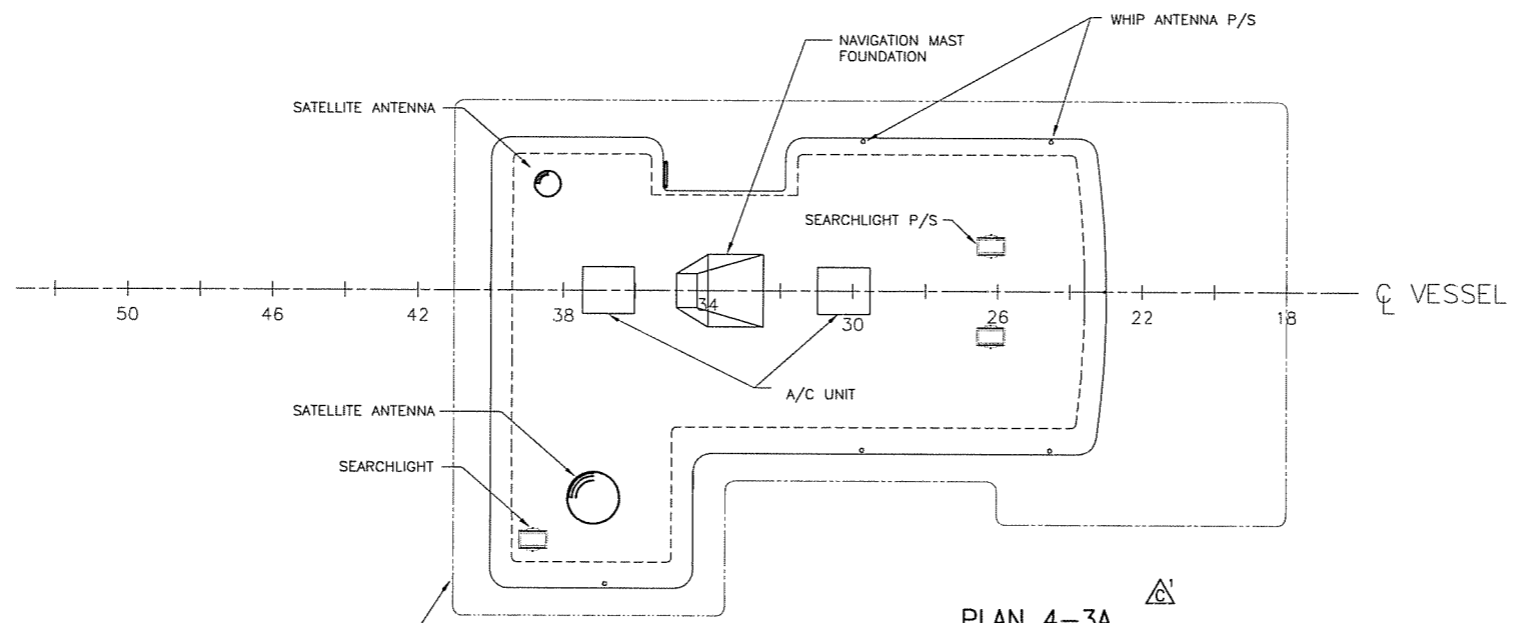

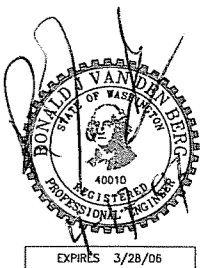


PLAN 4-3C
