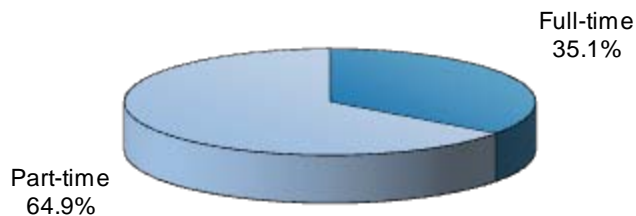
FULL-TIME/PART-TIME
