Capt. Henry Pease, Consular Papers Collection, 1867-1893

Historical Note:

Whaling master Captain Henry Pease, Jr., (1822-1892) son of Henry and Mary Fisher Pease was born in Edgartown. In 1851 he married Phebe Ann Smith (1828-1900) who accompanied him from 1854-1862 aboard the whaler *Cambria* from New Bedford. During the Civil War Captain Pease was appointed on December 4, 1863 as acting Ensign in the U.S. Navy, serving on *Galena* and *St. Louis* in the West Gulf. On January 9,1865 he was appointed acting master of *Mary Sanford* and *Geranium* in the South Atlantic. He was appointed U.S. Consul to Santiago, Cape Verde in 1882 until 1892. In the pictorial "The Whaling Captains of Edgartown," there is a photograph of Captain Pease. This pictorial is housed in the MVM.

Scope and Content Note:

The collection consists of papers and letters relating to his work as Consul, with a few personal letters and papers including a letter from his younger brother, Benjamin (1834-), addressed to their father. Ben Pease became a pirate, and joined "Bully" Hayes, America's last famous buccaneer, raiding in Micronesia until both were murdered, according to MVM records. A small notebook documents the California Gold Rush expenses of Charles Wesley Pease in 1851.
