Setting Up Your Business - Checklists

New Food Business Checklist

The following questions will help you in the main things you need when setting up a food business.

- Have you developed a coherent business plan?
- Have you REALLY done your market research competition analysis, industry trends, target customer research (do you know who you are selling to and will they want it?)
- Do you NEED food premises at this stage (Have you thought about outsourcing to avoid fixed costs? Or, are you sure that you will have orders to afford premises?)
- Have you registered your premises?
- Have you considered health and safety and fire safety arrangements?
- Have you made arrangements for the new European HACCP directive that came into force on 1st January 2006
- Do you and your staff understand the principles of good food hygiene?
- Have you and your staff had food hygiene training?
- Have you considered what food safety problems there could be at each stage of your business?
- Do you need to register for VAT ?
- Do you describe food and drink exactly?
- Do you need to apply for a license to trade your products?

Registration of the company

- Choose the type of company that best suits your requirements:
 - a) Setting up as a sole trader or partnership
 Have you ring-fenced your personal assets against business failure?
 Do you have a partnership agreement?
 - b) Forming a limited company

Chef's Specials

Technical requirements and regulations

All owners and managers of a food business are responsible for ensuring that their businesses comply with the law. There are five key laws that all food businesses in Great Britain must be aware of and follow:

 - a) What I have to register?

Any premise used for a food business (including market stalls, delivery vehicles and other moveable structures.)

b) Who needs to register?

Anyone running a food business for more than 5 days in any 5 consecutive weeks, you must tell to the local authority about any premises you use for storing, selling, distributing or preparing food. Food premises includes restaurants, hotels, cafes, shops, supermarkets, staff canteens, kitchens in offices, warehouses, guest houses, delivery vehicles etc.

c) How do I register?

By filling a registration form at your local authority area. For more information please contact your Local Authority. If you are planning to start a new food business, you need to register with your local environmental health department 28 days before opening. If you change the activity at your food premises, you must tell your local environmental health department within 28 days of the change.

d) Some premises are exempt from registration

The greater part of premises should be registered. However, certain premises are exempt from registration. You should contact your local authority if you think you might be exempt.

- · Food Labelling and the Marking of Food
 - a) The name of the food;
 - b) A list of ingredients;
 - c) The appropriate durability indication;
 - d) Any special storage conditions or conditions of use;

And in certain circumstances:

- e) The name or business name and an address or registered office of either or both of the manufacturer or packer, or a seller established within the European Community;
- f) Particulars of the place of origin or provenance of the food if failure to give such particulars might mislead a purchaser to a material degree as to the true origin or provenance of the food;
- g) Instructions for use if it would be difficult to make appropriate use of the food in the absence of such instructions
- h) Declaration of Additives (Additives used as ingredient to perform functions in pre-packed foods must be declared on the label) There are certain exemptions and additional requirements listed in the main regulations.

There are less onerous rules for foods which are non-pre-packed or pre-packed for direct sale. These Regulations also attach conditions to the use of claims for foods for particular nutritional uses, reduced or low energy value claims, protein claims, vitamin or mineral claims, cholesterol claims, other nutrient claims and claims dependent on other foods; they prohibit medicinal claims. They also lay down a prescribed format for the nutritional labeling of foodstuffs.
