WORK IN PROGRESS

Books

A Companion to Philosophy of Religion, with Charles Taliaferro, Second Edition (Blackwell Publishers). The first edition was edited by Taliaferro and Philip L. Quinn. This new edition makes major changes to the first edition, including 25 new essays. In addition to co-editing the book, I contribute an introduction (co-authored with Taliaferro) and a chapter ("Probabilistic Arguments for Theism").

The Evidential Problem of Evil. In this book-length monograph, I distinguish "modus tollens arguments from evil" from "Bayesian arguments from evil," critically discuss some of the most important contemporary arguments of each type, develop a new Bayesian argument from evil, and then respond to various challenges to my argument, including challenges based on theodicies, skeptical theism, natural theology, and Reformed epistemology.

Papers

"A New Theory of Intrinsic Probability." This paper defends a new theory of intrinsic probability, in part by showing its advantages over Richard Swinburne's theory.

"Why Theists Bear a Heavy Burden of Proof." This paper applies my new theory of intrinsic probability to theism, arguing that the intrinsic probability of God's existence is very low and hence that those who recommend belief in God to non-theists bear a heavy burden of proof.

"Evolution and the Problem of Induction." This paper will show that knowing that our cognitive faculties were produced by evolution creates a "problem of induction" much more serious than Hume's, at least for the metaphysical naturalist. A solution to this problem based on my new theory of intrinsic probability will be proposed.
