When special freight train service on the New England Central Railroad, Inc. has been arranged by the operating department upon request of shippers or consignees, or as deemed necessary by the railroad, the rate will be.....

(Per Mile, Minimum 110 Miles)

1. The charge for the special service will be in addition to the regular freight charges which are provided for in freight tariffs or private contracts or quotes governing the movement of freight handled in regular freight trains.
2. Special freight train service will only be arranged upon reasonable advance notice to the NECR and when motive power and crews are available; and in the opinion of the officers of the NECR, the service can be performed without detriment to its other services.

CHARGES FOR MOVING LOCOMOTIVES

The charge for moving a locomotive over the New England Central Railroad will be \$9.00 per mile (minimum 75 miles).

- Conditions:
1. NECR to assume NO liability while moving locomotives.
 2. Subject to inspection/approval by NECR Mechanical Dept. prior to movement.
 3. Subject to NECR fuel surcharge
 4. Rate is contingent on locomotive moving in regular NECR train service with no restrictions.

ITEM 280

CLOSING CAR DOORS

When cars are released by the customer, all doors and hatches must be closed and cars cleaned of any dunnage. Failure to comply with this will result in the car not being pulled and demurrage assessed until such time as the car is ready to move.

CARS ORDERED AND NOT USED

If an empty car of private ownership arrives at destination and either available for placement and constructive placement, actual placement is performed and the car is subsequently released without being loaded, the charge will be.....

CARS RELEASED EMPTY, WHEN ACTUALLY LOADED

If a car is released empty and found to be loaded, the customer will be billed the freight rate, determined by the manager of pricing, in returning the car.
