ACCESS TO INFORMATION

The Right to Free Access to Information

Under the provisions of the Law on Free Access to Information of Public Importance (Official Gazette of RS, No. 120/04, 54/07), information held by public authority bodies created during work or related to the work of the public authority body, are available to everyone with the purpose of the fulfillment and protection of the public interest to know and attain a free democratic order and an open society.

The National Assembly of the Republic of Serbia holds numerous information stemming from its authority (proposals and adopted constitution texts; proposals and adopted texts of constitutional laws, laws, spatial plans and other documents; amendments to the Constitution, constitutional laws and laws; declarations, resolutions, recommendations, decisions, authentic interpretations; minutes of National Assembly sessions and sittings of all standing and temporary working bodies; electoral material; citizens' petitions and proposals; conclusions, rulebooks, orders, instructions, reports, certificates and documentation created in the work of the National Assembly Support Service).

The National Assembly:

- adopts and amends the Constitution;
- decides on changes concerning the borders of the Republic of Serbia;
- · calls for the Republic referendum;
- ratifies international contracts when the obligation of their ratification is stipulated by the Law:
- decides on war and peace and declares state of war or emergency;
- supervises the work of security services:
- enacts laws and other general acts within the competence of the Republic of Serbia;
- gives prior consent to the Statute of the autonomous province:
- adopts defense strategy;
- adopts development plan and spatial plan;
- adopts the budget and financial statement of the Republic of Serbia, at the Government's proposal;
- grants amnesty for criminal offenses.

Within its election rights, the National Assembly:

- elects the Government, supervises its work and decides on expiry of term of office of the Government and ministers;
- appoints and dismisses Constitutional Court judges;
- appoints the president of the Supreme Court of Cassation, court presidents, Republic Public Prosecutor, public prosecutors, judges and deputy public prosecutors in line with the Constitution;
- appoints and dismisses the Governor of the National Bank of Serbia and supervises his/her work;
- appoints and dismisses other officials stipulated by the Law.

The National Assembly also performs other functions stipulated by the Constitution and Law.

The right to access to information of public importance can be limited if it is necessary for the protection of a preponderant interest based on the Constitution or the law.

The National Assembly shall **not** allow the applicant to exercise the right to access information of public importance, if it would thereby:

- expose to risk the life, health, safety or another vital interest of a person;
- imperil, obstruct or impede the prevention or detection of criminal offense, indictment for criminal offense, pretrial proceedings, trial, execution of a sentence or enforcement of punishment, any other legal proceeding, or unbiased treatment and a fair trial;
- make available information or a document qualified by regulations or an official document based on the law, to be kept as a state, official, business or other secret, i.e. if such a document is accessible only to a specific group of persons and its disclosure could seriously legally or otherwise prejudice the interests that are protected by the law and outweigh the access to information interest;
- violate the right to privacy, right to reputation or any other right of a person that is the subject of information, except if the person has agreed, if it is a person, phenomenon or event of public interest, especially a holder of a state or political post, and if the information is relevant to the duties that person is performing, or if a person has given rise to a request for information about him/her by his/her behaviour, especially regarding his/her private life.

If the National Assembly refuses to partially or fully inform the applicant whether it holds the requested information, allow insight into the document containing the requested information, issue, or send a copy of the document, it is obligated to issue a decision on the rejection of the request and give a written explanation, notifying the applicant of the legal means at his/her disposal to appeal such a decision.

The applicant may lodge a complaint against the National Assembly's decision to reject the request. An administrative dispute complaint may be lodged pursuant to the law, on which the court notifies the Commissioner.

The purpose of publishing the **NATIONAL ASSEMBLY INFORMER** is to inform the public on the documents and information the National Assembly holds within its jurisdiction.

The **INFORMER** contains data relevant to the content, volume and manner in which interested persons can exercise their right to access to information of public importance.

The **INFORMER** is published in an electronic form which enables an easy search through the document, copying of parts of the text and taking over the whole document or its parts.

Nebojsa Pavlovic and Aleksandra Saso are the **AUTHORISED PERSONS** for processing requests for free access to information and in charge of updating the **INFORMER**.

On 28 September 2009, on the occasion of the International Right to Know Day, the National Assembly of the Republic of Serbia received an award for its contribution to the affirmation of the right to free access to information of public importance and transparency.

The data in the **INFORMER** was last updated on January 31st, 2010.

SUBMITTING A REQUEST FOR ACCESS TO INFORMATION

A request to exercise the right to access to information can be submitted:

An oral request to exercise the right to access to information is stated for the record at the National Assembly's Clerk's Office, 14 Kralja Milana Street, office 3, and such a request is entered into special records.

If the authorised person is requested information on, insight into or copy of a document by telephone, the authorised person may consider such a request an oral request for access to information but is not obligated to do so, of which he/she shall inform the requester.

A Request for access to information must contain:

- the name of the body to which the request is submitted;
- data important for location of the requested information;
- first name, surname and address of the requester (for physical entities);
- name and seat of the requester (for legal entities).

The submitter of the request is not obligated to state the reasons for requesting access to information, and in the request may also propose the manner in which the National Assembly shall make said information accessible.

Most frequently asked questions: names submitted by parties as future deputies, beginning of the session and constitution of the National Assembly, deputy groups' seating arrangements, manner of providing simultaneous translation for members of ethnic minority parties at the National Assembly, deputies' income from regular wages, wage supplement, reimbursement of travel expenses and per diem for foreign business travels, the time the deputies spend in the assembly chamber and minutes spent at the rostrum, reports on the property of political parties and how it is handled.

A large number of inquiries requested copies of bills and texts of amendments, political parties' reports on their property, minutes and shorthand notes of certain sessions of the National Assembly and the Assembly of Serbia and Montenegro.

All the requests were processed and adopted, except in one case when the applicant submitted an imprecise request which he failed to amend even after being orally informed that the request must be specified. No complaints had been lodged under article 22 paragraph 2 of the Law in any of the cases.

In dealing with requests for free access to information so far, the National Assembly did not exact a fee. Most requests required forwarding written information or copy of a short document at the National Assembly's disposal.

The National Assembly of the Republic of Serbia stores archive material generated in the National Assembly's work, from its foundation to date.

The archives contain the original documents of the National Assembly:

- Proposed and adopted texts of the Constitution;
- Proposed and adopted texts of constitutional laws, laws, spatial plans and other acts;
- Amendments to the Constitution, constitutional laws and laws;
- Declarations, resolutions, recommendations, decisions, authentic interpretations;
- Minutes of sittings of the National Assembly and all standing and temporary working bodies:
- Electoral material;
- Citizens' petitions and proposals;
- Conclusions, rulebooks, ordinances, instructions, reports, certificates and accounting documentation generated in the day-to-day work of the National Assembly Support Service.

In the process of passing laws, the bills and amendments are at the deputies' disposal at the Clerk's Office section with courier service and archives.

From January 2005 registry, recording and archiving of documentation at the National Assembly Clerk's Office is done by automatic data processing. The documentation in the National Assembly's possession is classified according to the List of categories of archive material with determined deadlines and is destroyed as worthless after the expiry of said deadlines.

Documentation of national, cultural and historical significance is stored permanently and processed according to archival rules for its protection and accessibility to the scientific, expert and general public.

The most common medium used for storing National Assembly documentation is paper. In addition to it, there are also electronic documents as well as shorthand and audio-magnetic records of all the National Assembly sittings and a large number of sittings of its standing and temporary bodies.

Data on the procedures undertaken by National Assembly of the Republic of Serbia under the Law on Free Access to Information of Public Importance in 2008 shall be published in the Informer after the Annual Report is submitted to the Commissioner for Information of Public Importance.

Most frequently asked questions: deputies' income from regular wages, per diem for attending the sittings of the National Assembly and its working bodies, wage supplement, travel expense fees and per diem for foreign business travels, the time the deputies spend in the assembly chamber and minutes spent at the rostrum, deputies' immunity, the National Assembly's use of budgetary funds, deputies' right to diplomatic passports. A large number of inquiries requested copies of bills and texts of amendments, minutes and shorthand notes of certain sessions of the National Assembly and its working bodies.

All the requests were processed and adopted, except in one case when the applicant requested a copy of a document not in the National Assembly's possession in which case the request was forwarded to the Commissioner and the requester was informed which state body is in possession of the requested document, and in one case administrative proceedings were initiated against the National Assembly, in line with the Law. In dealing with requests for free access to information so far, the National Assembly did not exact a fee. Most requests required forwarding written information or copy of a short document at the National Assembly's disposal.

By the end of 2008 the National Assembly had commenced the drafting of a new Informer on its work, which was published on the National Assembly's webpage on 14 January 2009. Also, the National Assembly has commenced preparations to construct a new National Assembly web presentation which should facilitate access to information and documents generated in the National Assembly's work.

Most frequently asked questions: deputies' income from regular wages, per diem for attending the sittings of the National Assembly and its working bodies (Note: On April 24, 2009, the Administrative Committee of the National Assembly adopted a Decision amending and modifying the Decision on Deputies' Fees, 28 No. 120-1105/09, abolishing the deputies' right to reimbursement of catering expenses - per diem), wage supplement and other fees; the time the deputies spend in the assembly chamber and minutes spent at the rostrum; deputies' immunity; the National Assembly's use of budgetary funds; National Assembly delegations' business travels, destinations and funds the National Assembly spent on the travels.

All the requests were processed and responded to within the legal deadline, and the requested information i.e. documents containing the requested information were duly forwarded - except in two cases rejected by the authorised person as unfounded under article 9 paragraph 1 item 5 of the Law, i.e. article 13, since too much information was requested.

In dealing with requests for free access to information in 2009, in two cases the National Assembly charged the expenses of copying ample documentation in line with regulations in force. Most requests required forwarding written information or copy of a short document at the National Assembly's disposal.

In 2009, the Commissioner for Information and Personal Data Protection received a complaint from Prijatelj-Epar Animal Rights Alliance from Subotica that the National Assembly had not processed this plaintiff's request. The authorised person forwarded the full documentation on the request that was duly processed within the legal deadline, to the Commissioner's Service.

The National Assembly is currently preparing a more modern and comprehensible web presentation that should significantly facilitate access to information and documents generated in or connected with the National Assembly's work.

MOST FREQUENTLY REQUESTED INFORMATION OF PUBLIC IMPORTANCE

Question: How high is the deputies' salary?

Answer: The deputies' net salary is 75,886.40 RSD.

Question: How high was the deputies' per diem for attending the sittings of the National Assembly and its working bodies in the first three months of 2009?

Answer: A deputy's daily wage for attending the sittings of the National Assembly and its working bodies, amounted to 2,209.00 RSD net for the month of January 2009, 2,459.00 RSD for the month of February 2009 and 1,908.00 RSD net for the month of March 2009.

Question: How high is the deputies' wage supplement?

Answer: A deputy's wage supplement is 30,354.00 RSD a month, which is 40% of a salary of a deputy employed full-time at the National Assembly.

Question: How do the deputies account for the expenses of coming to the sittings of the National Assembly and its working bodies by private car?

Answer: The National Assembly Support Service keeps official attendance records for the sittings of the National Assembly and its working bodies. Also, the deputies who come to the sittings of the National Assembly and its working bodies by private car, sign a statement confirming the use of their private car, stating the license plate, length of the drive, number of kilometers travelled and the date of the sitting of the National Assembly, i.e. its working body. Based on the official records kept by the National Assembly Support Service and the deputies' signed statements, the National Assembly Support Service – Financial and Material Affairs Sector fills a payment order for the appropriate reimbursement containing: the deputy's first and last name, grounds for reimbursement of expenses (sitting, working body) and the calculated expense reimbursement signed by the liquidator, treasurer and deputy being reimbursed.

Question: How many days total was the National Assembly in session in 2009?

Answer: Between January 1 and December 31, 2009, the National Assembly was in session for a total of **157** days, **107** days in regular session and **50** days in extraordinary session. Overall data on the National Assembly's activities in this period is available in chapter **INTRODUCTION – National Assembly Activities - January 1 - December 31, 2009.**

Question: How many laws and other documents did the National Assembly adopt in the period between January 1 and December 31, 2009?

Answer: In the period between January 1 and December 31, 2009 the National Assembly adopted **265 laws** and **65 decisions**.

Question: How much did an average working day of the National Assembly cost in 2008? **Answer**: An average working day of the National Assembly in 2008 cost up to 4,486,136.00 RSD, out of which, an average of 1,538,816.00 RSD a day was withdrawn from the National Assembly's pay office for the deputies' per diem and travel expenses for attending the sittings of the National Assembly and its working bodies.

Question: Is the Law on Smoking Ban in Close Premises being strictly enforced in the National Assembly offices?

Answer: In line with article 1 of the Law on Smoking Ban in Close Premises (Official Gazette of RS, No.16/1995 and 101/2005), the National Assembly Secretary adopted an Ordinance banning smoking in all rooms occupied by non-smokers. The text of the Ordinance is available on the National Assembly's website www.parlament.sr.gov.yu – Informer.

Question: On grounds of which regulation do the deputies have the right to a diplomatic passport, where have the deputies travelled in official visits in the current convocation and on what grounds?

Answer: In the current convocation, 128 deputies have exercised their right to a diplomatic passport under the Ordinance on persons issued a diplomatic and official/service passport, the manner of issuance and keeping records on diplomatic and official/service passports and visas issued (Official Gazette of Serbia and Montenegro, No. 37/2003).

In the current convocation the deputies have travelled as members of the National Assembly's standing delegations in international organisations, responding to invitations to study visits, seminars and expert conferences, to the following countries: Italy, Montenegro, Spain, France, Germany, Azerbaijan, Canada, Bulgaria, Malta, Belgium, United Kingdom, Poland, Bosnia and Herzegovina, Switzerland, Croatia, Monaco, Moldova, United States of America, Portugal, Russian Federation. The decision on a required foreign travel is made by the National Assembly Speaker based on a request and invitation letter from abroad submitted by the deputy at least seven days before the planned trip. The invitation letter submitted along with the request must contain the name of the event being held abroad, the period of the deputy's stay abroad and manner in which the travel expenses are covered. After a trip, the deputy is obliged to submit a written report on the official travel to the National Assembly Support Service – Financial and Material Affairs Sector to account for the expenses.

Please note that a diplomatic passport cannot be used without a valid visa issued by the Ministry of Foreign Affairs of the Republic of Serbia, at the request of the competent institution.

Question: How many deputies' questions were posed in 2009, and how many of them were answered?

Answer: In the period between January 1 and December 31, 2009 the deputies posed a total of **225** questions. Out of that number, 191 questions were answered, while 34 received no answer.

Note: Under article 235 of the Rules of Procedure, a deputy has the right to request information and/or explanations necessary for the discharge of his duty as deputy, from the National Assembly Speaker, the Chairman of a National Assembly Committee, ministers and dignitaries of other republican bodies and organisations on issues within these officials purview or within the purview of the body they are heading. In 2009, the deputies requested 461 pieces of information and explanations from the abovementioned officials. The National Assembly Speaker, National Assembly Committee Chairpersons, ministers and dignitaries of other republican bodies and organisations supplied 279 pieces of information and explanations.

Question: How high are the funds allocated for deputies' salaries, per diem payments, lump-sum payments and travel expenses in 2008?

Answer: The data on the funds allocated for deputies' salaries, per diem payments, lump-sum payments and travel expenses between January 1 and December 31, 2008 is given in Table 2 - Expenditure Structure for the Period January 1 – December 31, 2008 – Deputies, in chapter NATIONAL ASSEMBLY FINANCES.

Question: How much did the National Assembly spend on the deputies' per diem payments for attending and participating in the sittings of the National Assembly and its working bodies in the period from January 1 to June 1, 2009?

Answer: The deputies' per diem payments for attending and participating in the sittings of the National Assembly and its working bodies in the period from January 1 to June 1, 2009, cost the National Assembly:

- January 2009 5,989,301.00 RSD - February 2009 3,888,838.00 RSD - March 2009 6,618,344.00 RSD - April 2009 5,964,394.00 RSD - May 2009 213,554.00 RSD

Total: 22,674,431.00 RSD

Note: On April 24, 2009, the Administrative Committee of the National Assembly adopted a Decision amending and modifying the Decision on Deputies' Fees, 28 No. 120-1105/09, abolishing the deputies' right to reimbursement of catering expenses (per diem).

Question: How much did the National Assembly spend on the deputies' per diem payments for attending deputy group meetings in the period from January 1 to May 31 of this year? **Answer**: The deputies' per diem payments for attending deputy group meetings in the period from January 1 to May 31 of this year, cost the National Assembly:

- January 2009 325,185.00 RSD - February 2009 418,866.00 RSD - March 2009 507,139.00 RSD

Total: 1,251,190.00 RSD

Question: What is the amount of National Assembly expenses planned and incurred in the period between January 1 and September 30, 2009?

Answer: The National Assembly expenses planned for the period between January 1 and September 30, 2009, according to the 2009 Budget rebalance amounted to 1,568,606,000 RSD. The National Assembly expenses incurred in the abovementioned period amounted to 916,801,926 RSD, which is 58.45% of the National Assembly's expenses. More detailed data on the National Assembly expenses incurred in the period between January 1 and September 30, 2009 are available in chapter NATIONAL ASSEMBLY FINANCES.

Question: Questions concerning the immunity of deputies. **Answer**: The answer can be found in chapter **DEPUTIES**.

Question: Questions regarding the activities of the National Assembly Committees in 2009. **Answer**: In 2009, the National Assembly Committees held a total of 391 sittings. 16 committee sittings were held outside of the National Assembly seat in 2009. For the purpose of discussing certain issues within their purview, the Committee on Interethnic Relations and Committee on Relations with Serbs Living Outside Serbia created 5 subcommittees (the Committee on Interethnic Relations created 1 subcommittee while the Committee on Relations with Serbs Living Outside Serbia created 4 subcommittees). In 2009, the National Assembly Committees also created 10 task groups: Administrative Committee – 2; Finance Committee – 2; Committee on Health and the Family – 2; Environmental Protection Committee – 1; Legislative Committee – 1; Poverty Reduction Committee – 1; and Gender Equality Committee – 1. In 2009, the National Assembly Committees submitted 209 amendments to bills within their purview and adopted 293 general documents and document proposals: 179 decisions, 88 conclusions; 1 opinion; 24 decision proposals; and 1 recommendation. As part of their monitoring role, in 2009 the Committees considered 170 reports and pieces of information submitted by ministries and other state bodies, as well as held numerous roundtables in the function of public hearings.

NATIONAL ASSEMBLY - GENERAL INFORMATION

The National Assembly is the *supreme representative body and the holder of constitutional and legislative power* in the Republic of Serbia.

Competencies

As the holder of *constitutional* and *legislative* power, the National Assembly:

- · adopts and amends the Constitution;
- decides on changes concerning the borders of the Republic of Serbia;
- · calls for the Republic referendum;
- ratifies international contracts when the obligation of their ratification is stipulated by the Law:
- decides on war and peace and declares state of war or emergency;
- supervises the work of security services;
- enacts laws and other general acts within the competence of the Republic of Serbia;
- gives prior consent to the Statute of the autonomous province;
- adopts defense strategy;
- adopts development plan and spatial plan;
- adopts the budget and end-of-year balance of the Republic of Serbia, at the Government's proposal;
- grants amnesty for criminal offenses.

Within its *election* rights, the National Assembly:

- elects the Government;
- appoints and dismisses Constitutional Court judges:
- appoints and dismisses the president of the Supreme Court of Cassation, court presidents, Republic Public Prosecutor and public prosecutors:
- appoints and dismisses judges and deputy public prosecutors in line with the Constitution and the Law;
- appoints and dismisses the Governor of the National Bank of Serbia and the Governors' Council;
- appoints and dismisses the Civic Defender (Ombudsman);
- appoints and dismisses other officials stipulated by the Law.

Within its *control* function, the National Assembly supervises the work of:

- the Government and decides on expiry of term of office of the Government and ministers;
- security services;
- Governor of the National Bank of Serbia:
- Civic Defender (Ombudsman);
- other authorities and bodies as stipulated by the Law.

Within its representative function, the National Assembly i.e. the deputies:

- consider the citizens' petitions and proposals;
- hold meetings with the citizens at the National Assembly and National Assembly offices outside of the National Assembly seat.

Composition of the National Assembly

- The National Assembly consists of 250 deputies, elected in direct elections by secret ballot, in accordance with the Law.
- In the National Assembly, equality and representation of different genders and members of ethnic minorities are provided, in accordance with Law.

Election of Deputies and Constitution of the National Assembly

- Elections for deputies are called by the President of the Republic, 90 days before the end
 of the term of office of the National Assembly, so that elections are finished within the
 following 60 days.
- The first session of the National Assembly is convened by the National Assembly Speaker from the previous convocation, so that the session is held not later than 30 days from the day of declaring the final election results.
- At the first session, the National Assembly verifies the deputies' terms of office.
- The National Assembly is constituted by the verification of the terms of office of two thirds of the deputies.
- The verification of the terms of office of two thirds of the deputies ends the terms of office of the previous National Assembly convocation.
- After the decision on the verification of the terms of office is passed, the deputies take the
 following oath: "I swear that I shall perform the duty of deputy faithfully, honestly,
 conscientiously and true to the Constitution, that I shall defend human and minority rights
 and civic freedoms and serve the Serbian citizens, truth and justice to the best of my
 knowledge and abilities".

Status of Deputies

- A deputy's term of office begins on the day of verification of term of office at the National
 Assembly and lasts four years, that is until the expiry of terms of office of the deputies of
 the current National Assembly convocation.
- Under the terms stipulated by the Law, a deputy is free to irrevocably put his/her term of
 office at disposal to the political party upon whose proposal he or she has been elected
 deputy.
- Deputy may not be a deputy in the Assembly of the autonomous province, nor an official
 in bodies of executive government and judiciary, nor may he or she perform other
 functions, affairs and duties, which represent a conflict of interest, according to the Law.
 A deputy's function incompatible with the function of deputy ceases on the day of
 verification of the deputy's term of office.
- Election, expiry of term of office and status of deputies is stipulated by the Law.

Immunity of deputies

- Deputies enjoy immunity.
- Deputies *may not* accept criminal or other liability for the expressed opinion or cast vote in performing the deputy's function.
- Deputy who uses his/her immunity may not be detained, nor may he or she be involved in criminal or other proceedings in which prison sentence may be pronounced, without previous approval by the National Assembly.
- Deputy found in the act of committing any criminal offence for which the prison sentence longer than five years is not envisaged, *may* be detained without previous approval by the National Assembly.

• Failure to use the immunity shall not exclude the right of the National Assembly to establish the immunity.

National Assembly's Method of Operation

The National Assembly and its working bodies convene in sittings.

Regular session - The National Assembly is convoked for two regular sessions per year. The first regular session starts on the first workday of March, while the second regular session starts on the first workday of October. Regular sessions may not last longer than 90 days.

Extraordinary session - The National Assembly is convoked for extraordinary session at the request of at least one third of the deputies or the request of the Government, with previously determined agenda.

Without announcement - The National Assembly is convoked without announcement upon the declaration of the state of war or emergency.

Ceremonial sitting – On the occasion of state or international holidays, the National Assembly Speaker may convoke a ceremonial sitting of the National Assembly and invite the President of the Republic, Prime Minister, representatives of other domestic and foreign authorities and organisations to address the National Assembly.

Special sitting – The National Assembly Speaker may convoke a special sitting in which the National Assembly may be addressed by the President of the Republic, President or representative of a foreign country, parliamentary representative of a foreign country or a representative of an international organisation.

Documents Passed by the National Assembly

The National Assembly passes:

- laws;
- budget;
- development plan;
- spatial plan;
- financial statement;
- Rules of Procedure;
- declarations;
- resolutions;
- recommendations;
- decisions;
- conclusions; and
- authentic interpretations of the documents it passes.

The Law on the National Assembly (Official Gazette of RS, No. 9/10) establishes the status, competence, organisation and method of operation and decision making at the National Assembly, status, rights and duties of the deputies, emblems, symbols and regalia of the National Assembly, relations between the National Assembly and other state authorities, international cooperation, management of property used by the National Assembly, financing of the National Assembly and the status of the National Assembly Support Services.

The Rules of Procedure of the National Assembly of the Republic of Serbia (Official Gazette of RS, No. 56/05 – Refined Text and 81/06) regulate the organisation and work of the National Assembly, method of passing National Assembly documents and the manner in which the deputies' rights and duties are exercised.

Method of decision making in the National Assembly - The National Assembly adopts decisions by majority vote of deputies at the session at which majority of deputies are present.

Right to Propose Laws

- The *right to propose* laws, other regulations and general documents belongs to every deputy, the Government, assemblies of autonomous provinces or at least 30,000 voters.
- The Ombudsman and National Bank of Serbia have the right to propose laws falling within their competence.

Referendum

- Upon the request of the majority of all deputies or at least 100,000 voters, the National Assembly calls the referendum on issues falling within its competence, in accordance with the Constitution and Law.
- The subject of the referendum may not include duties deriving from international contracts, laws pertaining to human and minority rights and freedoms, fiscal and other financial laws, the budget and financial statement, introduction of the state of emergency and amnesty, as well as issues pertaining to election competences of the National Assembly.

Dissolution of the National Assembly - The President of the Republic may dissolve the National Assembly, upon an elaborated proposal of the Government. The Government may not propose dissolution of the National Assembly, if a proposal has been submitted for the vote of no confidence in the Government or if the issue of its confidence has been raised. The National Assembly is dissolved if it fails to elect the Government within 90 days from the day of its constitution. The National Assembly may not be dissolved during the state of war and emergency. The National Assembly, which has been dissolved, only performs current or urgent tasks, stipulated by the Law. In case of declaration of the state of war or emergency, its full competence is reestablished and lasts until the end of the state of war, that is, emergency.

In case of *dissolution* the National Assembly, i.e. the competent National Assembly committee, shall only perform current or urgent tasks, in particular:

- · resolve term of office and immunity issues;
- carry out international cooperation as stipulated by law;
- deal with cases concerning material and status issues of deputies and other elected or appointed persons;
- deal with cases under a legal deadline or dictated by the needs of the state.

National Assembly Assets and Financing – In the discharge of its duties, the National Assembly uses the funds allocated in the budget of the Republic of Serbia and assets owned by the Republic of Serbia. The National Assembly manages these resources in line with the regulations on the budget system and rules on the assets owned by the Republic of Serbia.

The National Assembly manages the assets necessary for the discharge of its duties. The deputies, elected and appointed persons, as well as National Assembly Support Service employees are obliged to manage the assets used by National Assembly with due care and for the designated purpose, in the performance of their duties.

National Assembly Budget – The National Assembly manages and distributes the National Assembly's operational funds independently. The National Assembly budget is a constituent part of the budget of the Republic of Serbia. The Government may not suspend, delay or restrict the

execution of the Assembly budget without the consent of the National Assembly Speaker. The procedure for the adoption of the Assembly budget is regulated by the Law on the National Assembly and Rules of Procedure.

The audit of the execution of the Assembly budget is conducted according to the rules of budget inspection and state audit. Internal audit of the budget execution is implemented by the internal auditor at the National Assembly who is accountable before the Secretary General. At least once a year, the internal auditor submits an activity report to the competent committee and Secretary General.

The Secretary General submits quarterly reports to the competent National Assembly committee on the use and disposal of the National Assembly's assets, while the competent committee submits an annual report to the National Assembly on the use and disposal of the National Assembly's assets.

ORGANISATION OF THE NATIONAL ASSEMBLY

The National Assembly Speaker:

- represents the National Assembly;
- convokes National Assembly sessions and establishes the proposal of the agenda;
- presides over National Assembly sessions;
- convenes meetings of the National Assembly collegium and presides over the meetings;
- is responsible for the work in the National Assembly sessions of the and implementation of the Rules of Procedure;
- is responsible for the timely and coordinated work of the National Assembly working bodies;
- carries out other duties stipulated by the Constitution and the Rules of Procedure.

The Speaker of the National Assembly is elected from the ranks of deputies at the proposal of at least 30 deputies. The election procedure for National Assembly Speaker is regulated by the Rules of Procedure.

If the National Assembly Speaker's term of office is terminated prior to its expiry, the duty of the National Assembly Speaker, pending the election of a new Speaker, is performed by the oldest National Assembly Deputy Speaker.

National Assembly Deputy Speaker

The National Assembly determines the number of Deputy Speakers by a special decree. The National Assembly Deputy Speaker assists the National Assembly Speaker in performing duties within his/her purview.

National Assembly Collegium

A National Assembly body convened by the National Assembly Speaker to coordinate and consult on the work of the National Assembly. The Collegium assists the National Assembly Speaker in representing the National Assembly, convoking National Assembly sessions, confirming proposals of the agenda, coordinating the working bodies and other matters falling within the purview of the National Assembly Speaker.

The Collegium comprises the National Assembly Speaker, National Assembly Deputy Speakers and presidents of deputy groups in the National Assembly. Non-members may attend the Collegium meetings if invited by the National Assembly Speaker.

National Assembly Working Bodies - The National Assembly establishes permanent working bodies, as it may establish temporary working bodies. Permanent working bodies are committees while boards of inquiry and commissions are temporary working bodies.

Committees are established to consider bills and other documents submitted to the National Assembly; review the Government's policy governance; monitor the Government's and other state bodies' compliance with the laws and other general acts, and consider other matters falling within the competence of the National Assembly. Within its competences, a Committee follows the work of the Government and other bodies and authorities the work of which is supervised by the National Assembly in accordance with the Constitution and the law. The Committee considers the reports of the bodies, organisations and authorities submitted to the National Assembly under the law. The National Assembly elects committee members and deputy committee members at the proposal of the deputy groups proportional to the number of deputies of a deputy group in relation to the total number of deputies at the National Assembly.

Subcommittee and the working group – A Committee may establish a subcommittee for the purpose of considering certain matters within its purview and the preparation of proposals on said matters, and the Committee Chairperson may establish a special task group. The subcommittee and task group do work for the needs of the Committee and may not appear independently unless the competent Committee decides otherwise.

A temporary working body may be established in order to monitor the condition in a particular field and confirm the facts of certain occurrences and events. The composition and task of a temporary working body are established by a National Assembly decision.

Deputy Groups - Deputy Groups in the National Assembly are formed from the ranks of deputies. A Deputy Group has a Head and a Deputy Head. The Deputy Group Head represents the Deputy Group. Support and clerical duties required by Deputy Groups are carried out by the National Assembly Support Service.

Secretary General

- assists National Assembly Speaker and Deputy Speakers in preparing and chairing sittings;
- heads the National Assembly Support Service;
- sees to the implementation of conclusions of the National Assembly:
- also performs other duties foreseen by law and by the Rules of Procedure.

The Secretary General is appointed by the National Assembly at the proposal of the National Assembly Speaker. The Secretary General accounts for his/her work to the National Assembly and National Assembly Speaker. The term of office of the Secretary General is terminated on the day of appointment of a Secretary General of a new National Assembly convocation, resignation or relief of duty.

The Secretary General has a deputy who assists him/her and stands in his/her stead in case of absence or inability to work. The Deputy Secretary General is appointed by the National Assembly at the Secretary General's proposal with the approval of the National Assembly Speaker. The Deputy Secretary General is accountable for his/her work to the National

Assembly, National Assembly Speaker and Secretary General. The term of office of the Deputy Secretary General is terminated on the day of the appointment of a Deputy Secretary General of a new National Assembly convocation, resignation or relief of duty.

National Assembly Support Service

The National Assembly Support Service provides expert and other services for the National Assembly. The Service is managed by the Secretary General who has the status of an official managing a state body. The organisation and work of the National Assembly Service are regulated by a National Assembly decision at the proposal of the competent National Assembly Committee (the Administrative Committee).

The internal organisation and job systematisation of the National Assembly Support Service are stipulated in a rulebook enacted by the Secretary General with the approval of the competent National Assembly Committee (the Administrative Committee). The rights and duties of civil servants and employees of the National Assembly Support Service are regulated by laws and other regulations relating to civil servants and state body employees, general labour regulations and special collective contracts for state bodies.

NATIONAL ASSEMBLY SITTINGS

Opening and participating in a sitting - The National Assembly Speaker opens the sitting of the National Assembly and, on the basis of official records on the presence of deputies, ascertains the existence or non-existence of a quorum for the work of the National Assembly. A quorum for the work of the National Assembly exists if a minimum of one-third of deputies are present at the National Assembly sitting. The quorum for the work of the National Assembly on Voting Days, for the adoption of the minutes of the previous sitting, and for the adoption of the agenda, as well as at the constituting sitting of the National Assembly, exists if at least 126 deputies are present at the National Assembly sitting. The quorum is established using the electronic voting system, whereby every deputy is obliged to identify himself/herself upon entering the Assembly chamber, by inserting his/her identification card into the

deputy's electronic voting unit. There is a practice at the National Assembly that the deputies report to the clerks in front of the Great Session Hall, but the official attendance records are established by the electronic voting system.

Course of a sitting - The agenda of a sitting is established by the National Assembly. The National Assembly decides on the agenda as one unit without debate. Deputies, Committees and other bodies of the National Assembly and the Government may propose amendments and modifications to the proposed agenda. The proposed amendments and modifications to the agenda are debated and the National Assembly decides on each proposal for amendment or modification to the agenda individually. When the agenda is established, the National Assembly decides on the proposals in the following sequence:

- for an urgent procedure;
- to withdraw particular items from the proposed agenda;
- to expand the agenda;
- to merge two debates; and
- to change the sequence of particular items.

When discussion is opened on every item of the agenda of the National Assembly sitting, the floor is given in the following sequence to:

- the proposer of the document, i.e. the authorised representative of the group of proposers of a document;
- the Rapporteur of the appropriate Committee;
- any deputy who requested that his opinion should be presented separately at a Committee sitting;
- Deputy Group Head or representative;
- deputies, alternately, according to whether they support or dispute the proposal;
- Prime Minister and members of the Government.

When the debate on all items from the agenda is over, and voting has finished, the National Assembly Speaker concludes the National Assembly sitting.

Parliamentary Questions – Any deputy has the right to ask a parliamentary question of a minister or the Government, within their purview. Deputies' questions are posed to the Government in the presence of Government members every last Thursday of the month at the current session, between 4 p.m. and 7 p.m. during which period work according to the agenda is suspended. Deputies' questions are posed verbally or in written form. The Government i.e. minister is obliged to immediately provide a verbal answer to an verbal question. If the answer requires some preparation, it should be explained immediately, and the answer shall be forwarded to the deputy in written form within 8 days from the day the question was posed. At the proposal of a deputy group, at least once a month, the National Assembly Speaker schedules a day for certain Government ministers to answer parliamentary questions regarding a current issue.

Information and Explanations – Any deputy has the right to request information and explanations they need to perform the duty of deputy, from the National Assembly Speaker, National Assembly Committee Chairperson, ministers and dignitaries of other republican bodies and organisations on issues within the officials' rights and duties, the competence of the authority they head, except during a National Assembly sitting. Exceptionally, the head i.e. representative of a Deputy Group can exercise this right in a National Assembly sitting, verbally, in a single address lasting up to 5 minutes on Tuesdays and Thursdays immediately after the sitting is opened and the number of attending deputies is established, and before the debate commences. Persons from whom the information and explanations are requested are obliged to forward the requested information i.e. explanation to the deputy in written form within 15 days.

Violations of Rules of Procedure by National Assembly Speaker - A deputy has the right to complain of a violation of the Rules of Procedure by the National Assembly Speaker i.e. Chair, if he/she believes that the behaviour of the abovementioned is not in line with the provisions of the Rules of Procedure at a National Assembly sitting in progress, immediately after the violation is noticed. The National Assembly Speaker i.e. Chair grants the deputy the floor immediately after the end of the address of the previous speaker, giving preference to heads of Deputy Groups. The deputy is obliged to state which provision of the Rules of Procedure had been violated by the National Assembly Speaker i.e. Chair and elaborate the violation for up to two minutes. If the National Assembly Speaker i.e. Chair believes that there had been a violation, he/she is obliged to rectify it.

If the National Assembly Speaker i.e. Chair believes that no violation had taken place, he/she is obliged to explain. If after the explanation of the National Assembly Speaker i.e. Chair the deputy still believes that the Rules of Procedure had been violated, he/she may request, without the right to explain, that the National Assembly vote on it at Voting Day without debate.

The time used by a deputy abusing the right to complain of a violation of the Rules of Procedure by the National Assembly Speaker i.e. Chair, is deducted from the total discussion time allotted to his/her Deputy Group per current item on the agenda, if the Deputy Group has discussion time left.

Keeping order at a sitting - Keeping order at a National Assembly sitting is the responsibility of the National Assembly Speaker. In case of a violation of order at a sitting, the National Assembly Speaker may pronounce the following measures:

Reprimand - A deputy shall be reprimanded if he/she:

- should approach the speaker's platform without the permission of the National Assembly Speaker;
- should speak before requesting or being granted the floor;
- should speak about an issue that is not on the agenda even after having been cautioned by the National Assembly Speaker;
- should interrupt the speaker in his/her presentation or make loud remarks, i.e. distract the speaker, or otherwise imperil freedom of speech;
- should present facts and assessments concerning the private lives of others;
- should use expletives and insulting expressions;
- should violate order at the sitting by any other actions, or should act in contravention of provisions of the Rules of Procedure.

<u>Denial of the floor</u> - The floor shall be denied to a deputy who has been reprimanded twice but nevertheless continues to violate article 106 of the Rules of Procedure. A deputy denied the floor is obliged to immediately step away from the speaker's platform.

<u>Expulsion from the sitting</u> - A deputy shall be ordered to leave a sitting if, even after the floor is denied to him/her, he/she should obstruct or hinder deputies in their work at the sitting, fail to obey the decision of the National Assembly Speaker on denial of the floor to him/her, or continue committing other violations under article 106 of the Rules of Procedure. The order for a deputy to leave the sitting may also be given without any other measures having first been imposed, in case of physical assault or other similar action jeopardising the physical or moral integrity of participants in the sitting, in the National Assembly building. A deputy ordered to leave the sitting is obliged to immediately leave the session hall.

FINES

- A reprimanded deputy shall be fined 3,000 RSD;
- A deputy who has been reprimanded twice at the same sitting shall be fined 8,000 RSD;
- A deputy denied the floor shall be fined 16,000 RSD;
- A deputy ordered to leave the sitting shall be fined 32.000 RSD.

If several measures have been pronounced to the deputy for violation of order at a National Assembly sitting, the fines shall not be compounded; rather, only the highest fine shall be imposed.

The Administrative Committee rules on imposing a fine on a deputy. The individual decisions of the Administrative Committee on imposing fines on deputies do not define where the said means are to be directed exactly and all become part of the budget of the Republic of Serbia. The Administrative Committee adopts a special decision stating that the more substantial means in the budget of the Republic of Serbia thus collected, be given to charity.

VOTING

The National Assembly votes on Bills, development plans, zoning plans, the budget, the end-of-year balance, the Rules of Procedure, declarations, resolutions, recommendations, decisions, conclusions and authentic interpretations of documents passed by the National Assembly in principle, detail and their entirety at Voting Day sittings. The National Assembly Speaker convenes Voting Day sittings after the conclusion of the debate on all items on the agenda, with *two exceptions*:

- the National Assembly Speaker can convene a Voting Day sitting on the budget proposal without waiting for the completion of the debate in principle and detail on the other items on the agenda;
- when electing the Government, immediately after the debate concludes, the National Assembly Speaker sets a Voting Day for the office of Prime Ministers and Government Ministers. The proposal to elect candidates for the office of Prime Minister and Government Ministers are voted on as one unit, by secret ballot, unless the National Assembly decides that the vote should be taken openly.

In line with the Constitution, law and Rules of Procedure, the National Assembly decides by voting. The deputies vote "For" a motion, "Against" a motion, or abstain from voting.

The National Assembly decides by either open voting or secret ballot.

The National Assembly decides by open voting.

- by using the electronic voting system;
- by show of hands; or
- by roll call.

Voting by using the electronic system is done by pressing appropriate keys on devices located in front of each deputy's seat (voting unit), having previously inserted identification cards, issued to all deputies, into slots on the devices. The period of time for voting using the electronic system is 15 seconds. Upon expiry of this period, the National Assembly Speaker closes the vote and announces its result. A decision is considered adopted if more than half of the deputies identified, i.e. the majority envisaged by the Constitution, have voted for it. A computer printout of the results of each vote are delivered to Deputy Groups at their request, as well as to the Information Service of the National Assembly for presentation to the media.

The deputies are obliged to use only their own identification cards, and to identify themselves upon entering the chamber by inserting the card into the voting unit i.e. to remove it when leaving the chamber.


If a *vote is taken by show of hands*, the deputies first declare who is in favour of the motion, then who is opposed to the motion, and, finally, who abstains from the vote. A Deputy Group may designate one of its members to monitor the counting of the votes. A decision is considered adopted if more than a half of the deputies present, that is, the majority foreseen by the Constitution, vote for it.

If the National Assembly decides to take a vote by *roll call*, the Secretary of the National Assembly shall roll-call the deputies in the alphabetical order of their last names, and every roll-called deputy shall

say either "Yes", "No" or "Abstained". The National Assembly Speaker repeats the first and last name of the deputy who has voted and his/her statement, or establishes that he/she is absent or that he/she does not wish to vote. The Secretary of the National Assembly records the statement of each deputy or the fact of his/her absence alongside his/her name on the list. A decision is considered adopted if more than half of the Deputies who voted, that is, the majority foreseen by the Constitution, vote in favour.

The National Assembly decides by *secret ballot* when doing so is foreseen by law, the Rules of Procedure, or by a special decision of the National Assembly. Deputies vote by secret ballot by using either the electronic voting system or ballot papers, as decided on by the National Assembly. The procedure of voting by secret ballot is regulated by the National Assembly Rules of Procedure available at the National Assembly website, www.parlament.rs (Article 127 – 135).

ADOPTION OF A LAW



PROCEDURES FOR ADOPTING LAWS AND OTHER NATIONAL ASSEMBLY DOCUMENTS

- procedure for amending the Constitution;
- procedure for adopting laws;
- procedure for ratifying international treaties;
- procedure for adopting the budget of the Republic of Serbia and end-of-year report;
- procedure for adopting the development plan and spatial plan of the Republic of Serbia;
- procedure for giving prior consent to the Statute of the autonomous province;
- procedure for adopting a declaration, resolution, recommendation and strategy;
- procedure for adopting the Rules of Procedure and other general documents;
- procedure for authentic interpretations of laws;
- procedure for adopting Uniform Methodological Rules for Legislative Drafting;
- procedure for verifying and terminating deputies' terms of office;
- procedure for election and termination of office;
- procedure for supervising the work of the Government;
- procedure for supervising the work of security services;
- procedure for dismissing the President of the Republic of Serbia;
- procedure for supervising the work of state authorities, organisations and bodies;
- procedure for responding to a request of the Constitutional Court;
- procedure for deciding on war and peace and declaring the state of war or emergency.

The procedures are regulated by the National Assembly Rules of Procedure available at the National Assembly website, www.parlament.rs (Article 142 – 244).

NATIONAL ASSEMBLY COMMITTEES

Role of Committees - Committees are standing working bodies of the National Assembly established to consider and review issues falling within the purview of the National Assembly, to propose official documents, as well as to carry out reviews of policies pursued, and laws, by-laws and other regulations implemented by the Government of the Republic of Serbia, to be done by each Committee for the field that falls within its purview; and also to perform other duties foreseen by the Rules of Procedure. There are 30 standing Committees, and each Committee may, from its midst, appoint one or more sub-committees to consider certain issues from its purview.

Before being considered by the National Assembly, a bill is considered by competent Committees and the Government, if it is not the submitter of the bill. In their reports i.e. opinion, the competent Committees and the Government, if it is not the submitter of the bill, may propose that the National Assembly accept or reject the bill in principle. The competent Committees and Government submit reports i.e. opinions to the National Assembly no later than five days from the beginning of the National Assembly sitting where the bill is being considered.

Deputy Groups nominate members for each Committee proportionally to the number of deputies they have at the National Assembly. The proposed candidate list for Committee members is voted on as a unit, by open voting. A Committee is constituted if a majority of present deputies have voted in favour. If a deputy group does not nominate candidates for Committee members, the Committee is constituted in the composition in which it is elected based on the nominations of the deputy groups who nominated candidates from their midst, and which is then considered its full membership regarding the existence of decision-making quorum, if more than half of the number of Committee members foreseen by the Rules of Procedure have been elected.

The first sitting of a Committee is convened by the National Assembly Speaker. At the first sitting, the Committee elects a Chairperson and deputy Chairperson from its midst. Pending the election of Committee Chairperson, the first sitting is chaired by the oldest Committee member.

Preparation and convocation of a Committee sitting - A sitting of a Committee is convened by its Chairperson who is obliged to convene a sitting of the Committee at the request of at least one third of the total number of its members, as well as at the request of the National Assembly Speaker. If the Committee Chairperson fails to do so by the requested deadline, the sitting of the Committee shall be convened by its Deputy Chairperson, or by the National Assembly Speaker. Information about the date and agenda of a Committee sitting shall be communicated to all Deputies, Deputy Groups and the Government at least five days prior to the holding of the Committee sitting. Exceptionally, the information may be communicated within a shorter period, but with the provision that the Committee's Chairperson shall be obliged to explain reasons for doing so at the Committee sitting

Course of a sitting - At a Committee sitting, bills are first discussed in principle, and then in particular. After the discussion finishes, the Committee submits to the National Assembly a report containing its opinion and proposals. The Committee designates a Rapporteur who shall, if necessary, present the report of the Committee report at a National Assembly sitting. At the request of a particular Committee member, his/her personal opinion presented at the Committee sitting, shall feature separately in the report of the Committee and he/she is entitled to present it at the outset of the debate on the proposal of the document at the sitting of the National Assembly. A Committee shall deliberate in sitting regardless of the number of Committee members present. A Committee adopts decisions by a majority of votes of its members present if the sitting is attended by a majority of its members. A deputy who is not a member of the Committee may attend a Committee sitting and take part in it, without,

however, having the right to vote. When a Committee sitting is considering Bills and/or amendments to Bills, the proposers of such Bills, or their authorised representatives, are invited to attend the sitting. Minutes are kept at each Committee sitting which include the basic data about the proceedings, the names of present and absent Committee members and names of other participants in the sitting, proposals presented in verbal and written form, opinions of the Committee, the outcome of every vote taken, each personal opinion differing from that of the other members, as well as names of Rapporteurs designated by the Committee.

ACTIVITIES OF THE NATIONAL ASSEMBLY COMMITTEES IN 2008

In its present convocation, the National Assembly was constituted on June 11, 2008. The National Assembly Committees were constituted by a National Assembly's decision of July 4, 2008. They comprise 11 to 25 members. The Committee on Petitions and Proposals and Economic Reforms Committee have not been constituted in the current convocation.

At the sitting held on October 28, 2008, the Administrative Committee adopted decisions on the formation of a Working group tasked with drafting the National Assembly Bill and a Working group tasked with drafting the National Assembly Rules of Procedure. At the Fourth Extraordinary Sitting in 2009, the National Assembly adopted the Decision amending and modifying the Rules of Procedure of the National Assembly of the Republic of Serbia (Official Gazette of RS, No. 13/09). The Legislative Committee of the National Assembly determined the reviewed text of the National Assembly Rules of Procedure, published in the Official Gazette of RS, No. 14/09.

OPFNNFSS OF WORK

The openness of the National Assembly's work is ensured by: the creation of conditions for television and internet broadcasts of National Assembly sessions; press conferences; official press releases; enabling the representatives of the media, observers of domestic and foreign associations and organisations, as well as interested citizens to follow the National Assembly's work; insight into the National Assembly's documentation and archives; insight into shorthand notes and minutes taken at National Assembly sessions; via the National Assembly's webpage and in other ways stipulated by the law and Rules of Procedure. The manner of establishing openness of work and the procedure for excluding the public are regulated by the Law and Rules of Procedure.

Representatives of the press and other media accredited to follow the National Assembly's work are allowed to observe the sittings of the National Assembly and its working bodies and insight into the bills and other documents debated by the National Assembly, shorthand notes of the sitting, insight into the National Assembly's documentation and archive.

All National Assembly sittings are broadcast live via RTS – public service broadcaster, the length of the proceedings notwithstanding. Representatives of the media, deputies and employees of the National Assembly Support Service may also follow the sittings via the internal television in the National Assembly Building, 14 Kralja Milana Street and the National Assembly House, 13 Nikola Pasic Square.

Shorthand notes are kept at National Assembly sittings, which include the text as uttered, without omitting any words or phrases. The shorthand notes are distributed to the Deputy Groups by the following day at the latest. If a deputy wishes so he/she may authorise the text of his/her address within three days from the day of the sitting. Representatives of the media may make use of the shorthand notes of the National Assembly, and when quoting such notes are required to specify whether the statements were authorised.

Conditions for the work of representatives of the press and other media are ensured through the provision of facilities necessary for observing activities at sittings of the National Assembly and its Committees. These conditions are ensured pursuant to appropriate documents adopted by the Administrative Committee of the National Assembly.

The National Assembly and its deputies communicate with the public via announcements, press releases, press conferences, corrections and official denials.

Press releases and other means of public information are given by the National Assembly Speaker, Committee Chairperson, Deputy Group Head or a deputy. Official press releases are prepared by the Public Relations Department of the National Assembly Support Service, and are approved by the National Assembly Speaker or a person authorised by him/her.

The Public Relations Department of the National Assembly Support Service prepares information announcing all events to be held at the National Assembly and forwarding them to news agencies, the press and other media. The announcements of all events at the National Assembly can be found on the official site www.parlament.rs.

Any deputy may hold a press conference at the National Assembly. A request to hold a press conference must contain its date and venue, topic and notification whether any written material will be available for distribution to the press. The request is submitted to the National Assembly Secretary who approves it and forwards it to the Public Relations Department of the National Assembly Support Service who in turn informs the media and ensures the appropriate conditions in the Press hall, at the Building at 14 Kralja Milana Street i.e. Great Hall of the National Assembly House at 13 Nikola Pasic Square.

DEPUTIES' RIGHTS AND DUTIES

Verification of Deputies' Terms of Office

The deputies' terms of office are verified at the first sitting of the National Assembly on the basis of certificates attesting to election as deputy and the report of the Republic Electoral Commission on the conducted elections, within thirty (30) days from the date of the day the elections were held.

At its constituting sitting, the National Assembly sets up a three-member Commission, which establishes whether data from the certificates attesting to the election of each deputy are identical to those contained in the report of the Republic Electoral Commission. Based on the report of the three-member Commission, the oldest deputy chairing the constituting sitting of the National Assembly notes that the Republic Electoral Commission has presented a report on the conducted elections and indicate which certificates attesting to the election of deputies are in accordance with the report, whereby the terms of office of these deputies shall be verified. Deputies acquire rights and duties in the National Assembly on the date of verification of their terms of office.

Under article 11 of the Law on the Election of Deputies (Official Gazette of RS, No.35/00, 57/03 – RSCC decision, 72/2003 – s. law, 75/03 – amend. s. law, 18/04, 101/05 – s. law and 84/05 – s. law), a deputy cannot at the same time hold any judicial or other office to which he has been appointed by the National Assembly of the Republic of Serbia, nor other official or an employee of the republican bodies performing duties related to the competence of such body, except in cases provided by the Constitution. On the day of verification of the deputy's term of office, a person appointed by the National Assembly of the Republic of Serbia is revoked from such office, and the employment status of a person working in state bodies will be congealed.

If a deputy is employed, his/her employment status is considered congealed from the day his/her term of office is verified until it expires, with his/her right to return to his/her employer within 15 days from the termination of office guaranteed by the Labour Law.

Under article 88 of the Law on the Election of Deputies, a deputy's term of office shall terminate before the expiration of the term for which he has been elected: if he resigns; if he has been sentenced by effective Court decision to an unconditional prison sentence of no less then six months; if he has been deprived of business capacity by effective Court decision; if he has taken employment or assumed a function which are incompatible with the position of deputy according to this Law; if he has lost the citizenship; if he no longer permanently resides on the territory of the Republic of Serbia; and in case of the deputy's death. The deputy's term of office terminates on the day when any of the abovementioned cases occur.

The day of termination of term of office is ascertained by the National Assembly of the Republic of Serbia at the first session following the receipt of report on reasons for termination of the deputy's term of office and the deputy's term of office is assigned to a new deputy in the manner established by the Law on the Election of Deputies and the National Assembly Rules of Procedure.

Deputy Identification Card

The identification card allows a deputy to prove his/her status and realise the rights acquired through the office of deputy. Upon verification of his/her term of office, a deputy is issued with a special identification card. The identification card specifies immunity rights and the rights to free transportation in line with the Constitution of the Republic of Serbia and the Law on Income of Deputies at the National Assembly of the Republic of Serbia. After the termination of his/her term of office, a deputy is obliged to return the identification card to the National Assembly Service.

A deputy has the right to:

- propose laws and other documents;
- propose authentic interpretation of the law;
- · submit amendments to bills and other proposed documents;

- participate in debates and rulings on bills and other proposed documents at sessions of the National Assembly and its working bodies;
- participate in submitting referendum proposals on matters regulated by the law;
- submit proposals to create a commission or boards of inquiry;
- submit proposals to organise public hearings on matters of public interest;
- propose changes and amendments to the agenda;
- pose deputy questions;
- participate in submitting interpellation and motion of no confidence to the Government or individual member of the Government;
- hold press conferences at the National Assembly facilities:
- be duly and fully informed on all issues within the National Assembly's purview;
- request information necessary to perform hie/her duty as deputy from the National Assembly Speaker, chairpersons of National Assembly committees and other working bodies, Prime Minister, Government members and officials of other republican bodies and organisations;
- undertake other actions in performing the deputy's function in line with the law and Rules of procedure.

A deputy has the right to:

- a salary;
- fees; and
- other income in line with the law and other documents.

The Right to a Salary - A deputy has the right to a salary under the Law on Income of Deputies at the National Assembly of the Republic of Serbia (Official Gazette of RS, No. 7/91, 22/91, 28/91, 48/91, 68/91, 44/98 and 34/01) and the Law on Salaries in State Authorities and Civil Services (Official gazette of RS, No. 34/01, 62/06 – state law, and 63/06 – amendment of state law). Under the decision of the Administrative Committee of the National Assembly on the realisation of deputies' right to full employment at the National Assembly of the Republic of Serbia, 28 No. 112-230/04 of February 9, 2004, all deputies can be fully employed at the National Assembly. If a deputy wishes to be fully employed he/she submits a request for full employment at the National Assembly to the Administrative Committee. The Administrative Committee adopts a decision on the coefficient for the calculation and payment of the deputy's salary. A deputy fully employed at the National Assembly hands in a concluded and authenticated employment booklet to the Administrative Committee within eighth days from the day of its conclusion and authentication.

Article 7 of the Law on Salaries in State Authorities and Civil Services (Official Gazette of RS, No. 34/01 - state law and 63/06 - amendment of state law) sets the coefficients for calculation and payment of salaries of National Assembly Speaker, National Assembly Deputy Speaker, Chairperson of a standing working body of the National Assembly, deputy group head, Deputy Chairperson of a standing working body of the National Assembly, deputy group deputy head and deputy:

- 12.00 for National Assembly Speaker;
- 10.50 for National Assembly Deputy Speaker;
- 9.40 for Chairperson of a standing working body of the National Assembly and deputy group head;
- 8.80 for Deputy Chairperson of a standing working body of the National Assembly and deputy group deputy head; and
- 8.60 for a deputy fully employed at the National Assembly.

The base for the calculation and payment of salaries is determined by the Administrative Committee of the National Assembly in accordance with the funds secured in the budget of the Republic of Serbia. According to the last decision of the Administrative Committee 28 No. 120/295/05 of February 3, 2005, net base salary amounts to 8 825.00 RSD

Salary Compensation - After termination of office deputies fully employed at the National Assembly have the right to salary compensation in the rate of the salary they earned on the day of termination, for six months at the longest. The right may be extended, but not for longer than six

months. A deputy whose office has ceased during pregnancy or maternity leave has the right to salary compensation after the termination of office in the rate of the salary they earned on the day of termination, for one year at the longest.

A deputy whose office was terminated before the expiry of term he/she was elected to has no right to salary compensation if they had been sentenced to an effective prison sentence of no less than six months.

Right to Severance Pay - Under article 51 of the Ordinance on fees and severance pay of civil servants and employees (Official Gazette of RS, No. 98/07), in order to exercise the right to retirement, a deputy fully employed at the National Assembly has the right to severance pay in the amount of one and a half salary earned in the month preceding the month for which the severance pay is paid, provided that it cannot be lower than three average salaries in the Republic of Serbia according to the last data published by the republic authority in charge of statistics, at the day of payment.

Fees and Reimbursements - Under the Law on Income of Deputies at the National Assembly of the Republic of Serbia, a deputy has the right to:

- Deputy Supplement Under article 9 of the Law on Income of Deputies at the National Assembly of the Republic of Serbia (Official Gazette of RS, No. 7/91, 22/91, 28/9, 48/91, 68/91, 44/98 and 34/01) all deputies have the right to a deputy supplement in the form of a monthly lump sum for the performance of deputy duties in an electoral unit, in the amount of 40% of the wage earned by a deputy fully employed at the National Assembly. The deputy supplement amounts to 30,354.00 RSD net;
- Right to deputy wage differential Under article 5, paragraph 1 of the Law on Income of Deputies at the National Assembly of the Republic of Serbia (Official Gazette of RS, No. 7/91, 22/91, 28/9, 48/91, 68/91, 44/98 and 34/01) a deputy not fully employed at National Assembly has the right to payment of the differential between the full wage of a deputy fully employed at the National Assembly and the pension or wage the deputy earns. The differential is paid based on a certificate of wage or pension rate for every month individually, that the deputy submits to the National Assembly Service Financial and Material Affairs Sector;
- Right to payment for self-employed deputies Under article 5, paragraph 3 of the Law on Income of Deputies at the National Assembly of the Republic of Serbia (Official Gazette of RS, No. 7/91, 22/91, 28/9, 48/91, 68/91, 44/98 and 34/01) and Decision of the Administrative Committee of the National Assembly 28 No. 120-1716/01 of June 11, 2001, a self-employed deputy has the right to a monthly payment of 80% of the wage earned by a deputy fully employed at the National Assembly. The payment is realised on grounds of a certificate attesting to entry in a register (Bar Association, Agency for Economic Registration);
- Reimbursement of costs for use of private car A deputy has the right to reimbursement of costs for the use of private car in the amount of 15% of the price of a liter of fuel per kilometer, according to the List of distances between the deputy's place of residence and Belgrade which is part of the quoted decision. When sittings of the National Assembly or its working bodies are held for two or more days consecutively, the right to reimbursement of costs for the use of private car in full is granted to a deputy for one arrival and departure. For the remaining workdays, the right to reimbursement is granted for distances of up to 125 km between the National Assembly seat and the place of residence, so that the total of kilometers crossed cannot amount to more than 250 km. A deputy shall not be granted the right to reimbursement of costs for the use of private car for those days when he/she has exercised the right to reimbursement of overnight costs or the right to apartment lease allowance;
- Remuneration of catering expenses A deputy has the right to remuneration of catering expenses in the amount of 5% of the average monthly income per employee in the Republic of Serbia economy sector according to the last data published by the republic authority in charge of statistics. A deputy realises the right to remuneration in full if he/she had participated in both the morning and afternoon proceedings of a National Assembly session, and the right to half of the remuneration if he/she had attended only the morning or only the afternoon part of a session. A deputy who had participated in the work of a

National Assembly working body as its member, has the right to remuneration of catering expenses in full:

- Reimbursement of hotel accommodation costs A deputy who neither resides on the territory of Belgrade, nor leases an apartment in Belgrade can exercise the right to hotel accommodation in the days when the National Assembly or the working bodies he/she is member of are in session, in all except first class hotels (******), by submitting relevant bills to the National Assembly Support Service – Financial and Material Affairs Sector:
- Reimbursement of apartment lease costs At a personal request of a deputy who neither resides on the territory of Belgrade nor uses the right to hotel accommodation, the Administrative Committee of the National Assembly may decide that he/she be paid a monthly allowance of up to 35 000 RSD for the lease of an apartment in Belgrade. To exercise this right a deputy must submit an authenticated apartment lease contract. A deputy who exercises this right also has the right to an allowance for living separately from his/her family, in the amount of 40% of the average monthly income per employee in the Republic of Serbia economy sector according to the last data published by the republic authority in charge of statistics, at the day of payment. The family of a deputy exercising the right to allowance for living separately from his/her family comprises of marriage partner and any underage children living with the deputy in a common family household. A deputy who exercises the right to reimbursement of apartment lease costs cannot exercise the right to reimbursement of costs for the use of private car.

Note: On April 24, 2009, the Administrative Committee of the National Assembly adopted a Decision amending and modifying the Decision on Deputies' Fees, 28 No. 120-1105/09, **abolishing** the deputies' right to remuneration of catering expenses (per diem).

Right to use public transportation - The Law on Income of Deputies at the National Assembly of the Republic of Serbia (Official Gazette of RS, No. 7/91, 22/91, 28/91, 48/91, 68/91, 44/98 and 34/01) establishes the deputies right to unlimited free rail, road, river and public city transportation on the territory of the Republic of Serbia in all directions. The manner in which this right is exercised is established by the Decision on the manner and procedure for exercising the right to free transportation of deputies at the National Assembly of the Republic of Serbia (Official Gazette of RS, No. 7/92)

Right to use official car – According to the Ordinance on the conditions and manner of use of official cars (Official Gazette of RS, No. 112/08), the right to regular use of an official vehicle and chauffer belongs to the National Assembly Speaker, National Assembly Deputy Speakers and National Assembly Secretary. The deputies have the right to use official vehicles to perform certain duties in accordance with the Decision of the Administrative Committee of the National Assembly on the use of official cars.

Right to use business landlines and mobile telephones - The Decision of the Administrative Committee of the National Assembly on the use of business landlines and mobile telephones of the National Assembly of the Republic of Serbia, Decision 28 No. 404-727/09 of March 5, 2009, regulates the manner of use of business landlines in the offices of the Building and Home of the National Assembly, the right to use a business mobile telephone and SIM card and number, the right to an business SIM card, as well as the right to add credit to a private card for a mobile telephone given to certain persons for the purpose of performing National Assembly duties. The original text of the decision is available in the SUPPLEMENTS chapter.

Right to refreshments - Coffee, tea, mineral water and non-alcoholic beverages may be served during sittings and official meetings at the National Assembly, in a manner determined by the Decision of the Administrative Committee of the National Assembly on catering services during official meetings at the National Assembly of the Republic of Serbia. The National Assembly Speaker and Deputy Speakers, Deputy Groups' heads and deputy heads and committee chairpersons during sittings and meetings they have convened, as well as the National Assembly Secretary, i.e. the person conducting a meeting under his/her orders have the right to free refreshments.

Diplomatic Passport - A deputy is issued a diplomatic passport when entrusted a mission abroad. After the official trip, the deputies' passports are deposited with the National Assembly Secretary. A request for a diplomatic passport and visa for said passport are submitted to the National Assembly Secretary upon receiving a decision of the National Assembly Speaker on required official foreign travel.

In addition to the request, one must submit:

- two photographs 3.5 x 4.5 cm faithfully depicting the features of the person submitting the request;
- proof of citizenship (not older than six months) or copy of regular passport;
- proof of payment of administrative fee.

Right to per diem payment for foreign travel - Deputies have the right to per diem payment for official foreign travel in the amount and manner stipulated by the state authority in charge. The decision on required foreign travel is made by the National Assembly Speaker on grounds of a request and invitation letter from abroad submitted by the deputy no less than seven days before the planned travel. The invitation letter submitted along with the request must contain: the name of the event taking place abroad, period of deputy's stay abroad and manner of coverage of travel expenses.

After the official travel had taken place, the deputy is obliged to submit a written report on the official travel to the National Assembly Support Service – Financial and Material Affairs Sector, justifying the expenses. The amount of the per diem payment for foreign travel is determined by the Ordinance on fees and severance pay of civil servants and employees (Official Gazette of RS, No. 98/07).

A deputy is obliged to:

- observe the Constitution, Law and Rules of Procedure;
- participate in the work of the National Assembly and its working bodies;
- abide by the decisions of the competent National Assembly Committee establishing the deputies' rights and duties;
- protect information considered a state, military or official secret even after the cessation of his/her employment at the National Assembly;
- behave in a manner respectful of the dignity and order at the sittings of the National Assembly, its working bodies and deputy group meetings:
- address the other deputies with respect, without using insulting language and disclosing information and speculations concerning other persons' private lives;
- to use the Republic of Serbia budgetary funds allocated for the functioning of the National Assembly in a responsible and rational manner;
- submit a report to the competent state authority on his/her assets and income, as stipulated by the law; and
- perform other duties as stipulated by the law and Rules of Procedure.

Rights after the expiration of term of office – A deputy whose term of office has expired has the right to:


- return to work for the employer where his/her employment status had been congealed due
 to his election to the office of deputy, within two months from the expiration of his/her term
 of office;
- access the archives and documents on the National Assembly's work that he/she had access to during the term of office; and
- access the National Assembly Library and Deputy Club.

A deputy whose term of office has expired is issued with a lasting identity card for the purpose of exercising abovementioned rights.





NATIONAL ASSEMBLY SUPPORT SERVICE

The National Assembly Support Service provides expert and other services for the National Assembly, its working bodies, the deputies and deputy groups, as well as certain services for the Republic Electoral Commission.

The Decision on the Organisation and Work of the National Assembly Support Service (Official Gazette of RS No. 62/06) regulates the organisation and work of the National Assembly Support Service, defines and classifies the positions and jobs of those employed at the National Assembly Support Service, and regulates other issues of importance for the National Assembly's work.

National Assembly Secretary General and Deputy Secretary General

The National Assembly Support Service is **headed by the National Assembly Secretary General** who adopts rulebooks, orders, instructions and decrees for the purpose of proscribing the manner of operation and discharge of duties at the National Assembly Support Service. The National Assembly Secretary General passes a document on the internal organisation and job systematisation in the National Assembly Support Service, adopted by the Administrative Committee of the National Assembly.

The Secretary General has a *deputy* who assists and stands in for him/her in case of his/her absence or inability to work. The Deputy Secretary General is appointed by the National Assembly at the proposal of the Secretary General with the consent of the National Assembly Speaker. The Deputy Secretary General is answerable for his/her actions before the National Assembly, National Assembly Speaker and Secretary General.

The Sector for organisational and clerical affairs caries out general clerical duties, conducts public procurement processes, information, research and library duties, maintains the electronic voting system, computer network and telecommunication systems at the National Assembly.

The Public Procurement Department performs the following duties: prepares documentation for the implementation of processes of public procurement of property, services and work for the needs of the National Assembly; carries out public procurement processes; prepares and forwards reports to competent authorities; keeps records on contracts concluded on public procurement and monitors the realisation of said contracts.

The Department for Information, Research and Library Duties conducts expert, analytical, information and research duties concerning the National Assembly's legislative activities, expert research and comparative analysis for the needs of the deputies and working bodies of the National Assembly on issues to be discussed at National Assembly sittings.

The Department for Information, Research and Library Duties comprises *two sections*:

- Information Research Section
- Library Duties Section

The Information Research Section carries out duties which allow the deputies, working bodies and the National Assembly Support Service access to all acts in assembly procedure, draft laws and other

acts of the Government and ministries, positive national legislation, foreign legal acts and acts of international organisations and the European Union, bibliographic and factographic information; it prepares informative material on issues to be discussed at National Assembly sittings, prepares statistical reports on the National Assembly's legislative activities, prepares expert analyses and information at the request of international organisations, national parliaments and institutions in the network of the European Centre for Parliamentary Research and Documentation.

The Library Duties Section has at its disposal a specialised closed type library which collects, preserves and issues library material and sources of information to the deputies and the National Assembly Support Service. The employees of the Section take care of the reception and classification of library material, take inventory and initial library material, catalogue, index and classify library material and take care of the library's catalogue, provide expert assistance to the users when making and formulating requests for information, deal with the storage and circulation of library material, deal with the protection of old and rare books, provide inter-library borrowing services with the National Library of Serbia and other libraries for the needs of the deputies.

The Information Technology Department prepares the development and improvement programme for the connection system and other electronic systems, maintains and regulates the working regime of the telephone exchange, conference discussion system and internal television, sees to the sound system of the session halls and recording of the course of the sessions, maintains the National Assembly's computer network, maintains and improves the National Assembly's web presentation, provides e-mail services for National Assembly users, designs application software and conducts other business within the Department's competence.

The Sector for investment, technical and running maintenance deals with the investment, technical and running maintenance of the premises, installations, facilities, machines and equipment, the construction, reconstruction, development, adaptation and rehabilitation of the premises and offices used by the National Assembly, maintenance of sanitation and adequate hygiene in the premises and offices used by the National Assembly.

The Sector for investment, technical and running maintenance comprises *two departments*:

- Investment maintenance department; and
- Technical and running maintenance department;

The Investment maintenance department performs the following tasks: analyses the existing situation and predicts the National Assembly's short-term and long-term technical and technological needs; drafts long-term and short-term development plan proposals, long-term and short-term investment plan proposals and annual public procurement plan proposals pertaining to the field; deals with the protection and use of cultural properties, interior and exterior design, and performs duties concerning construction, reconstruction, additions, adaptation and rehabilitation of the premises and offices used by the National Assembly.

Technical and running maintenance department performs the following duties: technical and running repairs of the premises, installations, facilities, appliances and equipment; air-conditioning of the buildings and offices and sanitation and maintaining adequate hygiene of the buildings and offices used by the National Assembly.

BUILDINGS USED BY THE NATIONAL ASSEMBLY

National Assembly House – 13 Nikola Pasic Square

The edifice of the present House of the National Assembly of the Republic of Serbia was erected near the place where on November 30, 1830 the Great National Assembly took place. On that occasion, the Turkish sultan's state decree on the rights of Serbs was proclaimed and the hereditary title of Prince Milos was confirmed. The construction of the parliamentary edifice, based on the design of the architect Jovan Ilkic from 1901, started in 1907, when King Petar I Karadjordjevic laid the cornerstone of the future House of National Representation.



The construction of the building was completed in 1936 and the first session in the new edifice was held on October 20th of the same year. At the time, it was the National Assembly of the Kingdom of Yugoslavia. In September 1939, the Assembly was dissolved and during the Second World War it was occupied by the aggressor's civil administration for Serbia. Several decades after the end of the war, this was the building of the Assembly of the Democratic Federal Yugoslavia, the Assembly of the Federal People's Republic of Yugoslavia and the Assembly of the Socialist Federal Republic of Yugoslavia. After the dissolution of SFR Yugoslavia, in the 1990s, this edifice became the seat of the Federal Republic of Yugoslavia, i.e. the seat of the Assembly of the State Union of Serbia and Montenegro. On June 5, 2006, Serbia became an independent state, thus, the parliamentary building became the House of the National Assembly of the Republic of Serbia.

The Government of the Republic of Serbia – Office Buildings and Space Allocation Commission adopted Conclusion 77 No. 361-3712/2006-001 of July 6, 2006 allocating the following for the use of the National Assembly: real estate in Belgrade, 13 Nikola Pasic Square (building of the former Assembly of Serbia and Montenegro) with full equipment and instruments of labour in it for the purpose of providing office space necessary for the Assembly's operations. In the same Conclusion, the Government of the Republic of Serbia – Office Buildings and Space Allocation Commission ruled that,

in addition to the abovementioned real estate, the National Assembly of the Republic of Serbia shall continue to use the building in Belgrade, 14 Kralja Milana Street, it had so far used in the performance of its duty.

The National Assembly House covers an area of 13,400 m2 and contains four floors: subterranean part, ground floor, first floor and attic and mezzanines – below the subterranean part, between the subterranean part and ground floor and between the ground floor and first floor. The building contains 100 offices, great and small plenary halls and four committee halls with full conference equipment. All the halls are air-conditioned. The building is equipped with computers, printers, scanners and fax machines, has an internal television channel and computer network with a non-stop internet connection.

The library, situated on the first floor of the National Assembly House, has an area of 165 m2 and contains over 60,000 books.

Building of the National Assembly – 14 Kralja Milana Street

The original design for the Building of the National Assembly at 14 Kralja Milana Street was completed in 1948, and its construction was completed in late 1953. The building was designed by architect E. Azriel, and was constructed by the Construction Institute of Serbia. The Building was originally named the Office Building of the Presidency of the Government of the People's Republic of Serbia at 14 Marshal Tito Street. The first National Assembly session in the building was held on March 20, 1954, while in the period between 1945 and 1954, the National Assembly sessions were held in the building the currently known as National Assembly House, 13 Nikola Pasic Square.



The National Assembly building at 14 Kralja Milana Street contains 160 offices, three committee halls (on the first, third and fifth floor respectively), one big and one small Assembly session hall, Press hall and so-called Presidency hall. All the halls are air-conditioned. Regarding technical equipment, the building is furnished with computers, printers, scanners and fax machines, it has an internal television channel and computer network connecting all National Assembly premises, with a non-stop internet connection. The Big Hall, where National Assembly sessions are held, is equipped with an electronic voting system and a system for simultaneous interpretation.

The National Assembly has six large air-conditioning systems at its disposal, treating the Big Hall and adjoining hallways, Small Hall, committee halls, Press hall, Blue Salon and the restaurant. The building is equipped with a cable distribution system providing every office with an on-line and internet connection (service provided by the Department for Joint Affairs of Republic Authorities), intranet and cable television. The National Assembly has an analogue telephone exchange in the building at 14 Kralja Milana Street and a digital telephone exchange at the National Assembly House, 13 Nikola Pasic Square, and the joint operation of both telephone networks is provided by the new IP telephone exchange.

Under the Contract on the use of office space in an office building, 16 Kralja Milana Street – entrance from 11 Dobrinjska Street, the National Assembly had concluded with the Economics Institute, starting from 2003, the National Assembly has been using a number of offices on the ground floor, mezzanine and first floor of the building.

Ancillary Services

The deputies, employees of the National Assembly Support Service and other persons using the National Assembly premises on other grounds are allowed the use of:

- A post office at the National Assembly Building at 14 Kralja Milana Street, providing full postal services: operations with personal accounts, opening personal transfer accounts, enabling all types of deposits and payments, payment of all types of bills, deposits into dinar or foreign currency accounts, remittance by post, telegraph and post-net, opening internet user accounts, direct payment of additional internet hours or purchase of coupons, sale of telephone numbers and additional credit for 064 and 063 mobile phone networks and telephone cards of all values, currency exchange, reception and delivery of all types of mail and parcels, sending and reception of telegrams;
- A restaurant at the National Assembly Building at 14 Kralja Milana Street seating 164 and 5 bars serving hot and cold non-alcoholic beverages, as well as a restaurant at the National Assembly House,13 Nikola Pasic Square seating 124 and two bars serving hot and cold beverages. The Administration for Joint Services of the Republic Bodies is in charge of all types of public procurements for the restaurants and bars;
- A dispensary with medical personnel (doctor on call and nurse) providing medical assistance during National Assembly sessions. In addition to the dispensary which is supplied with medicines, an ambulance is also available for possible urgent transportation to health institutions;
- The Information Research Department of the National Assembly Support Service (ground floor next to the Press hall), enables access to information on the internet and databases: INTERMEX INDOK (continually updated database containing several thousands of revised texts of regulations); CELEX (official database of European Union legal regulations containing texts of the EU founding treaties, EC legislation, EU Court cases, opinions and resolutions of EU institutions and advisory bodies, European Court common law, bibliographical data on preliminary acts, petitions of the European Parliament and reports on the implementation of the Community's directives in member states); and ECPRD (database of the European Documentation and Research Centre containing an abundance of information, publications and research studies from a large number of European parliaments. CELEX database documents are available in 11 EU official languages and comprise information dating from 1951. The ECPRD database documents are available in English.
- The National Assembly library collection contains: professional books and monographies from the fields of law, politicology, sociology, philosophy, literature, and from the field of fiction mostly reference and prize winning books; collection of regulations of federal and republic bodies with registers from 1945 until present time; shorthand notes of the National Assembly of Serbia from 1889 until present time; considerable archival material (eg. Protocols of the Extraordinary National Assembly from 1880, of the Assembly of the Kingdom of Yugoslavia from 1919 until 1939, Official Gazette of the Kingdom of Serbs, Croats and Slovenes from 1921); professional journals; daily press. The library also has an electronic database of legal regulations, INDOK, comprising the regulations of Serbia and Montenegro, the Autonomous Province of Vojvodina and the City of Belgrade in force from 1991 until present time.

Under article 73 of the Rules of Procedure of the National Assembly of the Republic of Serbia (Official Gazette of RS, No. 14/09 -), at the sitting held on 5 March 2009, the Administrative Committee of the National Assembly of the Republic of Serbia adopted the

DECISION

on the foundation of a National Assembly Solidarity Fund

Article 1

Under this decision, a National Assembly Solidarity Fund is founded for the purpose of providing assistance to socially endangered groups (children, the elderly, disabled persons, refugees, internally displaced persons, Roma, poor population of rural areas) with the goal of supporting the implementation of the National Poverty Reduction Strategy.

Article 2

The Solidarity Fund consists of funds raised from the daily wages of National Assembly deputies.

The deputies contribute one daily wage per month into the Solidarity Fund.

Article 3

By a special decision of the Administrative Committee of the National Assembly the assets in the Solidarity Fund are given to charity for socially endangered persons listed in article 1 of the decision.

Article 4

The implementation of the decision falls into the purview of the Secretary of the National Assembly.

Article 5

The decision comes into force one day after its adoption.



Bringing Institutions Closer to the Citizens - This programme is available for individual requests (an organized group is not necessary). The programme consists of a joint visit to the National Assembly, the building of the President of the Republic, the Government of the Republic of Serbia and the City Assembly of Belgrade. Mobile Parliament - Field delegations comprising deputies and National Assembly Support Service employees visit distant regions and answer the citizens' questions in open forums in local self-governments. Two mobile parliaments have been organized up to date. The first made a three-day visit to Vranje, Nis and Pirot. The second mobile parliament visited Novi Pazar, Sjenica and Prijepolje.

National Assembly Session Simulation - In cooperation with the Ministry of Education of the Republic of Serbia, the Faculty of Political Sciences and the Munich Centre for Applied Policy Research, the National Assembly has realised the project SIMULATION OF A NATIONAL ASSEMBLY SESSION FOR HIGH-SCHOOL STUDENTS. It includes all material necessary to simulate a parliamentary session - its constitution, a bill entering procedure, working in deputy clubs, committees, writing amendments and opinions, debating in principle, on the particulars, and voting on a bill. Teachers were also trained in Citizens' Education in all 19 school administrations who shall implement session simulations in schools. 12 simulations have been held to date, involving 500 high-school students.
