AMENDMENTS TO THE CHARTER OF THE BRITISH PSYCHOLOGICAL SOCIETY

1. In the first paragraph of the pre-amble, **delete** "now occupying certain buildings at St Pancras in London".
2. In Article 1:
  - (a) **delete** "the old Institution" and **substitute** "The Old Institution (being the said Society known as the "British Psychological Society" whose President presented the said Petition)";
  - (b) after "'The British Psychological Society'" **insert** "(("the Society"))".
3. **Delete** Article 2 and **substitute** with:

"In this Our Charter and Statutes unless the context otherwise requires:

Annual General Meeting"	shall mean an annual general meeting of the Members held in accordance with Statute 13;
"Board of Trustees"	shall mean the board of Trustees of the Society;

“Boards of the Society”	shall mean the Society’s decision making boards;
“Code of Ethics and Conduct”	shall mean the Society’s code of ethics and conduct;
“General Meeting”	shall mean a general meeting of the Members as described at Statute 13(1);
“Graduate Basis for Chartered Membership”	shall have the meaning as set out in Statute 4;
“List of Members”	shall mean the list of members maintained by the Society;
“Members”	shall mean members of the Society namely Student Members, Graduate Members, Chartered Members and Honorary Members;
“Member Conduct Rules”	shall mean the member conduct rules of the Society;
“Member Network”	shall have the meaning as set out in Article 12;
“Officers”	shall mean the officers appointed by the Society;
“The Old Governing Body”	shall mean the persons constituting at the date hereof the Council of The Old Institution;
“The Old Institution”	shall have the meaning given in Article 1;
“Representative Council”	shall have the meaning set out in Statute 21;
“the Society”	shall have the meaning given in Article 1;
“Special General Meeting”	shall mean a special general meeting of the Society;
“Statutes”	shall mean the Statutes of the Society for the time being in force;
“Subscribers”	shall mean subscribers of the Society;
“The Trustees”	shall mean the Board of Trustees of the Society; and
words importing the singular number only shall include the plural number and vice versa.	

4. In Article 3;

- (a) *delete* “object” and *substitute* “objects”;
- (b) *delete* the number “(i)” before the first sub-paragraph;
- (c) after “In pursuance of”, *delete* “that object and no other the trustees”, and *substitute* “those objects and no other the Trustees”;
- (d) *renumber* subsequent sub-paragraphs (ii) to (iv) as “1” to “3”;

- (e) in 3(2), as renumbered:
    - (i) after "Code of" *insert* "Ethics and";
    - (ii) *delete*, "Contributors and";
  - (f) in 3(3) as renumbered:
    - (i) after "List of Members", *delete* "and Contributors".
    - (ii) *delete* "Council" and *substitute* "Board of Trustees";
  - (e) *delete* sub-paragraph (v);
  - (f) *renumber* sub-paragraphs (vi) to (xiv) as "4" to "12";
  - (g) in sub-paragraph 3(12) (as re-numbered) *delete* "purposes" and *substitute* "objects".
- 5. In Article 4:
  - (a) *delete* "the old", wherever it appears and *substitute* with "The Old";
  - (b) *delete* sub-paragraphs (i) to (v) and *substitute*
    - "1) Student Member
    - 2) Graduate Member
    - 3) Chartered Member
    - 4) Honorary Member";
  - (c) *delete* the final sentence "Provided that no person . . . Ordinary Member".
- 6. *Delete* Articles 5 to 16 inclusive and *substitute*:
 

"5. Subject to and in accordance with the provisions of the Statutes, the Board of Trustees may admit other persons as Subscribers to such privileges and benefits of the Society as they may determine from time to time excepting always the right to vote at General Meetings of Members.

6. The qualifications, mode of admission, rights, privileges and obligations of Members shall, subject as herein provided, be as prescribed by the Statutes.

(1) Any Member who shall have acted in breach of the Member Conduct Rules shall be liable to have his or her membership terminated or suspended in accordance with the procedures laid down in the Statutes.

7. Subject to the provisions of this Our Charter, the rights and obligations of Student Members, Graduate Members, Chartered Members and Honorary Members insofar as they are provided for by the Statutes may be varied or abrogated by any amendment of or addition to the Statutes without any sanction, approval, consent or resolution by any individual or class by a General Meeting.

8. The Statutes shall provide for the payment of entrance fees, transfer fees and subscriptions payable by Members.

9. Members may use such titles and abbreviations after their names as specified in the Statutes.

10. There shall be held a General Meeting of the Society once in each calendar year and Special General Meetings at such times as may be necessary or desirable, in every case in accordance with the provisions of the Statutes.

11. There shall be a Board of Trustees of the Society totalling not less than twelve Members who are Graduate or Chartered Members or Honorary Members who have been Graduate or Chartered Members, comprising the President, Honorary Treasurer, Honorary General Secretary, President-Elect, Vice President, the Chairs of the other Boards of the Society and other persons co-opted in a manner prescribed by the Statutes.

12. The Board of Trustees may establish Member Networks of the Society, as set out in this Article ("the Member Networks"), to assist in the promotion of its objects and the Statutes shall provide for the activities and conduct of the established and future Branches, Sections, Divisions and Special Groups;

- (1) Branches in any part of Our United Kingdom of Great Britain and Northern Ireland;
- (2) Sections concerned with special branches or aspects of psychology;
- (3) Divisions concerned with the standards of professional education and knowledge of their Members;
- (4) Special Groups (which may be otherwise designated) concerned with principal areas in which psychologists provide advice, tuition or services;
- (5) Other such groups as the Board of Trustees thinks fit.

13. The income of the property of the Society whencesoever derived shall be applied solely towards the promotion of the objects of the Society set forth in this Our Charter and no portion shall be paid or transferred directly or indirectly by way of dividend, bonus or otherwise howsoever for profit to the Members of the Society. Provided always that with the exception of Members of the Board of Trustees to whom the restrictions of the Charities Act 2006 apply nothing herein contained shall prevent the payment in good faith of reasonable and proper remuneration to any officers or servants of the Society or to any Member of the Society, for any services actually rendered to the Society, nor the payment of royalties to an author or editor under contract, nor the payment of reasonable and proper fees to any examiner appointed by the Board of Trustees whether a Member of the Board of Trustees or not provided also that at any given time the President and Honorary General Secretary may receive payment out of the property of the Society to compensate them for the sum or sums of money lost from employment or deducted from their earnings by their employers in respect of time spent on the conduct of the business of the Society, provided that:

- (1) such compensation does not exceed the amount that would be regarded as reasonable payment for the work undertaken on behalf of the Society;
- (2) a Member shall not vote on any resolution or question relating to any fee payable to him or her, or to his or her conditions of service;
- (3) nothing in this Article shall prevent the payment of interest at a rate not exceeding five per cent per annum on money which may be borrowed for the purposes of the Society from any Member of the Society;
- (4) nothing in this Article shall prevent the payment of any premium in respect of any indemnity insurance to cover the liability of the Board of Trustees which by virtue of any rule of law would otherwise attach to them in respect of any negligence, default, breach of trust or breach of duty of which they may be guilty in relation to the Society provided that any such insurance shall not extend to any claim arising from any act or omission which the Trustees knew to be a breach of trust or breach of duty or which was committed by the Trustees in reckless disregard of whether it was a breach of trust or breach of duty and provided also that any such insurance shall not extend to the costs of an unsuccessful defence to a criminal prosecution brought against the Trustees in their capacity as Trustees of the Society.”.

8. In Article 15 as renumbered, **delete** “Second”.
9. In Article 16, after “passed by a majority”, **delete** “of not less than two thirds”.
10. In Articles 16, 17 and 19 as renumbered, **delete** “of the Society”, wherever it appears.
11. In Article 17 as renumbered, **delete** “Board of Trade” and **substitute** “Department for Business, Innovation and Skills”.
12. In Article 18 as renumbered, **delete** “Article 16” and **substitute** “Article 13”.
13. In Article 19 as renumbered, delete “members of the Board of”.
14. In Article 20 as renumbered, delete “Letters” and substitute “Charter and Statutes”.

UNIVERSITY OF STRATHCLYDE CHARTER

For Articles 1 to 28 *substitute*:

**"The Name of the University**

1. There shall continue to be a body politic and corporate by the name of "The University of Strathclyde" ("the University") with perpetual succession and a Common Seal and whose current Members are set out in the Ordinances of the University.

### **The Objects of the University**

2. The objects of the University shall be to advance learning and knowledge by teaching, research and knowledge exchange in Science, Engineering and Business as well as defined areas of the Social Sciences and Humanities and to provide a high quality education and experience so as to inspire students to develop to the full their abilities.

### **The Powers of the University**

3. The University shall have all the powers of a natural person to do all lawful acts that are conducive or incidental to the attainment of the objects of the University, which includes but is not limited to the power to award and revoke degrees and other distinctions (including without limitation, diplomas, joint degrees, dual degrees, double degrees, certificates, fellowships, honorary degrees, honorary fellowships, memberships and associateships) in its own name and/or jointly with other education institutions.

### **Application of Income**

4. The University shall not make any dividend, gift, division, or bonus in money unto or between any of its officers or members of Court except by way of prize, reward or special grant.

### **The Court**

5. There shall be a court of the University ("the Court"), which shall be the supreme governing body of the University and shall be responsible for the exercise of the University's powers. The functions of the Court shall include, without limitation:
  - 5.1 the custody and use of the Common Seal;
  - 5.2 the oversight of the management and administration of the revenue, property, staff and students of the University; and
  - 5.3 oversight of the conduct of the affairs of the University.

### **Delegation of Functions of the Court**

6. The Court may delegate all or any of its functions provided that the Court shall not delegate any of the following:
  - 6.1 the determination of the character and mission of the University;
  - 6.2 the responsibility for ensuring the solvency of the University and for safeguarding its assets, including the appointment of auditors, the



- establishment of an audit committee and the approval of the University's annual audited accounts;
- 6.3 the making of, alteration, amendment or addition to this Our Charter or the Statutes; or
- 6.4 the appointment and removal of the Principal.

### **Officers**

7. The University shall have the following Officers:
- 7.1 the Chancellor, who shall be the ceremonial head of the University;
- 7.2 the Principal, who shall be the principal academic and administrative officer of the University and shall also have the title of Vice-Chancellor;
- 7.3 the Chief Operating Officer, who shall be the Secretary of Court; and
- 7.4 the University shall have such other Officers as is provided for by Ordinance.

### **The Senate**

8. There shall be a Senate of the University which, subject to the provisions of this Our Charter and the Statutes and to the general control and approval of the Court, shall be responsible for the academic work of the University, in teaching, in research and in knowledge exchange, and for the regulation and superintendence of the education and discipline of the students of the University.

### **The Students Association**

9. There shall be a Students Association of the University, which shall conduct and manage its own affairs and funds in accordance with a constitution approved by the Court. No amendment to or rescission of that constitution shall be valid unless approved by the Court.

### **Alumni**

10. The University shall engage with its former students and alumni. The University may, from time to time, prescribe in the Ordinances the conditions of such engagement.

### **Academic Freedom**

11. Academic and other staff of the University engaged to teach, research or provide learning have freedom within the law both to question and test received wisdom and to put forward new ideas and controversial or

unpopular opinions without putting themselves at risk of losing their jobs, or any privileges which they may enjoy at the University, by virtue of such ideas or opinions.

### **Equal Treatment**

12. The University shall be committed to the fair and equal treatment of every person and shall not discriminate on unjustified, irrelevant or unlawful grounds.

### **Staff and Student Engagement**

13. The University shall arrange opportunities for engagement and consultation with staff members and students of the University as deemed appropriate.

### **Community Engagement**

14. The University shall engage with its broader communities. The University may, from time to time, prescribe in the Ordinances the conditions of such engagement.

### **The Charter, Statutes, Ordinances and Regulations**

15. Following consultation with the Senate, the Court may amend, add to, or repeal this Our Charter by a resolution passed at a Court meeting by a majority of not less than three quarters of those present and voting. Such amendment, addition or repeal shall, when allowed by Us, Our Heirs or Successors in Council, have effect so that this Our Charter shall operate as though it had been originally granted and made as so amended, added to or repealed.
16. There shall be Statutes, Ordinances and Regulations of the University which shall contain all such other provisions consistent with this Our Charter as it may be thought proper to make for the convenient and effective attainment and execution of the objects and purposes of this Our Charter, provided that no provision of the Statutes, Ordinances or Regulations shall be repugnant to this Charter. The Statutes may direct that any of the matters authorised in this Charter to be prescribed by Statutes shall be prescribed by Ordinances or Regulations.
17. Following consultation with the Senate, the Court may by a simple majority amend, add to or repeal the Statutes provided that no such Statutes shall be either repugnant to the provisions of this Our Charter or shall have effect until approved by the Lords of Our Most Honourable Privy Council. In this Our Charter "Statutes" mean the Statutes set forth in the Schedule hereto and any Statutes amending, adding to or repealing the same.

18. Following consultation with the Senate, the Court may by a simple majority amend, add to or repeal the Ordinances and Regulations provided that no such Ordinances or Regulations shall be repugnant to the provisions of the Charter or the Statutes. The Court may delegate the power to make Regulations to any committee of the University.

**Interpretation**

19. Our Royal Will and Pleasure is that this Our Charter shall ever be construed benevolently, and in every case most favourably to the University and the promotion of the objects of this Our Charter.”

ALTERATIONS TO THE CHARTER OF THE ROYAL AFRICAN SOCIETY

1. For Article 8(a) *substitute*: "There shall be a Royal Patron of the Society. We do hereby reserve to Ourselves to be the first Royal Patron. The Royal Patron in succession to Ourselves shall be such member of the Royal Family as may accept that office at the request of the Council of the Society."
2. For Article 8(b) *substitute*: "There shall also be Patrons of the Society who will be such persons as may accept that office at the request of the Council of the Society."
3. *Delete* Article 10(a) and 10(b) and *substitute*: "10. There shall be a Chair of the Society, not more than three Vice-Chairs of the Society, an Honorary Treasurer, and a Secretary, and they shall be elected or appointed as prescribed in the Bye-laws."
4. *Delete* Article 11(a), 11(b), and 11(c) and *substitute*: "11. There shall be an Executive Committee of the Council (hereinafter referred to as "the Executive Committee"), which shall conduct the administration of the affairs and property of the Society subject to such directions as the Council may give from time to time, and which shall be constituted in accordance with the provisions of the Bye-laws."

5. For Article 12(b) *substitute*: "Repeals and amendments of, and additions to, the Bye-laws of the Society shall be made by Special Resolution in accordance with the said Bye-laws."

WHEREAS by section 3 of the Naval and Marine Pay and Pensions Act 1865(a), it is enacted that all pensions payable in respect of service in Her Majesty's Naval or Marine Forces to a person being or having been a Seaman or Marine therein, shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

AND whereas it is expedient to provide for the increase of certain pensions granted to Maltese Naval Locally Engaged Personnel to correspond with the benefits provided, in the case of civil pensions, by the Pensions (Increase) Act 1971(b), as amended by the Superannuation Act 1972(c):

NOW, therefore, Her Majesty, in exercise of the powers conferred upon Her by the said Act of 1865 and all other powers enabling Her in that behalf, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

1. This Order may be cited as the Naval and Marine Pay and Pensions (Maltese Naval Locally Engaged Ratings' Service Pensions Increase) Order 2010.
2. Pensions granted in respect of service given by Maltese Locally Engaged Personnel shall be increased in accordance with paragraph 2 of the Schedule to this Order, subject to the provisions of paragraph 1 of the Schedule.

## SCHEDULE

### PENSION INCREASES

1. A pension to which this Schedule relates may be increased provided either that:
  - (a) the pensioner has attained the age of 55 years, or
  - (b) the pension is a widow's pension, or
  - (c) the pensioner was invalided from Naval Service, or
  - (d) the pensioner is permanently incapacitated by physical or mental infirmity from engaging in regular full-time employment and provided that the pensioner, or, in the case of a widow's pension, her husband, was discharged from Naval service after July 1973.
2. The appropriate percentage increase for those currently entitled to receive Pension Increases shall be as follows:-

1.52 per cent from 1st August 2010

The Secretary of State for Justice, after giving ten days' notice of his intention to do so, has, under the Burial Act 1853 as amended, made representation to Her Majesty in Council that, subject to the exception below, burials should be discontinued in Dresden Churchyard, Church of the Resurrection, Dresden, City of Stoke-on-Trent.

The exception is that in any existing earthen grave in the churchyard, the burial may be allowed of the body of any member of the family of the person or persons previously buried in that grave, but no part of the coffin containing the body shall be at a depth less than one metre below the level of the surface of the ground adjoining the grave.

Her Majesty in Council is pleased to give Notice of this representation and to order that it be taken into consideration by a Committee of the Privy Council on 22nd December 2010.

And Her Majesty is further pleased to direct that this Order should be published in the London Gazette, and that copies of it should be fixed on the doors of the Churches or Chapels of the above mentioned place, or displayed conspicuously inside them, for one month before 22nd December 2010.
