Your affiant - can truly state that:

1. Affiant is a member of the Delaware State Police and has been employed by the Delaware State Police since January of 1990. Affiant is currently assigned to the Major Crimes Unit, located at DSP T-4 in Georgetown, DE, Sussex County Delaware. Affiant has been assigned to the unit since September of 2003.
2. The following information was obtained through a Children's Advocacy Center interview with a 29 year old female victim. Additional information was obtained from the victim's parents in an interview which was conducted at the conclusion of the CAC interview. The interview occurred on WE 12/09/09 and was conducted by Forensic Interviewer
3. On MO 12/07/09, victim was present in the office of Pediatrician Dr. Earl Bradley. The purpose of the visit was the victim was having a burning sensation while urinating. The victim suffers from labial adhesions and has had the condition since birth. One of the side effects of the condition is a burning sensation when urinating; however the victim has never experienced that particular side effect.
4. Dr. Bradley examined the victim with the mother present in the room. While examining the vaginal area of the victim, the victim never complained of or expressed any indication of pain. At the conclusion of the interview, Dr. Bradley carried the victim out of the examination room. The mother stayed behind in the examination room. The mother advised she stayed behind because she trusted Dr. Bradley with her child because of his position as a doctor. Dr. Bradley removed the victim to the basement of the office, where a toy room is located. It is Dr. Bradley's practice to take patients to this room to allow them to get candy or a toy after they have an examination completed.
5. Dr. Bradley and the victim were gone for approximately two minutes and returned to the examination room. The two remained in the room for several minutes and Dr. Bradley took the victim back down to the basement. Victim's mother stated they were gone for approximately two minutes and they returned. When they returned the victim had candy.
6. The victim and mother left the office and ate lunch. While on the way home from eating lunch, victim advised her mother that Dr. Bradley had hurt her Heiney (victim's word for vagina). Mother stated that Dr. Bradley had looked at her heiney in the exam room. Mother stated victim became vry upset and again the victim stated that Dr. Bradley had touched her heiney in the basement and it hurt.
7. Mother calls father and advises him of what victim had told her. Father then tells mother that he took victim to Dr. Bradley's office on 10/28/09 for a flu shot. Victim was given her shots and at the conclusion of the shots the victim was carried from the room by Dr. Bradley and taken to the basement. He advised they were gone for several minutes. He advised when the victim returned to the examination room being carried by Dr. Bradley, he

and victim left the office. Father stated while driving home victim told him that Dr. Bradley had touched her heiney. Father stated victim told him that this happened in the basement.

8. During the interview with Forensic Interviewer . . . , victim stated Dr. Bradley hurt her heiney. She also confirmed this with the use of an anatomical doll. She stated he hurt her heiney in the basement.

9. At the conclusion of the interview, Pediatric Nurse Practitioner . . . conducted an examination of the victim. . . contacted the affiant at the conclusion of the interview and advised there was a raw and tender area the size of a tip of a finger located on the labia minora at the posterior aspect. . . advised this can be consistent with something being inserted into the vagina.
