Introduction:

- 1. On 27 November 2006, Trump International Golf Links Scotland ("the applicants") submitted an application for outline planning permission for 'a golf course and resort development' on land at Menie House, Balmedie, Aberdeen ("the application¹"). The application was registered by the Aberdeenshire Council ("the planning authority") on 27 November 2006. The decisions taken by the planning authority in relation to the application are explained in their Statement of Case.
- 2. On 4 December 2007, the application was called in for determination by the Scottish Ministers.² This Statement has been prepared for the purposes of the public local inquiry called by the Scottish Ministers to consider the application.

Scope of the Application:

- 3. The application seeks outline planning permission for the development of:
 - (i) 2 x 18 hole links golf courses on Menie Links, Pettens Links and Blairton Links;
 - (ii) a golf clubhouse;
 - (iii) a golf academy;
 - (iv) a golf maintenance building and caddy shack;
 - (v) a short game area and driving range;
 - (vi) a 450 unit resort hotel;
 - (vii) a conference centre and spa;
 - (viii) 36 golf villas;
 - (ix) 950 holiday homes in four blocks;
 - (x) accommodation for 400 staff;

(xi) parking areas and access roads; and

(xii) 500 private residential houses.

4. The applicants had submitted an application for detailed planning permission for the

construction and formation of the golf course.³ The drawing showing the proposed

layout of the golf course for the purposes of the detailed application was also

submitted with the application for indicative purposes. However, the detailed application was withdrawn on 17 April 2008⁴ because the design and layout of the

proposed golf course has evolved, as shown on the drawing⁵ which was circulated to

proposed gon course has evolved, as shown on the drawing which was circulated to

Relevant Parties on 17 April 2008. This revised layout is the current indicative layout

of the proposed golf course and, for the avoidance of doubt, represents the

applicants' preferred method of mitigation.6

5. A further application for the detailed planning permission for the construction of the

golf maintenance building was submitted to the planning authority on 27 November

2006.⁷ This detailed application remains with the planning authority for determination

following the decision of the Scottish Ministers on the application.

The Development Plan:

6. The decision of the Scottish Ministers will be made in accordance with Section 25 of

the 1997 Act.8 This means that the determination will be made in accordance with

the relevant policies of the development plan unless material considerations indicate

otherwise.

- 7. A purely descriptive statement of planning policies is being prepared covering the statutory development plan and material considerations of government and local planning policies which have relevance to the development. The development plan comprises the Aberdeen and Aberdeenshire Structure Plan 2001-2016 ("NEST") approved by Scottish Ministers on 21 December 2001 and the Aberdeenshire Local Plan adopted on 30 June 2006 by Aberdeenshire Council. Material considerations include the emerging replacement for NEST which is being prepared by Aberdeenshire and Aberdeen City Councils on the basis of the guidance so far available from the Scottish Government on the format of the new strategic development plan for the Aberdeen city region as will be required once the relevant provisions of the Planning Etc (Scotland) Act 2006 come into force. Clarification of the status of this emerging plan is being obtained. Government policies which are considered to be material considerations include the National Planning Framework and a number of the Scottish Planning Policies/National Planning Guidelines (SPP/NPPG) series. The list of planning policies is being drawn up with regard to those listed in the Environmental Statement and in the report on the application by officers to the planning authority. It has already been the subject of discussion with the planning authority and it is the applicants' intention to seek prior agreement to this list of planning policies with Aberdeenshire Council and other relevant parties if possible.
- 8. The applicants' position is that, although the development draws some support from relevant policies within the development plan and from relevant national policy, it is a significant departure from the current Structure Plan and the Aberdeenshire Local Plan 2006.

Other Material Considerations:

9. Notwithstanding the acknowledged development plan departure, the applicants' position is that other material considerations justify approval of the application. The applicants' concur with the conclusion reached by the Head of Development Management and Building Standards in her report to committee⁹:

"There is no doubt that the proposal does conflict with many heritage designations but taking all of these landscape, natural, built and cultural heritage considerations together, along with other relevant matters, it is considered that these are not

compromised to such an unacceptable degree as to justify refusing the application. The view of Development Management, in line with Government guidance, is that this is an occasion where the social and economic benefits are of national importance and that these do override the adverse environmental impacts."

Agreed Statements:

- 10. Following the Reporters' request for parties to reach agreement on matters of fact wherever possible¹⁰, the applicants' consultants have held discussions with
 - Scottish Natural Heritage;
 - RSPB/SWT;
 - Transport Scotland;
 - · Aberdeenshire Council; and
 - SEPA
- 11. However, notwithstanding those discussions, it has not been possible to conclude any Agreed Statements in advance of 5 May. The applicants hope to reach agreement on the following matters before 12 May:
 - a) development plan policy;
 - b) national planning policy
 - c) housing land supply;
 - d) traffic generation figures
- 12. Discussions are ongoing with SNH, RSPB/SWT, SEPA and Transport Scotland. It is hoped that matters relating to SEPA and Transport Scotland will be addressed by written submissions on 21 May 2008, in accordance with the Note of the Pre Inquiry meeting. It is also hoped that some basis of agreement will be reached with SNH and RSPB/SWT before 21 May 2008.

Evidence to be led at the inquiry:

13. The applicants will address the following matters in their oral evidence to the inquiry:

(i) The Proposal:

- a) The applicants' track record in the US golf industry, including their environmental credentials, and their vision for a world class golf resort on the Menie Estate;
- b) The applicants' understanding of the environmental issues and their commitment to appropriate mitigation measures including the establishment and support of MEMAG (Menie Environmental Management Advisory Group);
- c) The need to cross-fund the golf resort from the residential development;
- d) An explanation of the design philosophy for the championship golf course and how its layout has evolved;
- e) An explanation of why the golf course cannot be relocated to avoid the SSSI;
- f) The widespread support of both the business community and the public to the north east of Scotland

(ii) Economic and Financial Benefits:

- a) An economic impact assessment has been undertaken by the Fraser of Allander Institute. This assessment will consider the total economic effects of the development, including any additional spin off benefits. This assessment of economic effects will include both the employment and gross value added of both the construction and operational aspects of the development;
- b) Clarification of the assumptions used for the economic impact assessment:
- c) The key capital operating and revenue costs;

- d) The annual cash spend arising from capital expenditure and operations;
- e) The Return On Investment (ROI) with housing and without housing;
- f) The justification and need for cross funding to make this an acceptable investment;
- g) The contribution of the development to diversifying the economy

(iii) Environmental Impacts and their Mitigation

The evidence will consider the general nature of the land, the SSSI and the surrounding area.

Geomorphology:

- a) The proposed golf course development will occupy the sand dune system at Menie Links; the northern part of which is an SSSI and the southern part an area of local geomorphological interest. The main reason for designation as an extension to the original Foveran SSSI is the scientific importance of the dune landforms and their formative processes. The applicants' geomorphological witness will demonstrate that the layout of the golf course will have a range of impacts on these geomorphological features and for many areas this is considered to be severe. To date several iterations have been made with the golf course architect taking into account expert advice on how some adverse impacts might be reduced without compromising the general design of the course and its supporting facilities. The witness will demonstrate that large parts of the interior dune topography will be unaltered and that the coastal dune and beach-dune interface zone will not be used as part of the golf course.
- b) Some areas of rapid change will be stabilised and the witness will demonstrate that this procedure will have consequential negative effects on both landforms and processes, including contiguous areas. The witness will demonstrate that the most recent course layout avoids some dynamic dune landforms and other areas, but that the course layout necessitates the stabilisation of one of the most important features – the sand dome.
- c) The witness will report on the impacts on the area south of the SSSI which is of substantially less geomorphological interest, mainly consisting of stable, mature

dune landforms. Nevertheless, the same provision of protection applies to the beach-dune interface and the coastal dune ridge. Reference will also by made to details of impacts and mitigation provisions on the remainder of the south area, as reported in the Environmental Impact Assessment and Appendices.

- d) The witness will outline the proposal to establish the Menie Environmental Management Advisory Group (MEMAG) as an independent advisory group designed to provide advice on:
 - 1 'best practice' environmental management and operation;
 - 2 monitoring of environment including ecology;
 - 3 the minimisation of unanticipated adverse changes in addition to those already recognised in the main Environmental Impact Assessment; and
 - 4 full compliance with the relevant conditions attached to the outline and detailed planning permissions for the development.

Habitat:

- a) The applicants' ecological witness will address the development site's habitats, flora, fungi and lichens, including the accuracy of site information, its importance in assessing site biodiversity and nature conservation interest, and its use in estimating the direct and indirect effects of the proposed development, particularly within the Foveran Links SSSI.
- b) The witness will address current estimates of the direct and indirect effects of the development, particularly within the Foveran Links SSSI, including revised data for a new Hawtree championship course layout. The witness will also review the potential for a further reduction of golf course impacts, including liaison with the course designers and more detailed site-specific proposals for mitigation. The mitigation measures will include reference to environmental benefits for the application site, including the Foveran Links SSSI.
- c) The witness will provide an overview of the short to long-term impacts of the development on site habitats and species of flora, fungi and lichens, particularly within the Foveran Links SSSI, set in a local, regional and Scottish context. This will show that the balance between habitats present on site will change significantly. However, the witness will demonstrate that key habitats and species populations will be retained, managed and enhanced in viable quantities in a manner which reflect existing habitat zonations and successional processes.

Ornithology and Species:

a) The applicants' ornithological and biological witness will address baseline conditions, the evaluation of baseline conditions and the assessment of environmental effects on the development site's bird and protected species populations and other biological interests. The witness will demonstrate that key receptor species mitigation will be specified as part of the proposed Environmental Management Plan. The witness will provide an overview of the potential for mitigation of residual adverse effects and medium to long-term positive enhancement of the development site's ornithological and biological interest. The witness will also identify additional opportunities for environmental enhancement for other species.

General:

The applicant may lead general evidence as to the designation and nature of the SSSI and its own component parts and of the surrounding area.

Legal Representation:

14. Mr Colin Boyd QC will appear at the inquiry on behalf of the applicants. Mr Boyd will be instructed by Ann Faulds, Partner, Dundas and Wilson CS LLP.

Witnesses:

15. The following witnesses will give evidence to the inquiry on behalf of the applicants:

1) Mr Donald J Trump, Trump International Golf Links Scotland

Mr Trump will speak to the proposal as outlined in paragraph 13 (1) a), b) and c);

2) Dr Martin Hawtree, Golf Course Architect

Dr Hawtree will explain the design philosophy of the championship golf course and why it cannot be relocated off the SSSI;

3) Mr Stewart Dunlop, Fraser of Allander Institute

Mr Dunlop will explain his economic analysis as outlined in paragraph 13 (ii) a) and b) above.

4) Mr Iain Webster, Johnston Carmichael, Chartered Accountants

Mr Webster will explain the capital expenditure costs, phasing, income expenditure and return on investment, including the requirement for cross funding as outlined in paragraph 13 (ii) c), d), e) and f) above.

5) Mr Jim McArthur, Hardies, Property and Construction Consultants

If required, Mr McArthur will explain certain costs in relation to the Financial Report and Analysis, May 2008, prepared by Johnston Carmichael

6) Mr William Ritchie, Independent Coastal Geomorphologist

Professor Ritchie will speak to matters of geomorphology as outlined in paragraph 13 above.

7) Dr Tom Dargie, Boreas Environmental Consultancy

Dr Dargie will address matters of habitat as outline in paragraph 13 above.

8) Mr David Bell, ECOS Countryside Services

Mr Bell will address ornithology and species as outlined in paragraph 13 above

9) Mr James Miller, Ironside Farrer - see paragraph 17 below

The applicants reserve the right to add to the evidence in response to the statement of case of other relevant parties.

Evidence to be addressed in written submissions:

- 17. The following matters will be addressed in written submissions:
 - a) National and development planning policy and advice. See paragraph 7 above. It is hoped that an Agreed Statement will be prepared and circulated no later than 12 May, which statement will form the basis of the written submission on behalf of the applicants.
 - b) The lack of adverse effect on the SPA; A written submission will be prepared which will take the form of a Non Technical Summary of the Appropriate Assessment which has been prepared by TIGLS in consultation on SNH of the effects of the proposed golf resort development on the Ythan Estuary, Sands of Forvie and Meikle Loch Special Protection Area (SPA). The written submission will address the assessment of effects on Pink Footed Geese and potential disturbance to species, and will conclude that there would be no adverse effect on site integrity.
 - c) Transport and traffic issues; It is hoped that an Agreed Statement will be reached with the relevant roads authorities' and circulated no later than 12 May, which statement will form the basis of the written submission on behalf of the applicants.
 - d) The proposed Access Strategy; The Applicants' intend to address this issue by way of a written submission which summarises the Environmental Statement Chapter 13: Recreation and Community Effects and Appendix 1 and the Public Access Plan contained in the July 2007 Response to Aberdeenshire Council and Statutory Consultees. The written submission will conclude with a statement that TIGLS will accept the imposition of a planning condition requiring the preparation of an Access Strategy for approval by Aberdeenshire Council, in consultation with relevant special interest groups including the Ramblers Association and the Belhelvie Community Council. The Applicants, however, reserve the right to call Mr James Miller to present oral evidence if considered necessary having had sight of the

statements of case of Relevant Persons, or if the Reporter would prefer to have oral evidence from the applicants.

Conditions and Reserved Matters:

18. The applicants have reviewed the list of proposed conditions produced by the planning authority. It is understood that those conditions reflect the decisions taken by the planning authority during 2007. Whilst accepting the obligations proposed by the planning authority, the applicants would like the opportunity to undertake a legal audit of the proposed conditions in consultation with the Council's legal advisers. Moreover, it is assumed that other Relevant Parties might wish to suggest conditions and the applicants reserve the right to comment on those conditions when they are in the public domain.

In particular, the applicants confirm their acceptance of the reserved matters listed by the planning authority in condition 3 of their list of proposed conditions.

Section 75 Agreement:

- 19. The applicants confirm their willingness to enter into a Section 75 agreement to cover matters including:
 - a contribution to affordable housing;
 - · a contribution to education facilities;
 - a contribution to community facilities;
 - off site road improvements;
 - establishment and operation of MEMAG;
 - local training programme;
 - local staff recruitment programme
