224 Children in 12 Udayan Ghars in the Ghar Programme identify themselves with the rest of the society in which they live and dare to dream big. Over 4725 youth, women and children overcome the skills and digital divide through the vocational and information technology trainings. 500 volunteers worldwide have joined to support the cause of Udayan Care.

The last three years have seen considerable rise in the investment directly proportional to the expansions that took place in Udayan Care. In 2006-07, the total amount invested in the programmes amounted to over 1.45 crores. With the expansions speeding up, the annual investment for 2007-08 was 2.02 crores. In 2008-09, the investment amounted to 2.61 crores.

Ltd.

Geriatric Society of India honored him in the year 2000 for selfless service and love for the suffering community in India. Ministry of Social Justice & Empowerment, Government of India awarded Chirayshya Samman for his exemplary contribution in public life and being a pioneer in building HelpAge India. He was given the Lifetime Achievement Award at the International Conference on Geriatrics and Gerontology in 2004. He was nominated Member National Council for Older persons by Ministry of Social Justice & Empowerment in 2005. He was conferred "Padma Shri" by the President of India in 2008.
