# Our Ruth wins the Premier's Book Award History prize

Congratulations to History Council Committee member, Ruth Marchant James for being awarded the 2007 Premier's Book Award in the Western Australian History category for *Cottesloe: a town of distinction* published by the Town of Cottesloe.


Ruth is one of our leading historians and the judges citation for this superb local history praised Ruth's knowledge and skill.

"An expansion of her earlier book, Heritage of the pines (1977) which concluded at World War II, this volume begins with the period of the 'first inhabitants' and early European settlement and brings the story to the present day. It includes extensive new research and interviews, and previously unseen photographs. It combines big picture issues with the minutiae of everyday life, and ranges across everything from geology to social history, from education to business, from religion to beach culture. Though focussed on one area of Perth's coastal strip, it also offers some broader reflections about life in Perth. The book is well designed, its large format lending itself to the attractive use of photographs. The referencing procedures are excellent, with useful appendices and a comprehensive bibliography. The writing is readable and attractive. In all, the author shows her knack for a thorough mining of the past for the information and entertainment of the present."

# A Library under Threat - The Battye Library Users' Survey

Following a significant restructure within the State Library in 2006 History Council members and affiliated bodies became concerned about changes to the structure and services provided by the J S Battye Library of West Australian History, and how they are impacting on the historical research culture of Western Australia.

A survey was designed by a group representing a broad range of history organisations and was supported by the State Library. The survey was issued in March and April 2008, through the mailing lists of the History Council and affiliated bodies and at the State Library. There were 93 responses, 89% of which were from those who identified themselves as long term (more than two years) users of the Battye. The results were collated by the History Council in May 2008, and a qualitative analysis was completed by the State Library in August. A quantitative analysis was then undertaken through Curtin University and the results were received in early October.

The results clearly identify a number of areas of concern, particularly with respect to staff and staffing and access to resources and facilities. It was very clear that there is a strong positive feeling and loyal support for the Battye Library and its staff. However, 49% of the respondents who used the Battye Service desk were less than satisfied with the service they received. Forty per cent of those who responded to questioning on the retrieval service were not satisfied with the service they had received. Results indicate that although staff members are very willing to help, they lack knowledge or are inexperienced. The use of general reference staff rather than collections specialists lies at the heart of this problem.

Severe frustrations with the lack of work space, lack of access to catalogue terminals, noise from non Battye users and the condition of equipment were all clearly expressed by respondents to the Survey. This deteriorating research culture is also linked to concern for the collections, with 51% of respondents not satisfied with the security of the collection.

The History Council and our affiliated organisations represent historians and researchers deeply concerned about Western Australia's history and aware of how crucial the Battye Library is to the understanding of our past. The survey results are an important tool for our organisations and provide a compelling call for us to work with the State Library to ensure that the JS Battye Library of West Australian History remains the premier research library as well as the State's major private archive, ephemera, film and oral history repository.

The publicly stated aim of the State Library's restructure was that it would bring greater levels of resourcing to the Battye Library as well as a range of positive outcomes. The results of the survey and the experience of Western Australian researchers shows clearly that this aim has not been realised and that the situation is now critical.

We urge members to contact the History Council should you require more details of the Survey or have additional comments to offer. In the meantime we will be asking for meetings with the State Librarian and the Library Board to discuss this unsatisfactory situation.

# Centre for WA History: Jean Chetkovich's presentation at the State Records Office

On Tuesday 18 November our Society's current councillor (and former Vice-President) Jean Chetkovich enthusiastically discussed the founding, achievements and future plans of the UWA-based Centre for WA History. Dr Chetkovich is the present director at CWAH (A part-time role), and her comprehensive talk thoroughly indicated the usefulness of the centre in capturing and preserving Western Australia's past.

CWAH has operated for 23 years, with its opening in 1985 representing the culmination of an idea in the state's sesquicentenary. Many publications had been released in that year (1979), and some prominent WA historians (especially Brian de Garis and Tom Stannage) were concerned at the variation in quality. Hence they decided to establish the centre to encourage research and writing to the highest standards. The centre produces books (27 so far), oral histories, reports, films and handles queries e.g. From radio stations such as ABC and 6PR. But predominantly, it organises commissioned histories.

Jean listed the features of a commissioned history, advising it should be factual, interesting, academically sound, benefiting its own field e.g. Health sector <u>and</u> also the field of WA history, and lastly not sanitised – nothing "swept under the carpet"; all "skeletons in the closet" to be acknowledged (otherwise it would not ring true).

Some examples of work recently undertaken include histories of the RSPCA, Town of Victoria Park and the Welsh Free Church. This last client intrigued the audience, most of whom were unaware it functioned in WA. Jean herself was involved with this project, and advised the religion came to our state in 1904, and a congregation still holds a monthly service in Trinity Church.

She spoke of the ever-increasing level of interest in WA history and noted the personalities of office bearers affected the public, with the keenness of current Governor Dr Ken Michael further driving the demand for CWAH services. Jean indicated excitement is building about the June 2009 release of the encyclopaedia of WA history, which has been 7 years in the making and has had over 400 contributors.

The audience's questions mainly focussed on the suggested charges for commissioned histories: Jean explained they tried to balance a fair fee for the historian with the client's budget, and a ballpark figure of \$80-90 000 for a year's work was given.

Jean and all those involved in the centre urge stronger links amongst the history community (including with the History Council of WA), and to this end offer many ideas, such as post-grad student research and networking nights.

This was the last in the 2008 series of lunchtime seminars. The program is likely to recommence in February 2009, with talks occurring monthly.

## 'European online library crashes'

A new digital library launched by the European Union has crashed within hours of opening – forcing its closure.

## History in the Pub

The History Council of Western Australia hosted another successful 'History in the Pub' session at the Hyde Park Hotel on Friday 17 October 2008.

The topic for the evening was *Finding HMAS Sydney*, a personal perspective and the speaker was Wes Olsen, author of *Bitter Victory: the death of HMAS Sydney*. Wes spoke engagingly about his long held interest in the fate of the *Sydney* and his role in the discovery of its wreck off the Western Australian coast earlier this year.

The cruiser, HMAS *Sydney*, was sunk by the German battleship the *Kormoran* and, tragically, all 645 of the *Sydney*'s crew were to lose their lives in the encounter. The actual site of the sunken ship had been under contention for over 60 years with a number of conflicting theories as to its whereabouts.

The *Kormoran* was also sunk during the battle but survivors of the German ship were not believed when they provided information as to the place where the ships went down. A Government grant allowed renowned wreck finder, David Mearns, to be brought to Australia and assisted by Wes and other researchers such as Glenys McDonald, herself an author of a book on the sinking of the Sydney, Mearns pinpointed the site. A major aid in unlocking the secret was the discovery of a code contained in a dictionary owned by the German Captain of the *Kormoran*.

A special guest at the event was Tom, a former sailor who was on the Sydney until three weeks before it was sunk.

A lively question time followed Wes's talk and it was clear that the fascinating story of the detective work involved in finding the remains of one of Australia's greatest disasters, as well as the poignancy of the subject touched many of us in the audience.

#### **Geoffrey Bolton Lecture 2008**

The 2008 Lecture, named in honour of Emeritus Professor Geoffrey Bolton AO, was presented by retiring Justice Michael Kirby AC on 20 October 2008 in the Government House Ballroom.

Kirby titled his address *Is Legal History now Ancient History*? and called passionately, and persuasively, for the reinvigoration of history, specifically legal history, teaching in Australia's law schools.

Justice Kirby recalled how his own career might have taken a very different path if he had pursued an early interest in Ancient History, instead of switching to study Law. He spoke about his continuing fascination with history which was nurtured by compulsory units in legal history at the Sydney Law School during his time there.

By the 1980s, however, the study of history had "virtually disappeared from most of the Australian law courses". Justice Kirby cited the example that out of 31 law schools now operating in Australia, only eleven institutions offered a course in history. Most of these were electives which few students chose and only four universities, Australian National University, University of Technology Sydney, Murdoch and Notre Dame, included the study of history in its mainstream courses.

In Kirby's view, our legal system is a product of history and without an understanding of the context in which legislation has been framed, "the narrative of liberty" as he put it, lawyers risk making mistakes.

In concluding his address, Kirby argued that we need to "*rekindle the teaching of legal history in Australia. The decline and fall has gone far enough.*"

Judging by the buzz of conversation afterwards, the evening was hugely enjoyable. Congratulations to State Records Office staff for all their hard work to ensure that event was a great success.
