## RESOLUTION

Condemning the murder of Turkish-Armenian journalist and human rights advocate Hrant Dink and urging the people of Turkey to honor his legacy of tolerance.

Whereas ~~Hrant Dink was a respected, eloquent advocate for press freedom, human rights, and reconciliation;~~

Whereas, ~~in 1996, Mr. Dink founded the weekly bilingual newspaper Agos and, as the paper's editor in chief, used~~

the paper to provide a voice for Turkey's Armenian community;

Whereas Mr. Dink was a strong proponent of rapprochement between Turks and Armenians and worked diligently to improve relations between those communities;

Whereas Mr. Dink's commitment to democratic values, non-violence, and freedom in the media earned him widespread recognition and numerous international awards;

Whereas Mr. Dink was prosecuted under Article 301 of the Turkish Penal Code for speaking about the Armenian Genocide;

Whereas, notwithstanding hundreds of threats to Mr. Dink's life and safety, he remained a steadfast proponent of pluralism and tolerance;

Whereas Mr. Dink was assassinated outside the offices of Agos in Istanbul, Turkey, on January 19, 2007;

Whereas tens of thousands of people in Turkey of many ethnicities protested Mr. Dink's killing and took to the streets throughout the country to honor his memory;

Whereas the Government of Turkey has pledged to undertake a full investigation into the murder of Mr. Dink;

Whereas the Prime Minister of Turkey, Recep Tayyip Erdogan, has stated that when Mr. Dink was shot, "a bullet was fired at freedom of thought and democratic life in Turkey";

Whereas the Foreign Minister of Armenia, Vartan Oskanian, stated that Mr. Dink "lived his life in the belief that there can be understanding, dialogue and peace amongst peoples"; and

Whereas Mr. Dink's tragic death affirmed the importance of promoting the values that he championed in life: Now, therefore, be it

*Whereas Mr. Dink was assassinated outside the offices of Agos in Istanbul, Turkey, on January 19, 2007;*

*Whereas tens of thousands of people in Turkey of many ethnicities protested Mr. Dink's killing and took to the streets throughout the country to honor his memory;*

*Whereas the Government of Turkey has pledged to undertake a full investigation into the murder of Mr. Dink;*

*Whereas the Prime Minister of Turkey, Recep Tayyip Erdogan, has stated that when Mr. Dink was shot, "a bul-*

*Resolved, That the Senate—*

1           (1) condemns the murder of Hrant Dink as a  
2           shameful act of cowardice perpetrated with contempt  
3           for law, justice, and decency;

4           (2) supports the pledge of the Government of  
5           Turkey to conduct an exhaustive investigation into  
6           the assassination of Mr. Dink and to prosecute those  
7           responsible;

8           (3) urges the Government of Turkey to repeal  
9           Article 301 of the Turkish Penal Code and work  
10          diligently to foster a more open intellectual environ-  
11          ment in the country that is conducive to the free ex-  
12          change of ideas;

13          (4) recognizes the decision of the Government  
14          of Turkey to invite senior Armenian religious and  
15          political figures to participate in memorial services  
16          for Mr. Dink;

1           (5) calls on the Government of Turkey to act in  
2           the interest of regional security and prosperity and  
3           reestablish full diplomatic, political, and economic  
4           relations with the Government of Armenia; and

5           (6) urges the people of Turkey to honor Mr.  
6           Dink's legacy of tolerance.

7           *That the Senate—*

8           (1) *condemns the murder of Hrant Dink, which*  
9           *was perpetrated with contempt for law, justice, and*  
10          *decency;*

11          (2) *supports the pledge of the Government of*  
12          *Turkey to conduct an exhaustive investigation into*  
13          *the assassination of Mr. Dink and acknowledges the*  
14          *prompt arrest of individuals allegedly responsible for*  
15          *the killing;*

16          (3) *urges the Government of Turkey to repeal Ar-*  
17          *ticle 301 of the Turkish Penal Code and work dili-*  
18          *gently to foster a more open intellectual environment*  
19          *in the country that is conducive to the free exchange*  
20          *of ideas;*

21          (4) *recognizes the decision of the Government of*  
22          *Turkey to invite senior Armenian religious and polit-*  
23          *ical figures to participate in memorial services for*  
24          *Mr. Dink;*

1           (5) *calls on the Government of Turkey and the*  
2           *Government of Armenia to act in the interest of re-*  
3           *gional security and prosperity and reestablish full*  
4           *diplomatic, political, and economic relations;*

5           (6) *supports Mr. Dink's wish that Turkey pursue*  
6           *further integration into Euro-Atlantic institutions*  
7           *and encourages the Government of Turkey to enact re-*  
8           *forms conducive to such ends; and*

9           (7) *urges the people of Turkey to honor Mr.*  
10          *Dink's legacy of tolerance.*
