Bruce McComish Prize

Congratulations to William Coleman and Selwyn Cornish from the School of Economics for having recently won the Bruce McComish Prize for their 2006 book *Giblin's Platoon: The Trials and Triumph of the Economist in Australian Public Life.*

This book tells the story of four men - L.F. Giblin, J.B. Brigden, D.B. Copland and Roland Wilson who, in the 1920s, formed a personal and intellectual bond that was to prove a pivot of economic thought, policy-making and institution-building in midcentury Australia. As economists they were to become key figures in the debates of the day, staking sometimes controversial positions on protectionism, central banking, industrial relations and federalism. As four men who really counted in Australian public life, they were decisive in the establishment of The Australian National University, the Commonwealth Grants Commission, and the modern form of the Australian Public Service and the Australian Bureau of Statistics.

The Bruce McComish Prize for Economic History was created in 2002 by businessman and author Bruce Sinclair McComish and is awarded each year for "the most original recent research in the field of economic history, undertaken within Australia or New Zealand." The judges of the 2007 prize described **Giblin's Platoon** as "a distinguished exercise in the history of economic thought that enriches the understanding of the transformation of the Australian economy." The prize is valued at \$5,000. Copies of the book are on sale in the Co-Op Bookshop for \$24.95.

Congratulations to Jeffrey Lai, Tamie Henderson (Statistics), Mai Hoang Do and Thomas Maher (Finance), four students from the School of Finance and Applied Statistics who were recipients of the University Medals for 2006.

Jeffrey Lai, who recently completed his Honours degree in Statistics shared the Tillyard Prize with one other ANU student. The Tillyard Prize is the oldest and most prestigious prize available to bachelor degree students of the University. Originally established in 1940, the prize is awarded to the student whose personal qualities and contribution to University life have been outstanding and who, in the year of the award, has completed a Degree of Bachelor with Honours. Jeffrey was also recently awarded a prestigious General Sir John Monash Scholarship to study overseas. **Well done Jeffrey!**
