576. EPS02: Light-emitting-diode lights

Report of Albert Lo, Property Asset Manager – 7/9/2010

As requested by Council at its meeting on 19/7/10, this report is prepared to provide Council with more information on the recently developed environmentally friendly light-emitting-diode (LED) lights.

Every time when we have a lighting project (either new work or refurbishment), we will look at different options and choose a best solution in terms of meeting the lighting output requirements, and minimal life cycle costing with good environmental outcomes. North Sydney Council in fact started to use LED lights back in 2007. The first applications were LED down lights in Council Chambers meeting rooms and LED high bay lights in the vehicle shop at Central Depot.

577. OSES01: Draft Plan of Management for Neighbourhood Parks

Report of Megan White, Landscape Planner – 11/08/10

North Sydney Council's Plans of Management are strategic documents that provide a consistent and usable set of guidelines for the effective short and long-term management of all open space owned or under the care, control and management of North Sydney Council. A new draft Plan of Management for Neighbourhood Parks has now been prepared in accordance with the Local Government Act 1993. This document supersedes Council's Neighbourhood Parks Plan of Management 2003.

The new draft Plan of Management for Neighbourhood Parks has been on public exhibition over the months of May and June 2010. In addition to being publicly advertised, hard copies of the draft document were distributed to all Precincts. The public submission period has now closed, and 3 written submissions have been received. This report documents the content of the public submissions and the alterations it is proposed to make as a result of the submissions.

The report also documents major works carried out in the Neighbourhood Parks since the preparation of the previous Neighbourhood Parks Plan of Management in 2003. It sets out the key features of the new draft Plan of Management and lists major projects to be undertaken in coming years.
