Integration with CCC was achieved in phases. Initially, Docutek included a button within the Docutek ERes user interface using RightsLink Basic*. This RightsLink Basic integration provides an open URL-based deep link from an application or web service directly to copyright.com.

In October 2005, Docutek enhanced the integration using Permissions Gateway. Permissions Gateway provides seamless, bi-directional access between Docutek ERes and CCC's rich rights licensing database through a set of application programming interfaces (API). This more robust integration enables Docutek ERes users to search, price and obtain copyright permissions — without ever leaving the Docutek ERes environment.

Samuels led the integration effort at Docutek. "The API offered through Permissions Gateway is powerful but not complex," he said. "We can confidently add new functionality to Docutek ERes without worrying about changes that CCC may make to its system."
