

USS IOWA SHIP STORE

The Des Moines reunion is behind us and we are left with many memories, most great, one not so. We celebrated getting together again but there was an emptiness hanging overhead. Our Executive Vice-President, "Whiskey" Bill Wysk was not with us. As most of you already know Bill suffered a stroke and passed away a few days before our reunion. I will miss working with him and getting the many phone calls through the year – usually discussing the same subjects time after time.

Although our reunion attendance was lower that we had hoped for sales in the Ship Store continue to surpass expectations. \$4755.00 has been deposited into the Store's account. Along with a Des Moines reunion T-shirt we introduced a new one. This T-shirt is printed with seven full color signal flags on the front of a light gray shirt, light blue for the kids. The flags spell out "USS Iowa." These shirts sell for \$14.50 or \$13.00 for the child size. Reunion pins will be available from the Ship Store until the minimal supply is depleted; price is \$8.00, packing and postage included. Registration coolers and money clips will also be available through the Ship Store while supplies last. Coolers are \$10.00, money clips \$9.00, and again, packing and postage is included.

This year several members have contacted me about an Iowa related item they have had made by a shop or craftsman in their region. A few have offered to buy the items for the Store with payment upon sale. I appreciate the initiative but in most cases we already carry a similar item, some slow movers. We are trying to reduce the inventory value and in most cases cannot justify picking up these unsolicited items. I hope you understand.

Boise, Idaho is our next stop and is less than a year away. It will be here before you know it. Start making plans and saving up for the trip. Hope to see you there.

ANNUAL REPORT OF THE PRESIDENT 2007-2008

Goals/Objectives:

(1) Provide for the continuation of the Association quarterly Newsletter.

(2) Plan, organize and facilitate the annual reunion.

(3) Continue operation of the USS IOWA Ship's Store.

(4) Continue the operation of the Association internet website www.ussiowa.org.

(5) Bring into our organization as many new members as possible, especially shipmates from the 80's crew.

(6) Stay abreast of the situation regarding final homeport of USS IOWA.

(7) Ensure that an appropriate USS IOWA museum is included at the memorial site and that all applicable records/memorabilia in our custody are properly identified and turned over to the museum curator.

(8) Provide for the maintenance of IOWA Point at the Naval Base, Norfolk, VA, and organize an annual ceremony to honor our shipmates, "The IOWA 47".

(9) Provide for appropriate recognition of selected honor students/graduates of Iowa State University Navy ROTC.

(10) Ensure that Treasurer's Funds and Ship's Store Accounts are audited annually.

(11) Ensure that a proposed budget for 2008-09 is submitted for approval at the crew's meeting in accordance with By-Laws.

(12) Maintain a record of all USS Iowa Veterans who pass on and ensure that they are remembered at annual ceremony and in the Taps section of Newsletter.

Accomplished/Completed:

REPORT FROM THE HISTORIAN'S DESK

During our recent reunion in Des Moines my wife, Debbie and I had the unique privilege of a privately guided tour of the State of Iowa Historical Building. Lucinda Martin, daughter of World War II gunnery officer, "Doc" Martin arranged the tour and escorted us to the Historical Society Building. We were met at the entrance by curator, Mr. Bill Johnson. I have had a working relationship with him since shortly after our Rapid City reunion but we had never met. Mr. Johnson and our Association entered into a contract to preserve, catalog and store our USS Iowa memorabilia until such time as our ship is pierside and her museum established.

Upon greeting us at the door, Mr. Johnson escorted us to the third floor and showed us the "Iowa Silver," the setting presented to the Navy for use on board USS Iowa (BB-4) in 1896 and subsequently used on board our ship. The silver was and amazing sight to behold and the animated stories told by Mr. Johnson kept our wide eyed attention. He also pointed out the wine caddy and display box which are on loan from the Wallace House Foundation of Des Moines.

At 10:36 a.m., on August 27, 1942, Mrs. Ilo (Brown) Wallace, wife of Vice-President Henry A. Wallace, spoke the words: "I christen thee Iowa. May God guard the Iowa and all who sail in her" as she swung a champagne bottle encased in the caddy against the ship's bow. This released our ship and she slid into New York's East River. Six months later USS Iowa was commissioned. According to Mr. Johnson

the bottle was encased in the metal caddy to allow the bottle to break safely without throwing glass pieces about. He told us that you can still hear glass when the caddy is shaken and champagne residue is still present on the caddy! The caddy and display box were presented to Mrs. Wallace after the christening ceremony.

After several more Iowa related stories, Mr. Johnson took us into the basement of the building where there was a myriad of objects with some historical relationship to the State of Iowa or her residents. We saw a gattling gun used by BB-4 U.S. Marines at the battle of Santiago, Cuba; a National winning Soap Box Derby Racer; early autos and TV cameras; a gasoline pump which posted a 17 6/10 cent price (we can only dream...); an iron lung and the carriage used by abolitionist John Brown! The basement is a museum unto itself and every item had a story Mr. Johnson was eager to tell us. We followed him into a side room in which was laid out items from a recent Civil War display and in a corner he pointed to a pile of boxes - our USS Iowa memorabilia – cataloged and preserved. He presented me with a note book which catalogs all our memorabilia. Our USS Iowa memorabilia will remain in the custody of the State of Iowa Historical Society until we establish our museum. I presented Mr. Johnson with more items that have been sent to me over the past year which will be added to the registry.

The tour was over much too soon but Mr. Johnson continued his "story telling" at our reunion dinner as our guest speaker. He kept everyone in awe as he related the history of the USS Iowas – the four ships that carried the proud name of a wonderful state. He took us from the Civil War era ship renamed Iowa through more than a century to the current Battleship Iowa with a knowledgeable and enthusiastic story. A wealth of Iowa information, Mr. Johnson is the right man in the right job and was a delight to listen to.

But still it would be beneficial for our membership to know the status of the Navy's decision to announce the final order to place the IOWA in the former Mare Island Naval ship yard, Vallejo CA.

From a practical stand point, it is important that we be given the opportunity to see what has been planned. We the Association must develop similar plans so that the committee can have the capability to share our thoughts and ideas with Historic Ships Memorial at Pacific Square (HSMPS). We have memorabilia which is recorded, catalogued and safely stored that should be integrated with HSMPS in a manner that reflects the working experiences/knowledge of our crewmembers who served on the IOWA.

What is currently known about the IOWA proposal is based on conversations with well informed individuals and media documentation that much work remains to obtain the necessary millions required to implement the project at Mare Island. The Veterans Association is optimistic that HSMPS will be awarded the IOWA so that all interested parties can proceed with the planning and work to convert the IOWA into a world class museum/memorial.

The mystery continues when the reverse side is examined showing part of a letter written in Philadelphia, PA by a member of his staff. Only part of the writers name and content of the message can be read which adds further mystery to the picture's origin and why it ended up where it did.

When you consider the events that follow, it appears that the destiny of the picture was in some mysterious way intended to be delivered to a crewmember of the IOWA where the picture now belongs as a treasured memorabilia for the IOWA museum/memorial. It happened during the days of Hurricane Katrina which reached land in the deep south many miles from Raleigh, NC where her winds were experienced

thing about this is that it landed where it was destined to finally end up in possession of someone who had indirect yet direct connection with someone who served aboard the USS Iowa, known to this day as President Roosevelt's ship... the connection of course turned out to be My daughme. ter recognized the value this incredible picture of the


