Former W&J Board of Trustees Member Dies at 81



W. Edward Sell '45, an alumnus and long-time friend of Washington & Jefferson College, died in his sleep on August 15, 2004, in his Mt. Lebanon home. He was 81 years old.

Sell, a native of Hanover, was a fixture at both W&J and the University of Pittsburgh School of Law. Sell graduated magna cum laude from W&J in 1945 with a bachelor's degree in economics and was later awarded an honorary doctorate by his alma mater. He earned his legal degree from Yale Law School in 1947. Sell was an active supporter of W&J and had served on both the board of trustees and the Alumni Pre-Law Advisory Committee. For the last 14 years, he was the chair and moderator of the W&J Homecoming pre-law lecture series, which has been renamed the W. Edward Sell Legal Lecture Series in his honor. W&J also has established a memorial fund in Sell's honor. Contributions to the fund will be used to establish the W. Edward Sell Pre-

Law Library, which will be located in Old Main. The Sell Pre-Law Library will serve those in the pre-law program by providing test preparation resources, law school application resources, research materials, and computer workstations.

Sell taught at the University of Pittsburgh School of Law for more than five decades. He served as distinguished service professor of law emeritus and law dean emeritus until the time of his death, often teaching a full course load. Sell taught in a broad range of legal areas, but specialized in corporate law. Many view him as the father of Pennsylvania business corporation law. He was considered to be the longest-serving faculty member at the University, joining the faculty in 1947. In honor of Dr. Sell's 50th year of teaching, a bust of him was placed in the entrance to the law school. He was also the recipient of 1986 Excellence in Teaching Award and the 1990 Chancellor's Distinguished Teaching Award from the University.

Besides his work with W&J and the Pitt Law School, Sell was very involved with his church, Southminster Presbyterian in Mt. Lebanon, and other community organizations. He served in various positions at organizations such as the St. Clair Memorial Hospital, the University Club, the Civil Service Commission of Mt. Lebanon, South Hills Child Guidance Center, the Pennsylvania Bar Institute, the Pennsylvania Bar Association, Citizens for a Mt. Lebanon Public Safety Center, the Supreme Court of Pennsylvania Historical Society, and Little Lake Theatre Company.

Sell is survived by his son, Dr. Jeffrey Sell of Baltimore, Maryland, and his three grandchildren, Peggy, Jeffrey, and Bridget. Shortly before his death, Sell became engaged to Dr. Doreen Boyce, president of the Buhl Foundation.
