# School of Medicine to Offer Post-Master's Certificate Programs in Therapy

In an effort to meet local communities' needs in a newly-merging field, Mercer University's School of Medicine will offer post-master's certificate programs in Medical Family Therapy and Pediatric Family Therapy beginning in January. These certificate programs, each of which can be completed in one year and offer courses primarily in late afternoon and evening, are designed to prepare clinicians to practice in specialty areas of family therapy.

According to Assistant Professor Matthew Orr, Ph.D, the Medical Family Therapy program is focused on learning to help individuals and their families adjust to issues of death and dying and manage life with chronic illness. It addresses the psychosocial aspects of health care for individuals, couples and families living with acute and chronic medical problems. Thanks to the Georgia Cancer Coalition, which has awarded financial support for the start-up of this program, special attention will be paid to central Georgia families facing life with cancer.

The Pediatric Family Therapy certificate provides specialized training in the treatment of child and adolescent mental and physical illnesses. This program extends the training of clinicians working with families with children and/or adolescents beyond the medical arena to include providing care in a variety of settings, such as schools, foster care systems, residential treatment facilities and the juvenile justice system.

The first certificate students will take courses in medical family therapy methods; chronic illness, death and dying; advanced developmental psychopathology; pediatric family therapy methods; and advanced developmental theory in family therapy, among others. As part of their studies, each student will also be required to complete four to nine hours of a clinical practicum, depending on their previous experience in a medical or pediatric setting.
