

## A14 Ellington to Fen Ditton

You are invited to attend an exhibition to view the detailed plans we have developed for the proposed A14 Ellington to Fen Ditton Improvement.

Following feedback from the earlier Public Consultations (March to June 2005 & December 2006 to March 2007), and Preferred Route Announcements (March & October 2007), we have been progressing the design of the scheme and carrying out an Environmental Impact Assessment. We would like to give you this opportunity to view our plans in more detail.

Our exhibition will enable you to see our proposals before the publication of draft Orders.

We plan to publish the Environmental Statement and draft Orders in Spring 2009. Depending upon the number and nature of any objections to the proposals, a Public Inquiry may then be held. This would be held before an independent inspector who will then make recommendations to the Secretary of State for Transport and the Secretary of State for Communities and Local Government. After consideration of any objections, representations, expressions of support and the inspector's report, the Secretaries of State will decide whether the Orders for the road should be made.
