

Financial Sanctions Notification

19/04/2010

Al-Qaida and Taliban

This notification is issued in respect of the financial measures taken against Al-Qaida and the Taliban.

Her Majesty's Treasury issue this notification to advise that with the publication of Commission Regulation (EU) No 318/2010 of 16 April 2010 in the Official Journal of the European Union (O.J. L97, 17.4.2010, p.10) on 17 April 2010, the European Commission has again amended Annex I to Council Regulation (EC) 881/2002 of 27 May 2002 with effect from 18 April 2010.

The amendment made to Annex I to Regulation 881/2002 by Regulation 318/2010 reflects the decision made by the United Nations Al-Qaida and Taliban Sanctions Committee on 29 March 2010 to remove one individual from the UN Consolidated List maintained under Resolution 1390 (2002).

The individual who has been removed from Annex I is therefore no longer subject to the asset freeze imposed by Regulation 881/2002 on the funds and economic resources of persons associated with Usama bin Laden, the Al-Qaida network and the Taliban as listed by the UN Al-Qaida and Taliban Sanctions Committee established pursuant to Resolution 1267 (1999). The persons covered by the freezing of funds and economic resources under Regulation 881/2002 are listed in Annex I to Regulation 881/2002 (as amended).

Details of the removal are set out in the Annex to this notification.

The Consolidated List of Financial Sanctions Targets which is maintained on the Treasury website has been updated to reflect the amendment made by the Sanctions Committee.
