USA Basketball Tested

Among the 33 under consideration for a final roster spot, 12 collected USA Basketball experience when they participated in the 2005 Youth Development Festival.

Capturing gold as members of the 5-0 USA Blue Team were Christy Marshall and La'Teena Wickett, who ranked second among 2005 participants for free throw percentage after shooting 88.9 percent from the line and tied for second for defensive rebounds per game with 5.4.

Silver medalists and USA White Team members included: Jayne Appel, who ranked second among all-time Festival participants for blocked shots with 13; Nikitta Gartrell, who ranked fourth among 2005 participants for 3-point field goals made per game at 0.8; Allison Hightower; Jasmine Stone, who ranked first among 2005 participants for offensive rebounds per game with 5.2 and tied for second for rebounds per game with 8.8; Danielle Wilson; and Monica Wright, who established an all-time Festival record for steals with 23 and tied the all-time, single-game record for steals with eight.

Capturing bronze as members of the USA Red Team were: Tina Charles, who established five all-time Festival records and three all-time single-game Festival records; Joy Cheek; Porsha Phillips, who ranked third among 2005 participants for blocked shots with 1.4 bpg.; and Brittainey Raven, who tied the all-time Festival single-game record for steals with eight.

Just the Facts

The Trials hopefuls include one rising college sophomore and 32 high school athletes, 15 from the class of 2006, 16 who are members of the class of 2007 and one athlete from the class of 2008.

The 33 athletes hail from 13 states, with Georgia (six), California, New York and Illinois (four each) ringing in with the most representatives per state.

Born on Jan. 11, 1988, Epiphanny Prince lists as the oldest athlete, while Jasmine Thomas, born on Sept. 30, 1989, is the youngest. Danielle Robinson, a 5-7 guard, is the shortest in the group, while four athletes stand above the others at 6-5, including Kelley Cain, Quanitra Hollingsworth, and Amy Jaeschke.

Many of the 2006 USA U18 National Team Trials participants caught the attention of various media outlets throughout the 2005-06 season for accomplishments on and off the court.

AAU Coach Mark Enger on Jayne Appel (Women's Basketball, April 2006)

"I coached the Paris twins (Courtney and Ashley now at Oklahoma) and Jayne is right in their league. They are two very different post players, but the two best post players I have ever seen are Courtney Paris and Jayne."

COACHING STAFF 2006 USA U18 NATIONAL TEAM TRIALS

DOUG BRUNO

2006 USA Basketball Women's U18 National Team Head Coach



Doug Bruno's selection as a 2006 USA Basketball U18 Women's National Team head coach is his first USA Basketball assignment.

"It's an honor to be coaching for USA Basketball," Bruno said. "I'm looking forward to coaching the talented athletes that we should see in Colorado Springs and to working with two great young

coaches in Carol Owens and Jennifer Rizzotti."

After 20 seasons (1976-77 through 1977-78 and 1988-89 to present) as head coach at DePaul and two (1978-79 through 1979-80) in the Women's Basketball League (WBL), Bruno has compiled an overall career record of 415-247 (.627 winning percentage) and 375-217 (.633 winning percentage) coaching collegiate squads.

He finished the 2005-06 season at 27-7, falling in the NCAA Tournament Regional Semifinal to Louisiana State University.

In the past four years, Bruno has led DePaul to four straight NCAA Tournament appearances. After posting a 15-14 record in 2001-02, he led one of the top turnarounds in the program's history with a 22-10 record in 2002-03 and made the school's first NCAA appearance since 1997. After advancing to the 2004 and 2005 NCAA second round, he piloted the Blue Demons to the 2006 Sweet Sixteen. In all, Bruno has led the DePaul women to 15 postseason appearances in the past 18 years.

Following a conference championship in 2004-05, Bruno was named the Conference USA Coach of the Year, and he also was selected as Conference USA's Coach of the Decade by a vote of the league's 14 head coaches.

In 2004 and 2005, he was named the Women's Basketball Coaches Association (WBCA) Region 4 Coach of the Year, placing him among seven others on the national coach of the year ballot. Bruno has been honored as the Illinois Basketball Coaches Association's Coach of the Year on seven occasions (1991, 1993,

1996, 2001, 2003, 2004 and 2005).

An advocate for women's basketball, Bruno was selected by his peers at the 2005 Final Four to serve as the 19th president of the Women's Basketball Coaches Association. Bruno is just the second male coach in the WBCA's history to lead the organization following Jim Foster in 1993. Before becoming president, he was the Male Coaches of Women's Basketball representative on the board of directors.

Prior to returning to DePaul in 1988, Bruno spent eight seasons as the associate men's head coach at Loyola of Chicago under Gene Sullivan.

During his stay, the Ramblers won 138 games and posted 17 or more wins in four seasons, including a pair of 20-win seasons.

Bruno also spent two seasons as the head

coach and director of player personnel for the Chicago Hustle of the WBL. His first team won the 1979 Midwest Division and led the WBL in 11 offensive categories as well as attendance.

CAROL OWENS

2006 USA Basketball Women's U18 National Team Assistant Coach



While Carol Owens enters her first coaching assignment with USA Basketball, she has twice been a USA Basketball athlete. Owens co-captained the North squad that captured the silver medal at the 1986 U. S. Olympic Sports Festival and was a 1989 USA Basketball Women's National Team Trials participant.

"It's an awesome feeling," Owens said.
"I've grown up as a player and now as a coach having a lot of pride in my country. I've played overseas professionally and have always had a great appreciation for the U.S. and, in particular, USA Basketball."

Owens has compiled a career record of 12-17 (.414 winning percentage) after her first season as a head coach at Northern Illinois University in 2005-06.

Northern Illinois finished the 2005-06 regular season at 11-16 and 7-9 for league play, both of which were improvements over the past year's 7-21 and 4-12 records. She helped advance the 2005-06 Huskies to the Mid-American Conference Tournament quarterfinals, collecting the program's first MAC Tourney win since 2002 along the way.

Prior to arriving at NIU, Owens spent 10 seasons (1995-96 through 2004-05) as an assistant at the University of Notre Dame (Ind.). As an assistant under Muffet McGraw, Owens coached five players who went on to gain USA Basketball experience, including 2004 Olympic gold medalist Ruth Riley and USA Basketball Team Trials participants Jacqueline Batteast (2002 and 2003), Teresa Borton (2002), Megan Duffy (2005) and Courtney LaVere (2003).

Owens helped Notre Dame reach 10 NCAA tournaments, six Sweet Sixteens, two Final Fours and the program's first NCAA National Championship in 2001. During her tenure Notre Dame compiled a record of 252-75 (.771 winning percentage), and in 2001,

Women's Basketball Journal named Owens as one of the top five assistant coaches in the country

As a player at Northern Illinois, Owens was a member of the squad that gained the school's first NCAA Tournament berth in 1990. As the first male or female in school history to reach the 2,000 career point / 1,000 career rebound mark, Owens was the MVP on a team that won the North Star Conference regular season championship and advanced to the second round of the 1990 NCAA Tournament.

Owens was a two-time Kodak District Four All-American (1989 and 1990), a United States

Basketball Writers Association District Four All-American (1990), the North Star Player of the Year (1990), a three-year All-North Star Conference first-team pick (1988-90) and a three-time Huskie captain.

She graduated in possession of 13 school records, including career points (2,102), career field goals (818), career field-goal percentage (.537), career free throws (466), career free throw attempts (662), career blocked shots (244), single-season free throw attempts (222), single-season steals (86), sin-

gle-game points (41), single-game field goals (16), single-game field-goal percentage (.917), single-game steals (11) and single-game blocked shots (7).

She also played professional basketball in Japan, Spain, and Italy from 1990 to 1993.

Owens has been enshrined into the Northern Illinois University Athletics Hall Of Fame (1995) and the Illinois Basketball Coaches Association Hall Of Fame (2001).

While Jennifer Rizzotti's selection as an assistant coach for the 2006 U18 Women's National Team is her first USA Basketball coaching assignment, she gained valuable experience as a gold medalist with the 1996 USA R. William Jones Cup team and as a 1995 USA Women's National Team Trials participant.

"I think it's just a great opportunity,"
Rizzotti said. "I had the chance to play for USA
Basketball when I was in college, and I know
how tremendous an experience it can be to play
at that level while representing your country. Now
I'm excited about helping younger players have
that same experience."

Rizzotti has compiled a career coaching record of 119-89 (.572 winning percentage) in seven seasons (1999-00 to present) as the head women's basketball coach at the University of Hartford (Conn.).

This past season Rizzotti and her Hawks captured their second consecutive America East Conference championship and advanced to the second round of the NCAA Tournament where they lost to Georgia, finishing the season at 27-4.

In the 2004-05 season, Rizzotti won her second America East title and made her second NCAA Tournament appearance in four years. In that same season she led the Hawks to a school record 22 wins and captured the team's 13th conference title for another school record.

Rizzotti was appointed Hartford's head coach just 12 days after defeating the New York Liberty for the WNBA championship as a member of the Houston Comets. At the time of her appointment, she was the youngest Division I women's basketball coach in the country.

Rizzotti played eight seasons of professional basketball after graduating from the University of Connecticut in 1996. In addition to five seasons in the WNBA, two with the Houston Comets and three with the Cleveland Rockers,

she spent three seasons with the New England Blizzard in the American Basketball League (ABL). She was a two-time ABL All-Star.

As a point guard at the University of Connecticut Rizzotti was the 1996 Associated Press National Player of the Year and the 1996 Wade Trophy winner as college basketball's outstanding senior player. She was also a two-time Kodak All-American first team selection, a GTE/CoSIDA Women's Basketball Academic All-American, the Big East Player of the Year and the Big East Women's Basketball Scholar-Athlete of the Year. During the

Huskies' run to the national championship in 1995, Rizzotti was featured on the cover of Sports Illustrated.

Honored as the 1993 Big East Rookie of the Year, Rizzotti started in every game UConn played while she was a Husky, 135 total. She graduated with a record of 117-18 (.867 winning percentage). Rizzotti helped her team win the Big East Tournament in 1994, 1995 and 1996. In addition to the school's 1995 national championship, Rizzotti helped her squad

reach the first round of the NCAA Tournament in 1993, the Elite Eight in 1994 and the Final Four in 1996.

In September 2003, Rizzotti was inducted into the New England Basketball Hall of Fame.

This past summer she joined an initiative by The Hartford insurance company called Playbook for Life. The program travels throughout the country to educate student-athletes on how to prepare for their financial future outside of athletics.

Tricia Betthauser

Tricia Betthauser's appointment as a 2006 Women's U18 National Team Trials court coach marks her first USA Basketball selection.

"It will be an amazing opportunity, and I'm extremely grateful," Betthauser said. "I'm really looking forward to getting back on the court. In high school, you aren't allowed to work with your players in the summer, so I'm anxious to get back out there, especially with the level of these athletes."

Betthauser will enter her first season as head coach at Adlai E. Stevenson High School in 2006-07. She returned to Stevenson as an assistant coach in 2005-06 after serving two seasons as an assistant coach in 1994-95 and 1995-96. Overall, Betthauser has compiled an 88-15 record (.854 winning percentage) in three seasons (1994-95, 1995-96 and 2005-06) as an assistant coach at Stevenson.

The 2005-06 season saw the Lady Patriots finish 21-12 to capture a regional championship and a sectional semifinals appearance. In her first stint as an assistant at Stevenson (1994-95 and 1995-96), she helped the Lady Patriots capture the program's only two state championships and a 67-3 overall record. Betthauser also helped coach Olympic and World Championship gold medalist Tamika Catchings, a member of the 2006 USA World Championship Team, during the 1994-95 season.

She served five seasons (2000-01 through 2004-05) at Indiana University, her third coaching position under head coach Kathi Bennett, as IU recorded a mark of 72-74. She helped the 2001-02 Hoosiers capture the program's first-ever Big Ten Conference Tournament title and first NCAA Tournament appearance since 1995. After Bennett was sidelined by a car accident in February of 2002, Betthauser led the Hoosiers to a 2-1 record while acting as head coach, including an upset against No. 15 University of Minnesota.

She also served under Bennett as an assistant at the University of Evansville (Ind.) for four seasons (1996-97 through 1999-2000). While at Evansville, Betthauser helped improve a 3-23 program in 1995-96 to 23-7 in 1999-00, capturing the best mark in program history. The Purple Aces secured the conference championship and an NCAA Tournament appearance in 1999. In Betthauser's final season at Evansville in 1999-00, the squad finished second in the conference and earned a WNIT appearance.

In her first position under Bennett in 1992-93, she served as a graduate assistant at her alma mater, the University of Wisconsin-Oshkosh, before spending one season as the head coach at Hilbert High School in Hilbert, Wis., in 1993-94.

Betthauser also played for Bennett for four seasons (1988-89 through 1991-92) at Wisconsin-Oshkosh, and the Titans compiled a record of 72-26 (.735 winning percentage) while Betthauser was in uniform. She helped her squad appear in three NCAA Division III Tournaments, reaching the second round in 1990 and 1991. In her senior season, 1991-92, Betthauser was her team's MVP and an All-Wisconsin Intercollegiate Athletic Conference (WIAC) first team selection. In addition, she was a four-year All-WIAC Scholar Athlete and graduated Cum Laude in 1993.

In the summer of 2006, Betthauser also is scheduled to conduct basketball camps for fifth through 12th grade girls through the Patriot Recreational Education Program.

2006 USA Basketball Women's U18 National Team Trials

Dorena Bingham

Dorena Bingham will report for her second USA Basketball coaching assignment as a 2006 USA Basketball Women's U18 National Team Trials court coach. Bingham also helped lead the USA Basketball Youth Development Festival West Team to a gold medal as an assistant coach in 2004.

"It is an honor and a privilege to be working with USA Basketball again," Bingham said. "To have the opportunity to work with the great athletes, coaches and staff is truly a dream come true."

Bingham has been the head coach at East High for 13 seasons (1994-95 to present). After taking the reigns of her program in 1994, "Bing" as her players call her, has built a basketball empire in Alaska, winning three consecutive Alaska state championships from 1999-00 through the 2001-02 campaign, while compiling an astounding overall record of 282-68 (.806 winning percentage).

In addition to three state titles, Bingham has guided her teams to a total of 10 state tournament appearances, including nine straight state tournaments from 1994-95 through 2002-03. East Anchorage's postseason runs have included two runner-up finishes (1995 and 1996), one third place finish (1997), three fourth place finishes (1998, 1999 and 2003) and one seventh place finish (2006). She also has helped her squads capture seven Region IV championships.

Bingham was honored as a 2006 ConocoPhillips Healthy Futures Local Fitness Champion, and recognized for the accomplishments of her team, she was named the Alaska Coach of the Year in 1995 and 2002. She also received the "Light Hope Award" in 2003, presented by the Office of Public Advocacy for dedication to coaching and community.

A total of 17 of Bingham's former players have gone on to play college basketball, including Natalie Jones of the University of Arizona and Azella Perryman of Stanford University (Calif.).

In the fall of 2007, Bingham will also begin her 22nd year of teaching.

Jerry Taylor

Entering his 26th year as the head coach at Roosevelt High, Jerry Taylor earned his first USA Basketball coaching position as a 2006 USA Women's U18 National Team Trials court coach.

"There are a lot of great things that have happened to me in my life in terms of sports, and this is one of the greatest," Taylor said. "My father and my son were both in the service, and now I get a chance to do something for my country."

Taylor led his 2005-06 squad to an 18-5 overall record and a perfect 12-0 conference record to capture first place in the Chicago North Conference. Taylor was given his third Chicago Public League Basketball Coaches Association (CPLBCA) Coach of the Year Award in 2006 and his third Northwest City All-Stars coaching assignment as a co-coach in 2006. He also was the CPLBCA Coach of the Year in 1982 and 1994 and a Northwest City All-Star coach on two other occasions. In addition, Taylor was selected to coach the City versus Suburban Girls All Star game in 1995. In 25 seasons, Taylor has led his squads to three section championships (1984, 1992 and 1994).

Among the players Taylor has helped guide to college basketball careers are Danielle Green of the University of Notre Dame (Ind.), Nikesha Langston of the University of Louisville (Ky.) and Lashawn Taylor of Casper Wyoming College.

Now a member of the board of directors of the CPLBCA, Taylor received the Chicago Youth Success Foundation Award in June of 1997 and the Cook County State Attorney Stay Award in April of 2001.

A 1974 graduate of the University of Illinois at Chicago, he also teaches at Roosevelt.
