# Liechtenstein - History

1342 - 1921

- 1342: The county of Vaduz is established
- 1699: Prince Johann Adam Andreas purchases the Lordship of Schellenberg
- 1712: Prince Johann Adam Andreas purchases the county of Vaduz
- 1719: Elevation to Imperial Principality
- 1806: Admission of Liechtenstein to the Rhine Confederation as a sovereign State
- 1852: Customs treaty with Austria
- 1868: Abolition of the armed forces
- 1921: New constitution enters into force













#### Liechtenstein - History

1923 - 2004

- 1923: Customs treaty with Switzerland and introduction of the Swiss franc
- 1975: Membership of OSCE
- 1978: Membership of the Council of Europe
- 1990: Membership of the UN
- 1991: Membership of EFTA
- 1995: Membership of the EEA and the WTO
- 2003: New constitution enters into force
- 2004: Hereditary Prince Alois is appointed by Prince Hans-Adam II as his deputy

#### Liechtenstein – System of State

Prince and People govern together

System of State:

The Principality of Liechtenstein is a "constitutional hereditary monarchy on a democratic and parliamentary basis".

■ The Reigning Prince:

The Reigning Prince is the Head of State and represents the State abroad.













# Liechtenstein - System of State

Prince and People govern together

#### Parliament:

The Liechtenstein Parliament (Landtag) consists of 25 Members of Parliament who are elected from two election districts. The term of office is four years. The Parliament is responsible for legislation, taxation, supervision of the Government and of the National Administration. Three parties are represented in the Liechtenstein Parliament.



#### ■ The Government:

The Government conducts the affairs of State. As the executive branch, it is responsible for the National Administration. It supervises approximately 50 Government offices which fulfill their assigned mandates. The Prime Minister chairs the five-member collegial Government appointed by the Reigning Prince on the recommendation of Parliament. The term of office is four years.

During the term of office 2009 - 2013:

Coalition government with the two biggest parties represented by three or two Ministers respectively.

#### Liechtenstein - Multilateral relations

internationally connected

- In addition to maintaining bilateral relations with other States, multilateral cooperation is an important element of Liechtenstein foreign policy.
- Multilateral relations enable Liechtenstein to secure its independence and develop its own foreign policy profile.
- As a State in the heart of Europe, Liechtenstein shares its destiny and is historically, politically, economically and intellectually a part of this continent.
- Working for a joint Europe Liechtenstein maintains a Permanent Representation at the Council of Europe in Strasbourg.













#### Liechtenstein - Multilateral relations

internationally connected

- Liechtenstein is a member of the European Free Trade Association (EFTA).
- In the negotiations between the States of the EFTA and the EU at the end of the 1980's and in the early 1990's, Liechtenstein as an independent partner supported the creation of a European Economic Area (EEA).
- In the spring of 1995, the Liechtenstein electors voted to join the EEA.
- When Liechtenstein joined the EEA in 1995, this marked a new dimension in its foreign policy: the Principality has put itself at the service of European integration and has promised its active collaboration.

- Prince Hans-Adam II. is the Head of State.
- On 15.08.2004 Prince Hans-Adam II appointed Hereditary Prince Alois his permanent representative for exercising the sovereign powers due to him, in preparation for his succession to the throne. Since 15th August 2004 the Hereditary Prince has thus been performing both nationally and internationally the duties of Head of State of the Principality of Liechtenstein.
- The Princely House of Liechtenstein is among the oldest noble families of Europe.













#### Liechtenstein - The Princely House

- The Princely assets include the financial company LGT Group, with 29 branch offices worldwide as well as extensive landed property, mainly in Austria.
- The Princely Art Collections encompass central works of European art from four centuries and are among the most significant private art collections in the world. The Collections began in the 16th century.
- The Liechtenstein-Museum in Vienna was opened in 2004.





# Liechtenstein – Development of the financial center

Opportunities and risks

- Since the beginning of the 1990's:
- Greater diversification of products in financial services, especially toward investment funds and insurance solutions, as well as significant expansion of the number of market participants.
- Rapid growth in the 1990's in the financial services sector worldwide.
- Money laundering risk recognized in Liechtenstein:
- responded with clear legal and regulatory measure for a clean financial center, and consistent implementation ensured.













# Liechtenstein - Development of the financial center

Combating money-laundering and terrorist financing (1/2)

- 1990 Liechtenstein is a State Party to the Convention of the Council of Europe on Money Laundering, Search, Seize, and Confiscation of the Proceeds from Crime.
- 1995 Implementation of the 1st Money Laundering Directive.
- 2000 Total revision of the Liechtenstein Mutual Legal Assistance Act.
- 2001 Establishment of the Liechtenstein Financial Intelligence Unit.
- 2002 Mutual Legal Assistance Treaty with the United States and adoption of the "Counterterrorism Package".













# Liechtenstein - Development of the financial center

Combating money-laundering and terrorist financing (2/2)

 2004 Tightening of the Law on Professional Due Diligence in Financial Transactions (Due Diligence Act)

> Establishment of the Liechtenstein Financial Market Authority through enactment of the Financial Market Authority Act.

- 2005 Implementation of the 2nd EU Money Laundering Directive.
- 2008 Partial revision of the Mutual Legal Assistance Act.

Implementation of the 3rd EU Money Laundering Directive.











# Liechtenstein – Development of the financial center

International cooperation in tax matters (1/2)

- 2002 Mutual Legal Assistance Treaty (MLAT) Liechtenstein – USA, on the basis of an expanded definition of tax fraud.
- 2007 Fiscal exemption has been relaxed as part of the implementation of the EU Money Laundering Directives. Serious cases of value added tax fraud and certain qualified customs offenses have been subject to legal assistance.
- 2008 Signing of the protocols for Liechtenstein's association with Schengen: From entry into force (2009) Liechtenstein will grant comprehensive legal assistance in cases of direct and indirect tax fraud.

Signing of an OECD-compliant Tax Information Exchange Agreement (TIEA) with the United States.











# Liechtenstein - Development of the financial center

International cooperation in tax matters (2/2)

- 2009 March 12: "Liechtenstein Declaration" Recognising the OECD-standard as the global standard in tax cooperation, within the context of double taxation agreements to be concluded on a bilateral basis.
- 2009 August 11: Agreement with the United Kingdom to ensure tax compliance of British clients.
- 2009 August 26: OECD-compliant Double Taxation Agreement (DTA) with Luxembourg.
- 2009 September 2: OECD-compliant Tax Information Exchange Agreement (TIEA) with Germany.















#### Liechtenstein - Financial center

competent - secure - personal

- Approx. 17% of employed persons work for banks, insurances, and trust companies.
- Operating in Liechtenstein are:
  - 16 banks (some of which are subsidiaries of international institutes)
  - 393 trust companies and trustees
  - 102 asset management companies
  - 420 domestic investment companies
  - 42 Liechtenstein insurance undertakings
  - 25 fund management companies with about 618 investment funds.














#### Liechtenstein - Financial services

banks - trust companies - insurance companies - investment funds

- Almost 10% of employed persons work in the banking and insurance sector and about 8% in the trust and legal sector.
- As of the end of 2009, Liechtenstein banks managed about CHF 125 billion in client assets. By comparison:
   As of the end of 2008, 327 Swiss banks managed about CHF 4,800 billion in client assets.
- Insurance undertakings generated premiums of CHF 6.0 billion (2008).
- The assets of Liechtenstein investment funds currently amount to about CHF 39 billion.

#### Liechtenstein - Industrial location

- Liechtenstein has 3,600 businesses, or 1 business per 10 inhabitants.
- Many Liechtenstein companies work in special, research-intensive market niches, in which they are considered global market leaders.
- 2nd sector: about 600 businesses. Over 86% of these are small businesses (1 to 9 employees).
- 18 companies employ more than 250 people.
- Liechtenstein industrial companies employ about 33,000 people in 184 foreign establishments.
- In 2008, the expenditures for research and development in the industrial companies of the Liechtenstein Chamber of Commerce and Industry amounted to 345 million Swiss francs.













#### Liechtenstein - Exports

Liechtenstein and Switzerland

- Exports: 747 million Swiss francs/500 million Euros (= 11% of Liechtenstein exports).\*
- 45% of all cross-border commuters to Liechtenstein are from Switzerland.
- The industrial companies of the Liechtenstein Chamber of Commerce and Industry employ 1,500 people in 17 foreign establishments in Switzerland.
- Companies with major exports to Switzerland are: Hilcona AG, Hilti AG, Intern. Möbel-Selection IMS AG, Swarovski AG and OC Oerlikon Balzers Ltd.























Liechtenstein Museum of Fine Arts:
 Opened in November 2000 as a museum of the visual arts.

Monolithic construction by the architects Morger, Degelo and Kerez. Façade of black, broken basalt and river gravel. Black-dyed cement.

The art exhibited, including from the Liechtenstein State Art Collection, ranges from the 19th century to the modern era. Exhibitions from the Collections of the Prince of Liechtenstein. The Museum of Fine Arts has gained an international reputation in just a few years.

#### Music:

Liechtenstein offers an impressive number of orchestras, music societies, choirs, and bands for music lovers.

Concerts take place throughout the year.

About 2,500 students attend the Liechtenstein Music School.

In a small area, the Principality of Liechtenstein presents diverse offerings of theater and dance, such as in the Theater on the Kirchplatz in Schaan and in the Schlössle Cellar in Vaduz.

- Liechtenstein is a varied and popular vacation country.
- Recreational offerings include museums, sledding in the winter, skiing fun at 2,000 meters elevation, paragliding over the Rhine Valley.
- Liechtenstein Tourism counted 72,000 visitors in 2009 and 176,000 overnight stays.
- Most visitors and overnight stays were from Germany, Switzerland, Austria, the United Kingdom, and the United States.
- 34% of all visitors and of all overnight stays were German citizens.

### Fine dining:

Dining in Liechtenstein ranges from the traditional restaurant to the gourmet temple.

#### Hotels:

Over 30 hotels, ranging from inexpensive tourist class to the tasteful first-class hotel. Also available: vacation apartments, pensions, camping grounds, youth hostel.

### Hiking:

Over 400 km of well-maintained and signposted hiking trails, 160 of which are in the mountain area up to 2,600 meters elevation. All may be reached by public transportation.

- Sports are very important in Liechtenstein.
- Popular sports:

In addition to individual sporting activities, Liechtenstein offers a wide range of opportunities to take advantage of clubs in many different types of sports.

Members in sports associations:

15,000 people in Liechtenstein are members of a sports association. This corresponds to 45% of the population. 1 in 240 people in Liechtenstein is president of a sports association.

Elite sports:

Liechtenstein has brought forth a number of internationally successful elite athletes.

- World Championship medals:
   Liechtenstein's skiers won 20 medals at world championships.
- Olympic medals:

Liechtenstein has won a total of 11 Olympic medals, all in Alpine skiing. This corresponds to 1 medal per 3,000 people in Liechtenstein.
