3. Part III - Narrative Summary of Events/Accomplishments

a. <u>JANUARY</u>

(1) Operations completed Installation of the Improved Fresnel Lens Optical Landing System (IFLOLS).

- (2) Reactor Department, in conjunction with Puget Sound Naval Shipyard, completed maintenance in the final stages of the Planned Incremental Availability (PIA), and Number 2 Propulsion Plant was placed in a maintenance condition (solid) for adjustment of a primary relief. Major shipyard work completed this month: steam generator authorized work, reactor coolant pump breaker re-installation, Reactor Fill Admission Valve work, reactor vessel head buffering, and Electronic Rod Drive Power Supply upgrades. Several precritical preparations were completed in anticipation of returning the reactors to service.
- b. <u>FEBRUARY</u>. Reactor Department began preparing plant equipment for light off. The Commanding Officer re-certified supervisory watch standers to resume standing steaming watches, and hot operations were completed ahead of schedule. Shortly after hot operations, successful completion of non-critical steaming testing indicated that steam driven pumps and generators required for reactor plant start up were ready for use.

c. MARCH

- (1) The Educational Services Office held March exams totaling 1,062 Navy-Wide examinations for the following paygrades: 298 for E-4 paygrade (180 advanced = 60.73%); 574 for E-5 paygrade (123 advanced = 21.42%); and 190 for E-6 paygrade (44 advanced = 22.63%).
- (2) March continued the testing phase and marked the end of the PIA. Power range testing certified all critical equipment supporting propulsion. The watch teams participated in casualty control drills during Fast Cruise and Sea Trials to certify their watch standing proficiency. Sea Trials completed the testing requirements for PIA. Unfortunately, Sea Trials also revealed steam leaks from all four main engines. All testing was completed on time, and the ship was certified for use.
- (3) Operations Department, OW Division completed several hurdles to ensure the ship's Electronic Warfare Systems were performing up to specifications before beginning the inter-deployment training cycle. Successful CSPAAT evaluations were completed on the ship's EW systems in conjunction with outstanding ULM-4 range evolutions of the SLQ-32(V)4 and WRL-1H. Field changes on the SLQ-32 were also completed. The USS JOHN C. STENNIS was chosen as the acting operational test platform, the 1st Navy unit to employ the Precision Targeting Workstation 4.0 system.

d. APRIL

- (1) Public Affairs assisted with the "Men of Honor" DVD/VHS Premiere aboard USS BUNKER HILL as media escorts.
- (2) Upon completion of Sea Trials, focus shifted to preparations for INSURV. In addition to INSURV preps, Nuclear Propulsion Mobile Training Team (NPMTT) commenced their first visit in a series of three in preparation for the Operational Reactor Safeguards Examination (ORSE).

e. MAY

- (1) The ship held the premiere of the epic movie "Pearl Harbor" on board in Pearl Harbor, Hawaii. This event was months in planning and encompassed the efforts of the entire ship. During the transit to Pearl Harbor, Disney came on board and erected a stage on the flight deck. The premiere was held on 21 May and was the highlight for the entire crew during the port visit.
- (2) The Career Counselors processed 44 reenlistments, 22 alone were held on the flight deck during the premiere of the movie Pearl Harbor. Public Affairs assisted in conducting 500 interviews with Radio stations during the

movie premiere week. 150 TV interviews were produced locally, nationally and internationally and included a massive amount of media coverage that reached the all-important and recruiting-age MTV/Entertainment Tonight generation; 150 print interviews promoting the Navy. While in Pearl Harbor, the ship conducted tours for 2,000 quests.

- (3) Completed Install and Certification of the Long Range Laser Line-up System (LRLS).
- (4) Reactor Department successfully performed all aspects of the full power demonstration, including a one-hour full power run, a quick reversal, prolonged astern operation, and a quick reversal ahead. During the trip to and from Pearl Harbor, Hawaii, casualty control response became the focus of training. Without an embarked air wing, the drill team was able to perform more complex casualty control drills including complete loss of propulsion (DIW) and power affecting drills. This concentrated training time greatly enhanced the proficiency of watch standers.
- (5) Battle Group Passive Horizon Extension System (BGPHES) was successfully upgraded with Field Changes 5 and 7. These upgrades enhanced SSES's ability to provide Indications and Warning (I&W) to the battle group by increasing the number of receivers available and allowing increased network connectivity by operators.

f. JUNE

- (1) Held a frocking ceremony in the hangar bay where 347 personnel were frocked to the next paygrade.
- (2) Completed installation of the Flight Deck Control Handler Camera System.
- (3) COMNAVAIRPAC NPMTT returned for their second visit to assess the Reactor Department's progress in preparing for ORSE. The inspection included casualty control drills, level of knowledge testing and interviews, and a thorough administrative review. Puget Sound Naval Shipyard personnel performed emergent repairs to number four main engine turbine and turbine casing.
- (4) OZ division and strike plot from 18-28 June productively hosted Fleet Battle Experiment-I. Nine separate C4ISR systems were successfully tested. OA division also provided stellar support with the Tactical Oceanographic and Atmospheric Summary System (TOAS). This system supports and provides all battle group platforms and assets with updated metrological forecasts and updates via message traffic.
- (5) AIMD had its COMNAVAIRPAC Maintenance Program Assist. The inspection was completed with an outstanding 41 of 44 programs graded "On Track".

g. JULY

- (1) Public Affairs published 15 issues of the Statesman; produced ADM/CO/CAG/Commodore Brief; Friends and Family Day video; Tijuana Liberty video; Seattle Port Briefs and Foreign Object Debris video. Provided inport tours for 350 people in San Diego.
- (2) Operations Department OI division successfully completed two CIWS PACFIRE exercises and performed outstanding during TSTA II/III and FEP. The OA division supported FEP providing the "best ever" environmental predictions allowing for optimum weapons strikes.

h. AUGUST

- (1) On the day trip from Everett to Seattle, enroute to Seattle Sea Fair, JCS hosted 1,700 personnel and provided tours, lunch and entertainment. Hosted over 12,000 people for tours during inport Seattle for Sea Fair. Hosted Seattle Sea Fair on board during reception for JOHN C. STENNIS' 100th birthday.
- (2) Reactor Department made significant improvements in preparation for ORSE, while the Air Wing certified for blue water operations. On the return from Seattle, the ship successfully completed the Intermediate Phase of the Inter-deployment Training Cycle with the end of COMPTUEX and the Final Battle Problem. NPMTT completed the third of three visits. This visit served as a dress rehearsal for ORSE.
- (3) Stellar support for the Seattle Sea Fair started a busy month for the USS JOHN C. STENNIS. The OP division directly assisted the Public Affairs Office by providing outstanding photographic support of Sea Fair and the Parade of Ships. The Shogun Quick Strike Cell, Strike Fusion Cell and the Time Critical Targeting Cell were stood up providing CVW-9 and the USS JOHN C. STENNIS full and complete integration. OP division provided over 5,000 feet of TARPS film in support of COMPTUEX. OM and OI division controlled numerous USW aircraft for over 30 hours and coordinated 24 attacks to complete numerous COMPTUEX objectives.
- (4) AIMD maintained a 98 percent test bench readiness rate and managed the successful verification of 792 rotatable pool items, which directly contributed to the command's highly successful completion of TSTA II/III, FEP and COMPTUEX.

i. SEPTEMBER

- (1) While underway performing FRS CQ, the tragic terrorist bombings of September 11 took place. JCS immediately became a North American Air Defense asset and began flying Combat Air Patrol missions over the Western Continental United States, the only aircraft carrier ever to conduct such missions.
- (2) During this month, the Educational Services Office processed 1,189 Navy-Wide Examinations for the following paygrades: 324 for E-4 paygrade (209 advanced = 64.50%); 646 for E-5 paygrade (144 advanced = 22.29%; and 219 for E-6 paygrade (55 advanced = 25.57%).
- (3) JCS received notification of her early deployment in support of Operation Enduring Freedom.
- (4) Reactor Department successfully completed another Operational Reactor Safeguards Examination, continuing a high standard set during two previous examinations.

j. OCTOBER

- (1) The John C. Stennis Center for Public Service hosted the Straight Furrow and Look Ahead Awards Dinner. The dinner was held on 12 October 2001 at the Hanalei Hotel in Mission Valley with about 65 personnel and spouses in attendance. The Straight Furrow Award was presented to CDR Victor Warriner, Operations Officer and the Look Ahead Award was presented to MMCS (SW/AW) Vincent Murray from Reactor Department. Mr. Rex Buffington, Executive Director of the Stennis Center for Public Service, presented both awards.
- (2) The Reactor Department conducted the annual Reactor Accident Drill and preparations for deployment.

(3) AIMD NDI Shop obtained a grade of satisfactory with zero discrepancies during a NAVSEADETRASO Inspection. A new piece of equipment called Liquid Filtration Cooling Unit (LFCU) was acquired from CNAP to support the air wing.

k. NOVEMBER
