"Apparently our own potential fascists figure they can succeed where Hitler failed. They've got the help of federal officials such as Atty. Gen. Tom Clark and J. Edgar Hoover who will Red-bait at the drop of anybody's hat. Despite 42 lynchings since V-J day, all that the director of the FBI could find to talk about before the racist American Legion in annual convention was 'the menace of Communism'. Clark and Hoover are ideologically equipped to retain the jobs should Hitler suddenly appear and take over the White House. This spectre of the Red Menace used by capitalists and their stooges to frighten the timid has to be exposed. That's our job as progressives."
